### **Cretan Glenti 2017 – Special Occasion Permit Liquor Licence**

WHEREAS, Hamilton City Council has received Notice (attached hereto as Appendix “A”) from Tery Tsiliganos on behalf of Cretans’ Association of Hamilton “Arkadi”, that they wish to obtain approval for a Special Occasion Permit Liquor Licence to sell alcohol on September 30, 2017 between the hours of 7:00 p.m. and 1:00 a.m. at St. Demetrios Greek Orthodox Church, 22 Head Street, Hamilton, Ontario during the Cretan Glenti 2017 taking place in Hamilton, Ontario;

WHEREAS, the Alcohol and Gaming Commission of Ontario requires that if a permit holder is not a registered charity or non-profit organization, that a resolution of the Council is required to designate the event as one of municipal significance; and
