BY-LAW NO. 17-

To Amend By-law No. 01-215 Being a By-law To Regulate Traffic

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by removing from section "C" (Flamborough) thereof the following items, namely;

Harvest Road	70 m West of Forest Avenue	230 m West of Tews Lane	40 km/h
Field Road	400m N. of Jerseyville Rd.	Governor's Rd.	60 km/h

And by adding to section "C" (Flamborough) thereof the following items, namely;

Harvest Road	Brock Road	Ofield Road	40 km/h
Field Road	400 m north of Jerseyville Road	Powerline Road	60 km/h

Wilson Street West	40 metres east of Seminole Road to 100 metres east of Hamilton Drive	North curb lane	Anytime	Westbound
Garth Street	30 metres north of Yates Gate to Twenty Road	East curb lane	Anytime	Northbound
Garth Street	150 metres north of Madonna Drive to 85 metres north of Twenty Road	West curb lane	Anytime	Southbound

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
