PLANNING COMMITTEE REPORT 17-015

That Item 8 of Planning Committee Report 17-015 respecting Removal of Hess Village Entertainment District from Licensing Bylaw 07-170 be amended by deleting the Item in its entirety and inserting the following therein:

8. Amendment to the Requirements of the Hess Village Entertainment District as outlined in City of Hamilton Licensing By-law 01-170

WHEREAS, the Hess Village Entertainment District requires a minimum of ten (10) Special Duty Police Officers each Thursday, Friday and Saturday from 11:00 p.m. to 4:00 a.m. April 15th to November 15th each calendar year;

WHEREAS, the Hamilton Police Service has worked with the bar owners to reduce the costs, given the change in attendance and have not acted unreasonably;

WHEREAS, Hess Village bar owners have been charged for four (4) Constables and two (2) Sergeant paid duties, Friday and Saturday, in 2017 and deployment was altered to begin on the Victoria Day weekend and end on the last weekend of September;

WHEREAS, in 2016 the amount spent from the Hamilton Police Service budget was \$31,524.48; and,

WHEREAS, staff from Licensing have confirmed that the number of establishments paying into the Paid Duty program has dramatically decreased since 2015; in 2015 fifteen (15) establishments shared the cost, in 2016 ten (10) establishments shared the cost and in 2017 only six (6) establishments shared the cost;

THEREFORE BE IT RESOLVED:

- (a) That the Hamilton Police Service further reduce the policing response to three (3) Constables and one half (1/2) Sergeant, continuing primarily two (2) nights per week on Friday and Saturday (with Thursdays optional and based on needs) from the Victoria Day weekend through to the end of September;
- (b) That Hamilton Police Service continue to pay for one (1) Dispatcher and three (3) mobile patrol Constables thereby making the bill for policing services a near even split between the Hess Village Bar Owners and the Hamilton Police Service/City of Hamilton, at a projected total of approximately \$48,000.00 each;
- (c) That City of Hamilton Licensing By-law 07-170 be amended to reflect the changes outlined in subsections (a) and (b); and,
- (d) That the appropriate City of Hamilton staff be requested to address the issue of declining establishments paying into the Paid Duty program in Hess Village and report back to the Planning Committee 45 days before the start of the 2018 Paid Duty season with solutions.

MOTIONS

7.1 Hamilton Police Service Requested to Actively Enforce Current Laws Prohibiting the Sale of Marijuana under the Criminal Code

(Conley/Collins)

WHEREAS, the Government of Canada is in the process of creating new legislation for the legalization of marijuana;

WHEREAS, possessing and selling marijuana for non-medical purposes is still currently illegal everywhere in Canada;

WHEREAS, marijuana dispensaries selling marijuana for non-medical purposes are persistently opening and operating in the City of Hamilton;

WHEREAS, marijuana dispensaries have a negative impact on the neighbourhood it is operating in as well as the entire Hamilton community;

WHEREAS, the City of Hamilton Licensing and By-law Services have formed a team of Officers to investigate municipal by-law violations under Zoning, Licensing and Sign By-laws at identified marijuana dispensaries in the city of Hamilton;

WHEREAS, the City of Hamilton Licensing and By-law Services have issued 45 non-compliance zoning notifications, 25 zoning charges are currently before the Court, and 6 licensing charges for selling food without a licence, resulting in the closure of 10 marijuana dispensaries in the City of Hamilton;

WHEREAS, 19 marijuana dispensaries still remain open in the City of Hamilton;

WHEREAS, the City of Hamilton is pursuing an injunction before the Superior Court to prohibit the distribution of marijuana through retail outlets but there will not be a final decision for several months; and,

WHEREAS, current laws prohibiting the possession and sale of marijuana are mainly enforced under criminal jurisdiction;

THEREFORE BE IT RESOLVED:

- (a) That the Hamilton Police Service be requested to enforce the *Controlled Drugs and Substance Act* and charge those selling non-medical marijuana in the City of Hamilton; and,
- (b) That the Mayor correspond with the Honourable Ralph Goodale, Public Safety Minister, to request that the process and implementation of the legislation for the legalization of marijuana be expedited to alleviate confusion within the community.

7.2 Cretan Glenti 2017 – Special Occasion Permit Liquor Licence

WHEREAS, Hamilton City Council has received Notice (attached hereto as Appendix "A") from Tery Tsiliganos on behalf of Cretans' Association of Hamilton "Arkadi", that they wish to obtain approval for a Special Occasion Permit Liquor Licence to sell alcohol on September 30, 2017 between the hours of 7:00 p.m. and 1:00 a.m. at St. Demetrios Greek Orthodox Church, 22 Head Street, Hamilton, Ontario during the Cretan Glenti 2017 taking place in Hamilton, Ontario;

WHEREAS, the Alcohol and Gaming Commission of Ontario requires that if a permit holder is not a registered charity or non-profit organization, that a resolution of the Council is required to designate the event as one of municipal significance; and,

WHEREAS, the City of Hamilton does not have an objection to the Liquor Licence Serving Time Extension for the following establishment;

THEREFORE BE IT RESOLVED:

- (a) That the City of Hamilton hereby deems Cretan Glenti 2017, being held in the City of Hamilton, Ontario on September 30, 2017, as municipally significant; and,
- (b) That the following applicant be provided a copy of this resolution for inclusion with their application to the Alcohol and Gaming Commission of Ontario:
 - (i) Cretans' Association of Hamilton "Arkadi" c/o Tery Tsiliganos, Hamilton, Ontario.

WHEREAS, the capital project for Dundas Library Expansion #7501341301 was approved by Council in the 2013 capital Budget;

WHEREAS, significant roof leaks continue to damage the ongoing renovation at Dundas Library to the point where it is not possible to complete the renovation and also not possible to open the facility to the public;

WHEREAS, a high number of pinhole leaks in the gas lines have been discovered serving HVAC units running over the leaking roof that need to be addressed; including replacement of the HVAC units as well as upgraded roof access for Union Gas to complete the gas line replacement;

WHEREAS, these infrastructure failures cannot be repaired and independent engineers have determined that the roof and HVAC requires replacement;

WHEREAS, the HVAC equipment which must be ordered has long lead times;

WHEREAS, inaction will result in facility damage from leaks, contractor demobilization, potential additional construction fees, delayed Library re-opening date and the inability to heat the facility over the winter;

WHEREAS, this work was unforeseen; and,

WHEREAS, Hamilton Public Library Board, at their meeting September 19, 2017, approved funding for one half of the requisite work;

THEREFORE BE IT RESOLVED:

- (a) That, pursuant to the City's Procurement Policy By-law Policy 11 Non-Competitive Procurements, Century Group Inc. be approved as the vendor for the urgent roof replacement, upgrade to roof access and HVAC replacement at the Dundas Library project, located at 18 Ogilvie Street, be approved; and,
- (b) That the General Manager, of the Public Works Department, be authorized and directed to negotiate and enter into an extension to Contract C13-27-16 for the urgent roof replacement, upgrade to roof access and HVAC replacement at the Dundas Library project, located at 18 Ogilvie Street, to be funded from the Capital Work in Progress Dundas Library account #7501341301, within staff limits and in a form satisfactory to the City Solicitor,

and report back to the Audit, Finance & Administration Committee with the outcome of those negotiations; and,

- (c) That the General Manager, of the Public Works Department, be authorized and directed to execute the extension to Contract C13-27-16 and ancillary documents with Century Group Inc. required for the urgent roof replacement, upgrade to roof access and HVAC replacement at the Dundas Library project, located at 18 Ogilvie Street, in a form satisfactory to the City Solicitor.

7.8 Amazon.com, Inc. – RFP for the Second Corporate Headquarters (Item 8.2)

(Merulla/Whitehead)

WHEREAS, Amazon.com, Inc. (Amazon) has issued a Request for Proposal (RFP) to determine the ideal location of its second Corporate Headquarters (HQ2) within North America;

WHEREAS, the City of Hamilton meets the bid criteria set out in the Amazon RFP and is a major urban center within the Greater Toronto-Hamilton area, with significant assets and services to offer;

WHEREAS, the Amazon HQ2 would grow our taxable, non-residential assessment base by 8 million square feet and increase the number of living-wage jobs in the City of

Hamilton by 50,000 in the first ten years; and, likely more considering the required support services;

WHEREAS, the City's Amazon HQ2 bid submission will also be prepared in a way to leverage other future, large scale economic development opportunities;

WHEREAS, staff have assessed the scope and complexity of Amazon's HQ2 RFP needs and are assembling the internal/external resources to mount a competitive bid;

WHEREAS, the cost of that bid will not exceed \$500K; of which the City Manager has the authority to allocate \$250K of City funding;

WHEREAS, staff are actively securing financial support from other private and institutional partners to fund the remaining \$250K required for the bid;

WHEREAS, staff are establishing a steering committee of community leaders from the private and public sector to work with all levels of government to advocate on behalf of Hamilton's Amazon HQ2 bid; and,

WHEREAS, the deadline to submit the Amazon HQ2 bid is October 19, 2017;

THEREFORE BE IT RESOLVED:

- (a) That staff be directed to work with provincial and federal governments to obtain their financial commitment to the Hamilton Amazon HQ2 bid submission to include, but not be limited to, the bid incentives as well as commitments related to re-investing revenues from a successful Hamilton bid into housing programs; small business support programs; and, other such programs that will ensure that a successful bid benefits all Hamiltonians;
- (b) That staff be directed to continue to work with private sector and institutional partners to supplement and offset the costs of the Amazon HQ2 bid submission, with any such funds to be added to the available budget for bid preparation
- (c) That By-Law 17-064, Procurement Policy, be waived in order to allow the City Manager to expediently engage the consultants required for the successful completion of the Amazon HQ2 bid, without exceeding the City's funding commitment; and,
- (d) That staff be directed to report back to the General Issues Committee with a breakdown on the total amount spent on the Amazon HQ2 bid, shortly after its submission.

7.9 Wentworth Lodge – Heritage Courtyard Project (Autumn Blaze Maple Trees) (Item 8.3)

WHEREAS, \$4,294 (HST included) for in the installation of 80mm calliper Autumn Blaze Maple trees at Wentworth Lodge, was approved as a portion of the \$100,000

outlined in Item 1(c), respecting Report CES17008 - Wentworth Lodge Courtyard Renovations, of the Emergency & Community Services Committee Report 17-003, which was approved by Council on April 12, 2017;

WHEREAS, the Wentworth Lodge Family Council believes that the 8” calliper Autumn Blaze Maple trees would be more suitable, as the more mature trees would provide an immediate source of shade for the residents; and,

WHEREAS, the installation of the 8” calliper Autumn Blaze Maple trees would increase the cost from \$4,294 (HST included) to \$24,860 (HST included), leaving an unfunded variance of \$20,566;

THEREFORE BE IT RESOLVED:

That \$20,566 for installation of 8” Autumn Blaze Maple trees at Wentworth Lodge, to be funded from the Ward 13 Specific Revenues Project (Account #3301609613), be approved.
