RECOMMENDATION

- (a) That the following be referred to the 2014 Budget Capital Budget process for consideration:
 - (i) That public facing Wi-Fi be installed in 26 City Recreation Centres, Community Centres and Arenas at a one-time implementation cost of \$128,000 with an annual operating impact of \$39,000 and 0.25 FTE:

- (b) That public facing Wi-Fi be installed in all Municipal Service Centres at a one-time implementation cost of \$7,000 to be funded from existing capital project number 2050757701;
- (c) That City parks not be considered for public facing Wi-Fi, at this time, due to cost versus benefit received;
- (d) That all City installed public facing Wi-Fi be branded and marketed as a service offered by the City of Hamilton and promoted in all suitable City promotional publications, at a one-time cost not to exceed \$3,000 for marketing and branding, to be funded from existing capital project number 2050757701;
- (e) That the item, respecting Wi-Fi in Municipal Buildings and City Wide Parks, be considered complete and removed from the Audit, Finance & Administration Committee's Outstanding Business List.

EXECUTIVE SUMMARY

The term Wi-Fi is used extensively throughout this report. Wi-Fi is the name of a popular wireless networking technology that provides wireless high-speed Internet and network connectivity. The availability of Wi-Fi makes high speed access to the internet possible for anyone with a Wi-Fi enabled laptop, tablet, camera, iPad, e-reader, game consoles and/or smart phone.

At the December 12, 2012, Council meeting, Report FCS09028(a) resulted in approval of the recommendation to dismantle the Wi-Fi infrastructure created through the Wireless Hamilton initiative. Wireless Hamilton ceased to provide public facing Wi-Fi as of March 1, 2013.

Council, at this same meeting, approved the following motion:

"That staff be directed to report back to the Audit, Finance and Administration Committee with a plan that seeks to address Wi-Fi capabilities in Municipal buildings and regional (City wide) parks."

The recommendations in this report shifts the strategic focus of the public facing wireless offering in the downtown core to one based on City facilities (i.e., recreation centres and administration buildings). The shift in strategy aligns with our comparator municipalities, as per the background research, which can be found in Appendix A of report FCS13033.

To meet the needs of various business units, or as part of Capital upgrades, the City currently has implemented public facing Wi-Fi in the following City facilities:

- All Fire Stations*
- Beasley Recreation Centre
- City Hall Lobby, Council Chambers, Board Rooms
- Dundas Town Hall
- Facility Services 330 Wentworth North
- Hamilton Street Railway Upper James Terminal*
- HECFI Facilities
- Lister Building
- Macassa Lodge
- MacNab Street Transit Terminal*
- Morgan Firestone Arena
- North Wentworth Twin Pad Arena
- Riverdale Recreation Centre**
- Rosedale Arena and Senior Centre**
- Sir Wilfrid Laurier Recreation Centre**
- Standard Life Boardrooms
- Stoney Creek Recreation Centre
- Traffic Operations
- Wentworth Lodge
- Westmount Recreation Centre

*Wi-Fi technology was installed in these locations to facilitate a specific business need and increase efficiency. For example, for Transit, Fire and EMS, when the vehicles enter the terminal or station, information is downloaded from the vehicle to a central database, eliminating the need for manual data entry. For transit, the system also downloads information from the Presto fare collection service. At the same time, information is uploaded to the equipment on the vehicles with no personal intervention. This includes software upgrades, security patches etc. for the computers on board.

The majority of the above locations provide Wi-Fi to both staff and the public. These locations are also accessible to staff that work in a mobile manner such as the various inspectors and public health nurses. These hotspots provide a location where staff can stop in during the day with their mobile device and check emails, enter data, access the corporate network for information etc., without having to return to the office.

The majority of the public facing Wi-Fi in the community centres/arenas above is a result of either new facilities being built or upgrades being conducted on existing facilities with the implementation of public facing Wi-Fi included in the capital construction costs.

FINANCIAL / STAFFING / LEGAL IMPLICATIONS (for Recommendation(s) only)

Financial: Recreation Centres, Community Centres and Arenas – Recommendation (a)

To implement public facing Wi-Fi in recreation centres, arenas and community centres outlined in Appendix B of report FCS13033 would incur a one-time cost of \$128,000. Appendix B of report FCS13033 provides cost details for both the purchase and installation of an appropriate number of access points to address public needs for the locations addressed by recommendation (a). The complete project would be implemented over a 3 year period. Once these Wi-Fi access points are installed they will take advantage of the existing fibre infrastructure in each facility eliminating any additional data transmission costs. There is also a need to add \$39,000 to the 2014 Information Services Division operating budget for on-going sustainability and support. A portion of this amount is for an additional .25 FTE for the Information Services Division of the Corporate Services Department for implementation and support of the new infrastructure.

<u>Municipal Service Centres – Recommendation (b)</u>

To implement public facing Wi-Fi in the Municipal Service Centres would incur a one-time cost of \$7,000 as outlined in Appendix C of report FCS13033. Once these Wi-Fi access points are installed they will take advantage of the existing fibre infrastructure in each facility eliminating any additional data transmission costs.

Parks designated as 'City Wide Parks' - Recommendation (c)

The direction from Council was to investigate the feasibility of providing Wi-Fi in what were referred to as Regional Parks. These parks are now referred to as City Wide Parks. Appendix D of report FCS13033 provides a map and Appendix E for report FCS13033

provides a list of the 23 parks designated as City Wide parks which are also listed below in Table 1:

There are a number of different technical solutions that can be used to implement a Wi-Fi solution in open spaces. In order to provide an accurate cost, each site would need to be evaluated on an individual basis, to acquire specific information such as the exact coverage area, appropriate technical solution, availability of fibre connectivity and backhaul costs.

A single access point provides coverage to a 150 metre radius from the access point. Multiple access points would be required in these parks to provide full park coverage, which would impact the installation cost significantly. Appendix F of report FCS13033 provides an indication of the costs to implement a single access point in parks, requiring different install scenarios, to implement multiple access points and the backhaul data costs.

Staffing:

The IS Division will require .25 FTE for the design, implementation and on-going support and maintenance of the new Wi-Fi infrastructure. The initial phase of Wireless Hamilton was an unsupported service which resulted in public dissatisfaction with the service. If we are to move ahead with public facing Wi-Fi, it is essential that a support model be put in place to ensure the needs of the public are addressed in a timely manner.

Legal:

Public Wireless Acceptable Use Policy, that has been approved by Legal Services, is already in place. This Policy is attached as Appendix H of report FCS13033.

HISTORICAL BACKGROUND (Chronology of events)

Report number FCS06102 was presented to the Committee of the Whole and approved at the September 27, 2006, Council meeting. This report was a joint submission by the City of Hamilton and FibreWired (since purchased by Rogers) to the Future Fund for \$501,102.98 to develop a wireless (Wi-Fi) infrastructure in the downtown area (bordered by Barton Street, Main Street, Victoria Avenue and Queen Street), as well as, five 'hotspots' (high-speed public wireless internet access locations) in strategic locations throughout the City. This request for funding, from the Future Fund, was for the initial phase of a multi-phase wireless project and the approval for the initial phase was for a 1 year period commencing January 2008.

Through Report FCS09028(a), Council at the December 12, 2012, meeting approved the recommendation to dismantle the existing Wireless Hamilton infrastructure to eliminate the provision of public facing Wi-Fi in open spaces.

Council, at this same meeting, also approved the following motion:

"That staff be directed to report back to the Audit, Finance and Administration Committee with a plan that seeks to address Wi-Fi capabilities in Municipal buildings and Regional (City wide) parks."

The Corporate wide focus group established to discuss the future of public facing Wi-Fi in Hamilton, discussed additional needs for future consideration of public facing Wi-Fi. This included suggestions such as:

- Employment and Income Support Patrons could use the Wi-Fi for job search activities and save their purchased cell phone or data usage for personal use. It would also allow them to view case updates;
- Transit way stations that would display bus arrival/departure times at major locations;
- Public Health Clinics enhance public service;
- Mobile Access Point(s) moved to locations throughout the City for events such as James Street Art Crawl, Around the Bay road race and other city festivals;
- Housing Services in shelters and drop in centres.

On-going requests for public facing Wi-Fi are being addressed as funding comes available.

ANALYSIS / RATIONALE FOR RECOMMENDATION

(include Performance Measurement/Benchmarking Data, if applicable)

Recommendation (a)

That the following be referred to the 2014 Budget Capital Budget process for consideration:

(i) That public facing Wi-Fi be installed in 26 City Recreation Centres, Community Centres and Arenas at a one-time implementation cost of \$128,000 with an annual operating impact of \$39,000 and 0.25 FTE.

The City currently has public facing Wi-Fi in the following City recreation centres, arenas and community centres:

- Ancaster Rotary Centre
- Beasley Recreation Centre
- North Wentworth Arena
- Riverdale Recreation Centre *
- Rosedale Arena *
- Sir Wilfrid Laurier Recreation Centre *
- Stoney Creek Recreation Centre
- Westmount Recreation Centre
 - * Currently underway, will be operational in March 2013.

The public facing Wi-Fi in the Recreation Centres, Community Centres and arenas above is a result of either new facilities being built; upgrades being

conducted on existing facilities with Wi-Fi included in the capital construction costs; or a specific need was being addressed as funding became available.

Staff research definitely indicates this is a trend in the various Municipalities across the country – see Appendix A of report FCS13033. The Cities of Burlington and Mississauga and the Town of Oakville already have public Wi-Fi in all Municipal arenas, community centres and recreation centres. The majority of the cities surveyed, indicated they have already implemented Wi-Fi in recreation facilities or planning to do so is underway.

According to our research and input from stakeholders, public facing Wi-Fi in Community Centres, Recreation Centres and arenas would allow:

- A better user experience for the public. While the children are participating in the various recreation programs guardians can catch up on unfinished tasks, read a book on their e-reader, browse the internet, communicate with others;
- Additional service for facility rentals. A growing number of customers expect internet to be available when they rent space in a City facility;
- Internet access should these facilities be needed as emergency evacuation centres;

Wi-Fi is quickly becoming a customer service standard. Recreation customers expect easy, fast and reliable access to information as well as the ability to stay in touch while they enjoy everything recreation facilities have to offer.

Staff in the Recreation Division of the Community Services Department have reviewed the list of facilities they administer and have developed a phased approach to implementing public facing Wi-Fi in their facilities. Appendix B of report FCS13033 outlines a 3 year implementation plan along with the costs associated with each facility. Appendix B of report FCS13033 also includes facilities that are not being recommended for public facing Wi-Fi at this time as these facilities will be addressed by future capital projects or, in some cases, the future of the facility is under discussion.

The operating impact associated with the above-noted capital investment totals approximately \$39,000. This consists of \$14,875 for controller maintenance, \$22,500 for .25 FTE and \$1,500 for licenses. This request for an additional .25 FTE is for the implementation and on-going maintenance and management of any new Wi-Fi infrastructure. IS staff currently manage and maintain all Wi-Fi technology in the facilities listed in Appendix G of report FCS13033, as well as, the Wi-Fi that is available in 21 of the Hamilton Public Library branches.

Recommendation (b)

That public facing Wi-Fi be installed in all Municipal Service Centres at a one-time implementation cost of \$7,000 to be funded from existing capital project # 2050757701.

The Municipal Service Centres, along with City Hall, are the locations where the public interact with the local level of government. Staff are recommending providing public facing Wi-Fi in these locations as these facilities are also used by local community groups as meeting or gathering places. Appendix C of report FCS13033 provides details on the cost of providing Wi-Fi in the various Municipal Service Centres.

Recommendation (c)

That City Wide designated parks not be considered for public facing Wi-Fi at this time due to cost versus benefit received;

As outlined in Appendix F of report FCS13033 and as experienced through the Wireless Hamilton initiative, providing Wi-Fi in outdoor locations, is expensive. The access points are more costly than those required for an indoor solution, the annual data backhaul expenses are \$4,200 per location, and fibre installation in some of the City Wide Parks is felt to be cost prohibitive based on the benefits received. Part of the rationale for disbanding Wireless Hamilton was the annual cost of data transmission.

Some of the City Wide parks have a fibre connection within the park boundaries and installation would be less costly than those parks that do not currently have a fibre point of presence. There are a number of different technical solutions to address the provision of Wi-Fi in open spaces. Appendix F of report FCS13033 provides some indication of the expected costs for Wi-Fi in open spaces; however, in order to get a more exact cost additional staff investigation would be required to establish the exact cost to acquire fibre connectivity and determine the number of access points to provide adequate coverage. Appendix A of report FCS13033 which provides the status of Wi-Fi in other Municipalities, indicates that most Municipalities are not providing public facing Wi-Fi in open areas.

Recommendation (d)

That all City installed public facing Wi-Fi be branded and marketed as a service offered by the City of Hamilton and promoted in all suitable City promotional publications, at a one-time cost not to exceed \$3,000 for marketing and branding, to be funded from existing Capital.

Whether the City continue using the "Wireless Hamilton" branding or establish a new brand for public facing Wi-Fi, it is important to let the public know this service is available and being provided by the City for their use. The initial phase of Wireless Hamilton did not include funding for branding and usage suffered because of it. Some suggestions for a brand are "Hamilton Connects" or "Connected Hamilton".

Staff are also investigating a program similar to "Keep Hamilton Blooming" which would be marketed to potential sponsors as "Keep Hamilton Connected". Staff will investigate the feasibility and interest in this type of initiative which would provide promotional signage to a sponsor in a specific facility while off-setting some of the operational costs.

ALTERNATIVES FOR CONSIDERATION

(include Financial, Staffing, Legal and Policy Implications and pros and cons for each alternative)

An alternative to Recommendations (a) and (b) would be to address these facilities, one at a time, either when a capital project is involved for upgrading a facility or when a specific business need arises and funding is available. This alternative means that some recreation facilities may never be addressed with public facing Wi-Fi while other neighbourhoods are being addressed. This is not being recommended as other comparator municipalities are providing public facing Wi-Fi in their recreation facilities and not providing Wi-Fi may have a negative impact on perception of the city as a technology enabler and on public participation in programs if a similar service is not offered.

Financial: The costs associated with this alternative would depend on the facilities being addressed. Appendix B and C of report FCS12033 provide the cost for an individual facility.

Staffing: At some point with growth in the Wi-Fi infrastructure an additional staff resource would be required. To address the 26 recreation centres would require an additional .25 FTE in the Information Services Division.

Legal: N/A

An alternative to recommendation (c) would be that one or two highly utilized City Parks be investigated further to establish exact costs for the implementation and maintenance of public facing Wi-Fi in outdoor spaces. A report would be brought

back to the Audit, Finance and Administration Committee with detailed costs and pilot criteria allowing Council to determine if staff would proceed with a pilot implementation in City wide parks or other public gathering places.

Financial: To provide exact financial information on a specific park additional effort would be required to determine coverage area, number of access points required, availability of a fibre connection, and technology solution. Some estimates are provided in Appendix F of report FCS13033.

Staffing: At some point with growth in the Wi-Fi infrastructure an additional staff resource would be required. An increase in staff compliment would not be required to pilot public facing Wi-Fi in a couple of City Wide Parks.



For Transit and Hamilton Emergency Services, when the vehicles enter the terminal or station, information is downloaded from the vehicle to a central database, eliminating the need for manual data entry. For Transit, the system also downloads information from the Presto fare collection service. At the same time, information is uploaded to the equipment on the vehicles with no personal intervention. This includes software upgrades, security patches etc. for the computers on board.

Any person who accesses or uses the wireless <code>Network</code> is personally responsible and liable for his or her own actions and use. ACCESS AND USE OF THE INTERNET AND ALL INTERNET SERVICES SUCH AS EMAIL SHALL BE AT YOUR OWN RISK.
