(d) PRESENTATIONS (Item 5)

(i) All Terrain Vehicles on Agricultural lands (no copy) (Item 5.1)

Officer David Hennick gave a presentation respecting ATV's on Agricultural lands within Hamilton. Officer Hennick spoke of Hamilton Police's initiative respecting ATV enforcement and new ATV squad.

The Committee asked questions of Officer Hennick with respect to enforcement, and what people in the rural community can do to protect themselves.

The presentation by David Hennick respecting All Terrain Vehicles on Agricultural lands, was received.

The Committee discussed the assessment rate of rural property. The Committee also discussed concerns with foreign ownership of agriculture lands within the Hamilton area.

(iii) Road Salt Usage in the Rural Area (no copy) (Item 6.3)

The Committee expressed concerns with the usage of road salt, and its effects on agricultural land. The Committee questioned if the City following the Code of Practice for the Environmental Management of Road Salts.

Darrel Smith, Manager, Roads & Maintenance was invited to a future meeting of the Agriculture & Rural Affairs Advisory Committee to speak on the use of road salt in the rural area.

(iv) Culverts and Rural Road Drainage (no copy) (Item 6.4)

The Committee discussed issues with rural drainage, and issues with the replacement of culverts in the rural area. The Committee indicated that they have concerns with the way some culverts have been replaced, and their effectiveness.

Darrel Smith, Manager, Roads & Maintenance was invited to a future meeting of the Agriculture & Rural Affairs Advisory Committee to speak on the Instillation and replacement of culverts in the rural area.

(v) Internet Service in the Rural Area (no copy) (Item 6.5)

The Committee indicated that internet service has improved in the rural area. Councillor Ferguson indicated that there has been an interest in installing fiber optic cable in the rural area, to offer more telecommunication options for rural consumers.
