Community consultation has taken place over the last year and a half, and to date, 104 individuals and 18 agencies have contributed their signatures to support endorsement of the Hamilton Food Charter.

Members are anxious to receive city department feedback in a timely fashion.

Media coverage has helped the coop gain momentum.
