## **CITY OF HAMILTON**

### **BY-LAW NO. 17-**

**A By-law to Amend Zoning By-law 05-200 by Repealing said By-law on Lands Located at 1215, 1217, 1219, 1221, 1227, 1229, 1231, 1235, and 1239 Barton Street (Stoney Creek)**

**WHEREAS** this By-law repeals Zoning By-law No. 05-200 on lands located in Stoney Creek as a result of a motion passed by Council on the 27<sup>th</sup> day of September, 2017;

**NOW THEREFORE** Council enacts as follows:

1. That Map No. 1311 of Schedule "A" - Zoning Maps, of Zoning By-law No. 05-200, be amended by deleting lands, the extent and boundaries of which are shown on a plan hereto annexed as Schedule "A" to this By-law.
2. That the Clerk is hereby authorized and directed to proceed with the giving of notice of the passing of this By-law, in accordance with the *Planning Act*.
