2. Ancaster Tennis Bubble PW17089 (Ward 12) (Item 5.2)

That Report PW17089 respecting the Ancaster Tennis Bubble, be received.

3. Sewer Lateral Cross Connection Program Update (PW14028(b)) (City Wide) (Item 5.3)

That Report PW14028(b) respecting the Sewer Lateral Cross Connection Program Update, be received.

4. Aviary, 85 Oak Knoll Drive, Churchill Park (PW17080) (Ward 1) (Item 8.5)

- (a) That capital funds in the amount of \$40K be approved to be funded from existing capital program 4401056127 (Churchill Park) to address building clean up and the existing Orders to the City from the Ontario Society of Prevention of Cruelty to Animals (OSPCA);
- (b) That the Friends of the Aviary (FOTA) work with Animal Control Section, Building and Licensing Division, and a licensed Veterinarian to commence immediate efforts to find an alternate location for the birds, and to report back no later than Jun 30, 2018, to Public Works Committee to confirm the new location for the birds. The move to an alternate location must be completed no later than November 22, 2018;
- (c) That the Director of Environmental Services be authorized to negotiate and enter into a new agreement with FOTA and terminate the 1992 agreement to the satisfaction of the City Solicitor with content satisfactory to the General Manager of Public Works, to confirm roles and responsibilities as per recommendation (b);
- (d) That with FOTA confirming a new location for the birds as per recommendation (b) that FOTA assume ownership of the existing birds at the Aviary on November 23, 2018 5:00PM for a fee of \$1.00, and that the Director of Environmental Services Division be authorized to take all necessary steps to transfer ownership of the birds;
- (e) That should FOTA not be successful in confirming an alternate location for the birds by June 30, 2018 5:00 PM, that the Animal Control Section, Building and Licensing Division, and a licensed Veterinarian commence relocating the birds, and that the Director of Environmental Services Division be authorized to take all necessary steps to terminate the new agreement between the City of Hamilton and FOTA.

5. Lighting Asset Modernization Project Acceleration (PW17085) (Item 8.1)

(a) That the acceleration proposal of the Lighting Asset Modernization Project be approved and facilitated through a single source procurement, pursuant to Procurement Policy #11 – Non-competitive Procurements, for the extra costs associated with accelerating to an upset limit of \$185,000; (b) That the General Manager of Public Works and Finance & Corporate Services, or his designate, be authorized to enter into and sign on behalf of the City of Hamilton, all negotiated agreements and all necessary associated documents with Fairway Electrical Services Inc., with content acceptable to the General Manager of Public Works, and in a form satisfactory to the City Solicitor.

6. Graffiti Management Strategy (PW17078/PED17198) (City Wide) (Item 8.3)

- (a) That the Graffiti Management Strategy and associated timelines outlined in this report be approved;
- (b) That staff provide updates on the progress of the Graffiti Management Strategy and its various components as part of the Clean and Green Strategy annual reporting;
- (c) That Municipal Law Enforcement (MLE) be approved to hire two (2) Municipal Law Enforcement Officers (Co-op students) for a 2 year pilot project;
- (d) That annual costs associated with hiring of two (2) Municipal Law Enforcement Officers (Co-op students) and operating costs of one (1) vehicle, approximately \$114,100, be funded through the Tax Stabilization Reserve #110046;
- (e) That the one-time capital cost associated with the purchase of one (1) vehicle to support the new Municipal Law Enforcement Officers (Co-op students), approximately \$26,400, be funded through Tax Stabilization Reserve #110046;
- (f) That the internal Graffiti Working Group, led by Policy & Programs staff, develop and undertake a graffiti enforcement strategy with victim assistance program.

7. Gypsy Moth Infestation Control Program (PW17088) (City Wide) (Item 8.4)

(a) That staff be directed under By-law 08-070 Respecting Gypsy Moth Infestation, to implement a Gypsy Moth Control Program involving aerial application of the biological control agent *bacillus thuringiensis 'kurstaki*' (Btk), to control the larval stage of *Lymantria dispar dispar* (European Gypsy Moth);

- (b) That infested areas which exceed 2,500 egg masses per hectare, as identified in By-law 08-070 as the treatment threshold, be the areas to receive aerial application of the biological control agent *bacillus thuringiensis 'kurstaki'* (Btk), as estimated in maps attached as Appendix E to PW Report 17-013 and that staff report back on actual areas of application upon completion of 2017 fall monitoring prior to treatment;
- (c) That By-law 08-070 Respecting Gypsy Moth Infestation be amended to remove reference to PW08028a and its appendices;
- (d) That the anticipated cost of \$1,950,000 in 2018 and \$550,000 in 2019 be referred to the 2018 capital budget process funded through the Tax Stabilization Reserve.
- (e) That a follow up survey be performed in the Fall of 2018, following treatment, to provide an assessment of the Gypsy Moth population size in the areas that were treated;
- (f) That the costs associated with the follow up survey be included in the total anticipated capital costs identified for the Gypsy Moth Infestation Control Program detail sheet to be submitted through the 2018 capital budget process;
- (g) That correspondence be sent to the Minister of Natural Resources and Forestry, requesting financial assistance from the province in dealing with Gypsy Moth infestations, and that any received funds will be used to offset the capital impacts identified through this program.

8. Removal of Outstanding Business List Item - Sulphur Springs Well (Item 9.1)

WHEREAS, at the August 17, 2017 meeting of the Public Works Committee staff were directed to bring back a report regarding options for keeping the Sulphur Springs Well open to the public; and,

WHEREAS, the Hamilton Conservation Authority has recently taken actions to resolve the issues surrounding the Sulphur Springs well and a City of Hamilton staff report is no longer required,

THEREFORE BE IT RESOLVED:

That the matter respecting a report request regarding the Sulphur Springs Well be removed from the Public Works Committee's Outstanding Business List.

10. Dundas Driving Park – East Rock Garden Project (Irrigation) (Added Item 10.1)

WHEREAS, the Dundas Driving Park has an historic rock garden on the west side of the park which, for many years, was in disrepair;

WHEREAS, in 2015 a group of local volunteers agreed to take responsibility for the rejuvenation and continued maintenance of this local landmark;

WHEREAS, as a result, the garden is once again the object of great beauty that it once was;

WHEREAS, this same group of volunteers have agreed to rejuvenate and maintain a second old rock garden on the east side of the Dundas Driving Park;

WHEREAS, there is no existing irrigation in the rock garden on the east side of the park and without it the garden cannot be rejuvenated and maintained successfully;

THEREFORE BE IT RESOLVED:

That up to \$5,500 for the installation of irrigation in the rock garden on the east side of the Dundas Driving Park, to be funded from the Ward 13 Cell Tower Revenues in Specific Revenues Project (Account #3301609613), be approved.


