THE FOLLOWING ITEMS WERE REPORTED TO COUNCIL FOR CONSIDERATION:

1. King Street West westbound Lane Closure (PW13041) (Ward 2) (Item 5.2)

(Collins/Jackson)

That Report PW13041 respecting King Street West westbound Lane Closure, be received.

2. Permanent Closure and Sale of a Portion of the Road Allowance of Kingsview Drive, Stoney Creek (PW04058(a)) (Ward 9) (Item 8.1)

(Jackson/Pasuta)

- (a) That in accordance with the approved recommendations of Item 8 Public Works, Infrastructure Report 04-011 that closure and sale of a road allowance of Kingsview Drive Stoney Creek, abutting 2 Tamarack Place as shown on Appendix A, attached to Report PW04058(a) (the "Subject Lands") proceed, subject to the following conditions:
 - (i) That the City Solicitor be authorized and directed to prepare a bylaw to permanently close the Subject Lands abutting as a public highway;
 - (ii) That the appropriate by-law be introduced and enacted by Council;

- (iii) That the Economic Development and Real Estate Division of the Planning and Economic Development Department be authorized and directed to sell the Subject Lands to the applicant in accordance with the Procedural By-law for the Sale of Land, By-law No. 04-299 at fair market value;
- (iv) That the City Solicitor be authorized and directed to register a certified copy of the by-law permanently closing the highway in the proper land registry office, upon confirmation from the Public Works Department that all applicable fees and costs associated with the application have been paid by the applicant;
- (v) That the by-law permanently closing the highway does not take effect until a certified copy of the by-law is registered in the proper land registry office;
- (vi) That the applicant deposits a reference plan under the Registry Act and that said plan be prepared by an Ontario Land Surveyor to the satisfaction of the Manager, Geomatics and Corridor Management Section and that the applicant deposit a reproducible copy of said plan with the Manager, Geomatics and Corridor Management Section.
- (vii) That the appropriate easements required by Union Gas and Hamilton Water be obtained by the applicant at the applicant's expense.
- (viii) That the Public Works Department publish a notice of the City's intention to pass the by-law pursuant to City of Hamilton By-law 04-299 being a By-law to Establish Procedures, including the Giving of Notice to the Public, Governing the Sale of Land Owned by the City of Hamilton.

(i) Gold Award - Best Public Sector GIS

Chair Ferguson recognized Hamilton's Public Works Department who recently received a gold award for implementing the Best Public Sector GIS (geographic information system). The award was presented by the Ontario chapter of the Urban and Regional Information Systems Association.

Hamilton received the coveted award May 8 for its Go360TM Permit Tracking solution. The system collects data from across the municipality, as well as third-party utility companies, to enable users to manage all types of permits required for road repairs and road use. Hamilton is the first municipality to implement this kind of system which integrates GIS data with other information systems to recover the proper amount of pavement degradation costs from road cutting. It also improves the coordination and safety of road-cutting projects among various organizations that maintain underground infrastructure. Permit Tracking follows the progress of all right-of-way permits from creation to completion including restoration.

Chair Ferguson invited Gord McGuire, Bob Howard, Gary Kirchknopf and Rich Shebib, forward for the presentation of the award.
