New Year's Eve Party @ Fairweather Brewery – Special Occasion Permit Liquor Licence

WHEREAS, Hamilton City Council has received Notice (attached hereto as Appendix "A") from Dan Ryan on behalf of the Fairweather Brewing Company that they wish to obtain approval for a Special Occasion Permit Liquor Licence to sell alcohol on December 31, 2017 between the hours of 8:00 p.m. and 1:00 a.m. at the Fairweather Brewing Company, 5 Oldfield Road, Unit 1, Hamilton, Ontario during the New Year's Eve Party @ Fairweather Brewery taking place in Hamilton, Ontario;
