4. Presentations:

4.1 Immigrant and refugee shelter access in the City of Hamilton Presentation overviews:

• Grace Baldwin, Good Shepherd Family Centre

- The Good Shepard Family Centre is an emergency shelter for families which also provides diversion support (avert losing shelter) and eviction prevention

 The shelter also supports refugee claimants at port of entry and supports persons with no status

- In 2017 the shelter served 128 families 51% were refugees or person with non-status.
- Refugee and non-status persons tend to stay at the shelter on average 17 more days than families
- the main issue is the time to process a person with non-status can't do anything – can't sign a lease, can't register
- In 2017 the shelter saw a huge spike in July, August and September due the impact of Global issues.
- Shelter staff not considered expert in the area of assisting with new comer issues – they are learning as they go
- there is an identifiable gap for refugees as to where they can get additional services the shelter staff focus on helping
- Mika House is the only shelter that is specific to refugee
- The biggest issue is New comer shelter
- Can ask to place in hotel last year there were 86 hotel referrals
 28% were for new comers
- presenter believes that early access to permanent housing is the best solution for everyone
- Trish Larner, Program Manager Mary's Place (Women's Shelter)
- target group is single women
- demographic information collected showed that usage went from 0-3 women/month in the first 3rd of last year to 15women/month in the last 3rd of the year – this influx reflects services to new comers
- this is a result of women staying longer and results in less women receiving services overall
- working with refugees and non-status persons is very new to the organization
 – usually work with mental and drug addiction issue
- the following issues have been identified for new comers:
 - Lack of immigration lawyers in Hamilton.
 - referring to Toronto base lawyer
 - transportation issues to Toronto
 - lack of outreach workers to go with them
 - Lack of health coverage. They don't seek medical because they are afraid it will affect their status.
 - Avoiding to access hospital as without status can end up with costly bills.
 - New Comers don't qualify for recommended programs that have financial assistance.
 - Agencies don't have translation services.
- Charmain Shand , Program Manager Martha House (Women's Shelter)
- Service women or children experiencing violence or homelessness
- Seeing an influx of new comers which have created a big challenge for staff to understand issues and manage immigration issues
- They are starting from scratch:

- o lawyers
- language assessment
- \circ interpreters, funding issue
- no funds to work with in the first few months while they are getting to the paper work
- if women is pregnant can see on site doctor but if addition tests are required have to pay
- The support after leaving the shelter seems to be an issue and some staff are extending their involvement with individuals beyond their stays at the shelter.
- There are not enough ESL programs in Hamilton. If they attend employment program, there is no translation services
- The see families who had trauma in their home country, can't start with any counselling because the settlement piece is so overwhelming.
- Presenter believes shelter service specific to new comer with skills in settlement and available funding can better service this demographic.
- Daryl Chezzi, Good Shepherd Centre (Men's Shelter)
- Shelter experience waves and influx of men presenting with no status.
- Some helpful strategies make sure that they return to 3rd floor program – more private – allow to stay longer -18 days is the average stay. Program is full most times.
- Medical care is an issue.
- Main limitation is that Settlement Services don't apply or they are coming back to shelter workers as they are comfortable and trust them.
- The shelter is setting up on-site programming.
- In Toronto New Comer specific shelters are run by private religious organization.
- Presenter believes that specific housing earmarked for new comers and some child tax benefit to subsidize housing would benefit.
