

### **Community Planning & GIS**

<b>Position</b>	<b>Status</b>
Manager, Community Planning & GIS	Temporary vacancy. Alissa Mahood has accepted the position on a temporary basis until the incumbent returns to work.
Senior Project Manager (SPM), Community Planning & GIS	Vacant. This is a temporary vacancy due to Alissa Mahood assuming the Manager position on a temporary basis.
Senior Planner, Community Planning & GIS	Position filled. Vacancy due to previous incumbent assuming SPM position in Development Planning, Heritage and Design.
Intermediate Planner, Community Planning & GIS (2 Vacancies)	One position became vacant as a result of parental leave.  One position became vacant because incumbent was the successful applicant for Senior Planner, Community Planning position. This position has subsequently been filled internally.
Planning Technician	One position became vacant as a result of internal staff movement.

### **Development Planning, Heritage and Urban Design**

<b>Position</b>	<b>Status</b>
Senior Project Manager (Rural)	Temporary Vacancy. Position has been filled as an Expression of Interest/Career Development opportunity. Trudy Kennedy was the successful internal applicant.
Senior Planner, Development Planning, Heritage and Urban Design (3 Vacancies)	Two of the three vacant positions were the result of the incumbent accepting employment with another municipality. The third vacancy was the result of the incumbent accepting a temporary position within PED as a career development opportunity.  All three vacant positions were posted and have been filled. One position was filled internally and the remaining two positions were filled by external applicants.
Planner I (Intermediate Planner)	There are currently 4 Planner I positions. Two positions became vacant as a result of internal staff movement. A third position became vacant as a result of the incumbent accepting a position with a consulting firm in Toronto. The positions will be posted in May.

	One vacant position was filled internally.
Planner II (Junior Planner)	One position became vacant as a result of internal staff movement. The position has been recently filled.
Planning Technician II	This is a newly created position from the Assistant Secretary-Treasurer, Committee of Adjustment. The position has been posted and interviews are being scheduled.
Assistant Secretary, Committee of Adjustment	There are two positions. One position became vacant as a result of the retirement of the incumbent and has been changed to Planning Technician II.
Administrative Secretary	The position has recently become vacant. The position will be posted in May 2019 and interviews will be scheduled for June 2019.
