

THIS AGREEMENT made this Twenty-fifth day of November, 1952.

OF THE FOURTH PART:

WHEREAS the Parties of the First Part are each respectively owners of part of Lot Number One in the Broken Front Concession of the Township of Saltfleet.

AND WHEREAS the Parties of the Second Part are each respectivel, owners of part of Lot Number Two in the said Broken Front Concession.

AND WHEREAS the Parties of the Third Part are purchasing part of Lot Number One under Agreement for Sale as evidenced by Agreement registered in the Registry Office for the Registry Division of Wentworth in Book for the Township of Saltfleet as Number 46488.

AND WHEREAS the Parties of the Fourth Part are registered Mortgagees respectively of certain parts of Lots Numbers One and Two owned by certain of the parties of the First and Second Parts.

AND WHEREAS by an Agreement registered in the said Registry Office in Book for the Township of Saltfleet as Number 30815, a right of way was created for the use of the parties of the First and Second Parts, their heirs and assigns.

AND WHEREAS by the said last mentioned Agreement it was provided that the owners of the lands and premises described in said last mentioned Agreement had the further right to use the continuation of such roadway or right of way as then existing from the westerly limit of the lands described in Schedule "A" in said registered Instrument Number 30815 to the road allowance between Lots Numbers Two and Three.

AND WHEREAS the said continuation of such readway or right of way or part thereof has been lost through erosion of Lake Ontario and is unusable.

AND WHEREAS the parties hereto have released and conveyed their right to use the said continuation of such roadway or right of way to Peter T. Smylski, owner of that part of Lot Number Two over which the said continuation of such roadway or right of way passed.

AND WHEREAS the parties of the First, Second and Third Parts have purchased from Peter T. Smylski and Donald James Bernard McCollum parts of Lot Two in the said Broken Front Concession of the Township of Saltfleet more particularly described in the Conveyance thereof from the said Peter T. Smylski and Donald James Bernard McCollum, the said Township having agreed to dedicate the lands described in the said Conveyance as a highway.

AND WHEREAS all the parties hereto have agreed with the owners of the lands described in said registered Agreement Number 30815 to release and convey all their right to use the said roadway or right of way described in said Instrument registered Number 30815 in consideration of the grant of a new roadway or right of way to connect with the said Township road.

AND WHEREAS this Indenture is entered into for the

purpose of creating such new roadway or right of way in defining the rights of the parties hereto with respect to the same and for releasing all the rights heretofore existing.

NOW THIS INDENTURE WITNESSETH that in consideration of the premises and the further consideration of the sum of One Dollar paid by each of the parties hereto to each of the other parties hereto (the receipt whereof is hereby acknowledged) the parties hereto mutually covenant and agree as follows:

THAT the following lands shall be designated as a roadway or right of way, viz., consisting of a strip of land Twenty feet (201) in width and lying Ten feet (101) on either side of centre lines, the first of such lines being in said Lot Two described as follows: COMMENCING at a point in the Northerly limit of the Township Road conveyed by Donald James Bernard McCollum to the Township of Saltfleet by Deed dated day of Muguet. 1952, said point being Ten feet (10') measured on a course of North sixty-eight degrees and seven minutes west (N 680 07! W) from a point on the division line between Lots One and Two in the said Broken Front Concession of the Township of Saltfleet and which point on said division line is Three thousand Six hundred and Fifty-seven feet Six inches (3,657'6") measured on a course of North Twenty-one degrees and Fifty-five Minutes East (N 21055' E) from the Northerly limit of the road allowance between the Broken Front and First Concessions of the Township of Saltfleet; THENCE North Twenty-one degrees and Fifty-five Minutes East (N 21055' B) and parallel to the division line between Lots One and Two a distance of Two Hundred and Ten feet (210').

The second of such lines being in said Lot Number
Two described as follows: COMMENCING in the said division line
between Lots One and Two which point is Three thousand Eight
hundred and Sixty-seven feet Six inches (3,867'6") measured
on a course of North Twenty-one degrees and Fifty-five minutes
East (N 210 55' E) from the Northerly limit of the road allowance



between the Broken Front and First Concessions of the Town-ship of Saltfleet; THENCE North Sixty degrees and Forty-five minutes West (N  $60^{\circ}$  45' W) a distance of Three hundred and Thirty feet (330').

The third of such lines being situate in said Lot One, described as follows: COMMENCING at the last mentioned point on the said division line between Lots One and Two, THENCE South Fifty-two degrees and Five munutes East (S 52° 05' E) a distance of Five hundred and Fourteen feet Seven inches (514'7").

- 2- THAT such roadway or right of way may be used by the respective parties hereto in connection with the respective lands described in Schedule "A" hereto.
- 3- THAT such roadway or right of way shall constitute the only right that any of the parties hereto shall hereafter have to use or cross the lands of any other parties hereto and the execution hereof shall operate as a release and conveyance of all rights heretofore subsisting including, but without restricting the generality thereof, the rights covered by the said Instrument registered Number 30815.
- 4- THAT the right to use the said roadway or right of way shall extend in perpetuity to the respective parties hereto for the passage of persons, animals and vehicles for all purposes necessary for the enjoyment of the lands respectively of the parties hereto and to their respective heirs, executors, administrators or assigns.
- 5- THAT Hugh W. Wylie and Nora Christabel Wylie and
  Donald James Bernard McCollum and Freeman Wilton Arthur McCollum,
  do hereby
  four of the parties hereto, each/make all the necessary grants
  to each of the other of them and to each of the other parties
  hereto in order to effectuate these presents.
- 6- THAT the owners from time to time abutting on the said roadway or right of way shall bear an equal share of the maintenance of the said roadway or right of way and in the



event of there being any dispute as to the condition in which the said roadway or right of way is maintained, then the same shall be settled by the Township Road Superintendent and if he will not act, then by a single arbitrator appointed under The Arbitration Act.
