EXECUTIVE SUMMARY

This is the final report in the phased approach in reporting back to Council to close out the 2020 City Enrichment Fund. Appendix A to Report GRA20003(c) contains the fourth phase of recommendations that have been submitted by City Enrichment Fund (CEF) Staff working with our applicants on a case-by-case basis to understand their status and report back to Council. Throughout this unpredictable year, CEF Staff closely followed CEF guidelines and the grant's mandate to ensure consistency, accountability and

transparency in our processes. Our community groups were top-of-mind every step of the way.

2020 City Enrichment Fund – Phased Approach:

Phase 1 - Amount Approved: \$ 2,541,713

Phase 2 - Amount Approved: \$ 2,640,836

Phase 3 - Amount Approved: \$84,663

Phase 4 - Pending Approval: \$ 166,851

Total Remaining Funds: \$654,277

Total CEF Budget: \$6,088,340

Programming Status:

The 2020 City Enrichment Fund consisted of 336 applications. With the phased approach this year a summary of programming status due to COVID reflects:

In-line with everything else this year, circumstances and funding sources have consistently changed. From the first report in May 2020 to September 2020, many of our applicants either received additional funding from other sources, continue to access other areas of funding that are still arising and becoming available from other levels of government or still in the process of pivoting their programming based on Hamilton reopens.

With the availability of additional COVID-19 supports, distribution of any remaining funds at this time would require a new set of guidelines and processes to follow-up with the status of organizations at this stage again. These fundamental resources are currently not available as many staff have been redeployed. As the city and community continues to adapt to a new normal, the remaining funds going to the reserve means

that there would be availability of one-time allocation to CEF applicants should it arise in the future.

Alternatives for Consideration:

FINANCIAL – STAFFING – LEGAL IMPLICATIONS

Financial: The 2020 approved budget for the City Enrichment Fund is \$6,088,340. All recommendations are within the approved 2020 budget. Payments of grants will be made based on the approved City Enrichment Fund payment plan (per Council approved guidelines).

- Staffing: There are no additional staff required to execute this phased approach, but there are additional work load and scheduling implications associated with the recommendations in Report GRA20003(c).
- Legal: There are no legal implications associated with the recommendations in Report GRA20003(c).
