However, the mapping layer has been inadvertently hidden from view since OMB Approval of the RHOP.</p> |
| <p>Volume 1: Schedule B-5 – Detailed Natural Heritage Features Key Hydrologic Feature Lakes and Littoral Zones</p> | <p>Identify Cootes Paradise and Desjardins Canal as “Key Hydrologic Feature Lakes and Littoral Zones”.</p>  <p>Remove “Key Hydrologic Feature Lakes and Littoral Zone” identification from Lake Ontario and depict both Lake Ontario and Hamilton Harbour as waterbodies (light blue).</p> | <p>Cootes Paradise and Desjardins Canal have always been identified as Key Hydrologic Feature Lakes and Littoral Zones. However, the mapping layer has been inadvertently hidden from view since Council Adoption of the RHOP. Depicting Hamilton Harbour and Lake Ontario as waterbodies (light blue) will improve interpretation by clarifying that these features are located outside Rural Hamilton.</p> |



| <p>Volume 2: Map 7 – Freelton Rural Settlement Area Plan – Land Use Plan</p> | <p>Redesignate lands from “Settlement Residential” to “Community Park” for lands located at 170 Freelton Road, Flamborough.</p>  | <p>Mapping error. Lands are owned by the City of Hamilton and are used for parkland purposes.</p> |

| <p>Volume 3: Appendix A – Site Specific Key Map</p> | <p>Identify lands located at 256 Lime Kiln Road, Ancaster as “Rural Site Specific Area R-YY”</p>  | <p>The identification of the lands as R-YY coincides with the addition of the rural site specific area text added to Volume 3 (see PED20201, Appendix “D2”).</p> |
