## **CITY OF HAMILTON**

### **BY-LAW NO. 19-**

**To Permanently Close and Sell a Portion of Public Unassumed Alley  
Abutting 193 East 22<sup>nd</sup> Street, Hamilton, Ontario, namely Part of Alleyway,  
Registered Plan 590, in the City of Hamilton, designated as Part 1, Plan  
62R-21039, being Part of PIN 17055-0097 (LT); City of Hamilton**

**WHEREAS** sections 8, 9 and 10 of the *Municipal Act, 2001* authorize the City of Hamilton to pass by-laws necessary or desirable for municipal purposes, and in particular by-laws with respect to highways; and

**WHEREAS** section 34(1) of the *Municipal Act, 2001* provides that a by-law permanently closing a highway does not take effect until a certified copy of the by-law is registered in the proper land registry office; and

**WHEREAS** highways to be closed by by-law are declared to be surplus to the needs of the City of Hamilton under the Sale of Land Policy By-law; and

**WHEREAS** at its meeting of March 28, 2018, Council approved of Item 5 of Public Works Committee Report 18-004, and authorized the City of Hamilton to permanently close and sell the portion of the public unassumed alley abutting 193 East 22<sup>nd</sup> Street, Hamilton, Ontario, namely Part of Alleyway, Registered Plan 590, in the City of Hamilton, designated as Part 1, Plan 62R-21039, being Part of PIN 17055-0097 (LT); City of Hamilton;

**WHEREAS** notice to the public of the proposed sale of the part of the public unassumed alley has been given in accordance with the requirements of the Sale of Land Policy By-law.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. The part of the public unassumed alley set out as:

Part of Alleyway, Registered Plan 590, in the City of Hamilton, designated as Part 1, Plan 62R-21039, being Part of PIN 17055-0097 (LT) is permanently closed.

To Permanently Close and Sell a Portion of Public Unassumed Alley Abutting 193 East 22nd Street, Hamilton, Ontario, namely Part of Alleyway, Registered Plan 590, in the City of Hamilton, designated as Part 1, Plan 62R-21039, being Part of PIN 17055-0097 (LT); City of Hamilton

2. The soil and freehold of Part 1 on Plan 62R-21039, hereby permanently closed, be sold to Richard Junior Masters and Peggy Ann Masters for the sum of Two Dollars (\$2.00).
3. That this by-law shall come into force and effect on the date of its registration in the Land Registry Office for the Land Titles Division of Wentworth (No. 62).
