# **RECOMMENDATION(S)**

That the Board direct the Administrator to engage eSCRIBE Software Ltd. as the Board's electronic agenda management software solution provider; and that

The Administrator be authorized to enter into and execute any required contact and ancillary documents required to give effect thereto with eSCRIBE Software Ltd., and that

The Administrator be directed to work with the Hamilton Police Service (HPS) to host eSCRIBE on the Service's website; and that

The Administrator purchase iPads, or other equivalent technologies, for Board Members who do not already possess such materials.

# **EXECUTIVE SUMMARY**

- On May 26, 2016 the Board directed the Administrator to work with the Chair to implement the use of electronic devices for monthly agendas
- The Board Administrator evaluated and reviewed multiple electronic agenda management solutions and determined that eSCRIBE was the best fit the Board's requirements
- Moving to paperless agendas benefits the Board by reducing Staff time in preparing agenda materials for meetings, reduces the need for storage space requirements, provides easier access to information, reduces paper waste and supports a more ecofriendly environment.

#### FINANCIAL – STAFFING – LEGAL IMPLICATIONS

- Financial: The cost to purchase, implement and receive training on eSCRIBE software will come in under the threshold required to post a request for proposal or request for quote.
- Staffing: Support will be required from the Administrator and HPS Information Technology Staff.
