Reason(s) for delegation request:

1. To request an adjournment (to a date to be determined) of the Procurement Sub-Committee's consideration of the recommendations made by the Manager of Procurement and City Staff in the letter sent by the Manager of Procurement to Associated Paving dated October 19, 2021 (the "Recommendation Letter"), in order to facilitate a fair opportunity for Associated Paving to make fulsome written and oral submissions in response to same, including in reference to all documents received from the City through the afternoon of October 26, 2021 and any additional relevant documents that have not yet been provided;

2. Alternatively, should the adjournment request be refused, the opportunity to make submissions to the Procurement Sub-Committee for 20 minutes to:
  - (i) dispute the recommendations of the Manager of Procurement and City Staff that are set out in the Recommendation Letter;
  - (ii) address the commercial relationship between the City and Associated Paving, as invited in the Recommendation Letter;
  - (iii) request that the Procurement Sub-Committee reject the recommendations set out in the Recommendation Letter; and
  - (iv) request confirmation that Associated Paving and its related corporate or individual entities will continue to be permitted to bid for and enter into contracts for road cut restoration work.
3. Also in the event that the adjournment request of Associated Paving is refused, Associated Paving requests the opportunity to make further submissions for the Procurement Sub-Committee's consideration on a later date, once Associated Paving has had the opportunity to conduct a fulsome review of the relevant documents, information and recommendations put forward by City staff.
