

## Local Epidemiology Update

- Local data can be found on the CoH webpage "<u>Status of</u> <u>Cases in Hamilton</u>"
- Brief update as of November 8th, 2021:
  - Number of new cases (7-day average): 17
  - Current reproductive number: 1.07
  - Current # of outbreaks: 7

## Vaccination Update

Of the eligible population in Hamilton (as of Nov 8, 2021): 85.5% have at least one dose & 81.9% are fully vaccinated

### In Hamilton, the risk of:

- COVID-19 infection among the unvaccinated population is 9.1 times higher than for fully vaccinated
- Hospitalization due to COVID-19 among the unvaccinated population is 28.9 times higher than it is for fully vaccinated
- ICU admissions due to COVID-19 among the unvaccinated population is 70.4 times higher than it is for fully vaccinated.
- Death due to COVID-19 among the unvaccinated population is 11.5 times higher than it is for fully vaccinated





## Vaccination Verification Requirements

### Proof of vaccination requirements took effect on September 22, 2021

The following documents can help businesses understand vaccine verification requirements:

- Government Regulations <u>O.Reg 364/20</u> (Step 3, Schedule 1)
- Ministry of Health <u>Proof of Vaccination Guidance for Businesses &</u> <u>Organizations</u>
- Ministry of Health <u>Questions & Answers</u> for businesses about proof of vaccination requirements
- Ontario Chamber of Commerce- <u>Proof of Vaccination Framework</u>(\*)
- City of Hamilton <u>Proof of Vaccination</u>

\* OCC- for businesses looking to implement their own POV mandate





## Vaccination Verification Requirements

- As of September 22, 2021, Ontario patrons need to be fully vaccinated to enter certain higher-risk settings.
- Workplace policies- Organizations can also choose to implement proof of vaccination requirements even if not mandated by Ministry \*could consider consulting legal prior to implementation
- Fully vaccinated = (full series of vaccine plus 14 days since last vaccination) and provide proof of identification to access certain public settings
  \*Where 3<sup>rd</sup> dose is recommended rather than required, no change to what is considered fully vaccinated will be made
- Validation of identification-name and date of birth need to match on both the vaccination receipt and the name identification document
- Management of personal health records a business or organization shall not retain any information provided by a patron if the information is provided pursuant to a requirement under section 2.1 of Schedule 1 of O. Reg. 364/20 under the ROA



## Vaccination Verification Exemptions

### **Exemptions:**

- a) Medical Individuals who cannot receive the vaccine due to medical exemptions (must show medical note)
- B) Children (under 12) Children who are 11 years and younger and are not eligible to be vaccinated
- C) Youth under 18 actively participating in an organized sport- including training, practices, games and competitions. For example, sports league, organized pick-up sports, dance classes, martial arts, swimming classes. There is not an exemption for youth spectators
- D) Temporary entry exclusively to access a washroom, outdoor area, make a retail purchase or place an order
- E) Meeting or event space to attend a wedding or funeral ceremony (but not an associated social gathering)

\*Other limited exemptions apply in meeting and event spaces (e.g. day camp, child care, social services, court services, government services). \*\* Exemption for individuals participating in a Health Canada COVID-19 clinical trial 7





## Vaccination Verification Requirements

Identification documents that may be used as proof of identification include:

- Birth certificate
- Citizenship card
- Driver's licence
- Government (Ontario or other) issued identification card, including health card
- Indian Status Card/Indigenous Membership card
- Passport
- Permanent Resident card

### Note:

- picture identification not required.
- Expired ID acceptable
- Under 18/youth may show photocopies of ID

Higher-risk settings where Proof of vaccination required:

- Indoor areas of food establishments
- Indoor & outdoor areas of food establishments with dance facilities
- Indoor areas of meeting & event spaces
- Indoor areas of facilities used for sports & rec fitness activity (includes waterparks)
- Indoor gyms, fitness/recreational facilities and indoor areas where spectators watch events (i.e. sporting events). Outdoors with usual capacity of over 20,000
- Indoor areas of casinos, bingo and other gaming establishments
- Indoor areas of concert venues, theatres & cinemas
- Indoor areas of bathhouses, sex clubs and strip clubs
- Indoor areas of horse racing tracks, car racing tracks and other similar venues
- Indoor areas where commercial film and TV productions take place with studio audiences
- Racing venues (e.g. indoor horse & car tracks)





## Vaccination Verification Requirements continued

# As of October 22, 2021 Ontario has an enhanced vaccine certificate and verification app

- Businesses must have the verification app (i.e. Verify Ontario) and accept paper and downloaded proof of vaccination documents
- Note the Verify Ontario app is the only authorized app for use by businesses/organizations
- The app provides greater security and privacy protection (the app does NOT retain or store data)
- The app speeds up the process of verifying vaccine eligibility
- Businesses or organizations are responsible for ensuring they meet the requirements regarding proof of identification and proof of vaccination against COVID-19 as outlined in the *Reopening Ontario Act*.



## **Capacity Limits**

### Indoors

- For workplaces without public access, capacity is based on ability to physically distance
- Indoor business open to the public = 50% capacity (e.g. museums, indoor clubhouses...)
- Other indoor areas open to the public 25% capacity where specified (e.g. dance clubs, sex clubs)

### Outdoors

- <u>General guidance</u> outdoor business or facility limited to 75% capacity (e.g. outdoor dance establishment)
- <u>Recent changes</u> Capacity limits have been <u>removed</u> for outdoor organized public events (such as outdoor parades, outdoor memorial services and other similar events and activities like concerts) and requires a mask to be worn if physical distancing of two metres is not possible.
- Motor vehicles for drive-in and drive-through venues no longer need to maintain 2 metre distance



## **Proof of Vaccinations & Capacity Limits**

### Capacity limits have been lifted to allow 100% capacity in the following settings:

- Concert venues, theatres and cinemas;
- Facilities used for sports and recreational fitness activities, including areas for spectators within those facilities, areas where personal fitness trainers provide instruction within those facilities, and waterparks.
- Meeting and event spaces
- Horseracing tracks, car racing tracks, and other similar venues; and
- Commercial film and television productions with studio audiences
- Restaurants, bars and other food and drink establishments;
- Casinos, bingo halls and other gaming establishments;

In the vast majority of settings where POV is required, capacity limits and physical distancing requirements have been dropped \*Indoor areas of bathhouses, sex clubs and strip clubs, & food establishments with dance facilities are still subject to physical distancing & capacity limits



## Proof of Vaccinations & Capacity Limits – opt-in options

### Settings that can choose to require proof of vaccination

- Personal care services (e.g., barber shops, salons, body art);
- Indoor areas of museums, galleries, aquariums, zoos, science centres, landmarks, historic sites, botanical gardens and similar attractions;
- Indoor areas of amusement parks;
- Indoor areas of fairs, rural exhibitions, festivals;
- Indoor tour and guide services;
- Boattours;
- Indoor areas of marinas and boating clubs;
- Indoor clubhouses at outdoor recreational amenities;
- Open house events provided by real estate agencies;
- Indoor areas of photography studios and services and;
- Indoor recreational amenities
- Indoor places of worship

### Day-to-Day opt-in option

When opting-in members of the public are not required to maintain a distance of at least 2 metres from others in the business/facility

When opting-in, proof of vaccination signs must be posted

Public health measures such as screening, masking and contact tracing remain in effect even when opting-in



## **Provincial Plan for Reopening Safely**

# Proposed rather than fixed plan – based on monitoring of key public health and health care indicators

The following data will be used to monitor COVID-19:

- New ICU admissions and hospitalizations
- Effective reproduction number
- Test positivity
- Weekly cases incidence rates
- Vaccination coverage rates

Local indicators will also inform any decisions to apply additional measures to specific public health regions at the discretion of the local Medical Officer of Health



### **Provincial Plan for Reopening Safely** -<u>News</u> Release

### A Plan to Safely Reopen Ontario and Manage COVID-19 for the Long Term

#### September 22, 2021

 Begin to require proof of vaccination in higher-risk indoor settings

#### September 25, 2021

 Begin easing capacity limits in certain settings

#### October 9, 2021

· Lift capacity limits in certain settings where proof of vaccination is required

#### October 22, 2021

- Enhanced vaccine certificate with official QR code and Verify Ontario app launched
- October 25, 2021
- Lift capacity limits where proof of vaccination is required in:
- restaurants and bars sports, recreational fitness facilities (such as, gyms),
- physical fitness training and waterparks
- casinos, bingo halls, and other gaming establishments
- meeting and event spaces (indoor)
- Permit certain settings to lift capacity limits if they require proof of vaccination, including, but not limited to:
- museums, galleries, etc.
- religious services, rites, or ceremonies
  - tour and guide services
    - personal care services, including barber shops, salons, body art

#### March 28, 2022 (and onwards)

- All remaining public health and workplace safety measures in businesses and organizations lifted, including masking
- Revoke public health Emergency Orders under the Reopening Ontario Act
- Recommendations on where masking could be maintained (such as transit)

#### Fall 2021

#### November 15, 2021

Lift capacity limits in other high-risk settings where proof of vaccination is required:

 food or drink establishments with dance facilities such as, night clubs, wedding receptions in meeting/event spaces where there is dancing

strip clubs

bathhouses and sex clubs

### Winter 2021-2022

In the absence of concerning trends, begin to lift vaccine certificate requirements, starting with the lowest risk settings, as follows:

#### February 7, 2022

- night clubs
- strip clubs
- bathhouses and sex clubs
- sporting events racing venues

March 28, 2022

meeting and event spaces

Spring 2022

· commercial and film productions with studio audiences

concerts, theatres and cinemas

Also begin to lift CMOH directives and capacity limits in settings where proof of vaccination is not required.

#### Monitoring COVID-19

- As the province safely reopens, the government will monitor trends in COVID-19 provincial and local public health and health system indicators, including:
- new ICU admissions test positivity and hospitalizations
- weekly cases incidence rates - effective reproduction - vaccination coverage rates number
- It will be particularly important to monitor trends in indicators over the winter holidays and as students return to schools in January

#### Managing COVID-19 for the long term

- As the province manages COVID-19 for the long term, responses will be localized and tailored based on local context and conditions
- · Local indicators will also inform any decision to apply additional measures to specific public health regions at the discretion of the local medical officer of health

#### Key principles:

January 17, 2022

· restaurants and bars

sports and recreational

gyms) and waterparks

· casinos, bingo halls, etc.

fitness facilities (such as,

- ongoing monitoring and testing
  - infrastructure in place to manage outbreaks
  - targeted, localized measures based on local context and conditions
  - minimize disruption to business and individuals

- Sample measures that may be implemented locally or regionally could include:
- reintroduce capacity limits and/or physical distancing requirements (percent and/or hard caps)
- add settings where proof of vaccination is required
- reduce gathering limits
- apply public health and workplace safety measures in specific settings where transmission is occurring
- recommend or require work from home, where possible
