Motion: To direct staff to make a formal request with the Mayor's Office and to work with the Mayor's office staff to have the Hamilton sign at City Hall illuminate with an array of eight (8) colours (in the order of black, brown, red, orange, yellow, green, blue, purple) that is representative of all elements of the Progress Pride Flag, save for the Trans Pride Flag elements, for as many days as possible in the month of June.

Motion: To direct staff make a formal request with the Mayor's Office and to work with the Mayor's office staff to have the Hamilton sign at City Hall illuminate with light blue, pink, white, pink, and light blue for Trans Day of Remembrance (November 20, 2022) and International Trans Day of Visibility Celebration (March 31, 2023).
