The purpose of this Report is to answer and expand on a few questions raised at the September 22, 2022 Audit, Finance and Administration (AF&A) Committee Meeting. The AF&A agenda included the following Communication item, the Hamilton Waterfront Trust 2021 Audited Financial Statement.

### **Project Management**

The Hamilton Waterfront Trust's (HWT) 2021 Audited Financial Statement reflects approximately \$1.5MN in Waterfront development, City of Hamilton management contract revenue. The Waterfront development contract revenue is tied to planning, design and construction of the Piers 5-7 Public Realm Projects.

Effective January 7, 2015, the City and HWT entered into a Project Management Agreement (PMA) which outlined the terms and conditions under which the City would retain the HWT to manage select City projects along the Hamilton waterfront. The PMA states that all such projects "will be defined in detail and shall have specific terms and conditions set out in each Project's Terms of Reference and Project Charter". The PMA does not specifically identify the City's signing authority for these Terms of Reference.

Council subsequently approved, Piers 5-7 Public Realm Projects (PW16088(a)), providing the General Manager of Public Works authority to negotiate and execute, on behalf of the City, each with content acceptable to the General Manager of Finance and Corporate Services, and each in a form satisfactory to the City Solicitor:

(a) The Terms of Reference ("TOR") between the Hamilton Waterfront Trust ("HWT") and the City of Hamilton ("City") for the planning, design and construction of the Piers 5-7 Public Realm Projects (the "Project") substantially on the terms and conditions outlined in the draft TOR attached as Appendix "A" to report PW16088(a)

#### **Waterfront Outdoor Rink**

Council approved year-round operation, maintenance and management of the Waterfront Outdoor Rink through Report FCS17040. Council approved the Hamilton Waterfront Trust for the year-round operation, maintenance and management of the Waterfront Outdoor Rink for an initial five-year period from January 1, 2017 through December 31, 2021, plus two five-year extension options exercisable at the City's discretion.

The City and Hamilton Waterfront Trust management agreement reflects HWT's responsibility to operate and maintain the Waterfront Outdoor Rink for the City.

#### **Annual Briefing**

Under the Revised Deed of Trust between the City of Hamilton and the HWT, the HWT is required to appear before the Council, or an appropriate Committee of the City, to present and report on the following:

- (a) its annual audited Financial Statements;
- (b) its Strategic and/or Business Plans and any changes thereto;
- (c) its ten (10) year Capital Plan; and
- (d) any changes to its organizational structure.

At the April 21, 2022 AF&A committee meeting, the Executive Director of HWT presented to Committee the following:

- HWT Mission Statement
- Summary of HWT historical project expenditures
- HWT operations and events
- HWT food service
- HWT attractions
- HWT events
- HWT community outreach efforts

- And Piers 5,6,7 project management highlights

At the April 21, 2022 AF&A committee meeting, the following was approved:

- Subsequent to the April 21, 2022 AF&A direction, on April 27, 2022 Council approved the following open session direction:

  - (b) That the Confidential Correspondence from David A. van der Woerd, Ross & McBride LLP, respecting the Hamilton Waterfront Trust, be received and remain confidential.
