5. **COMMUNICATIONS (Item 5)**

(i) Discovery Centre, West Harbour Redevelopment – Follow Up (Item 5.1)

J. Smith, Senior Consultant with the West Harbour Redevelopment project sent and update on the Discovery Centre Opportunity Study.

Council approved the recommendations to:

- 1. Initiate community and stakeholder consultation.
- 2. Consult with the Hamilton Public Library, the Hamilton Museum Citizens Group, as well as heritage stakeholders regarding potential partnership opportunities for colocating civic uses and providing heritage-based visitor experiences within the Discovery Centre Opportunity Study Site.
- 3. Consult with the urban Indigenous community to advance Actions of 2019 Hamilton Urban Indigenous Strategy.
- 4. Assess capital and operational costs for the Discovery Centre building; and,
- 5. Prepare a commercial market assessment for the Site.

To begin the community consultation, an <u>Engage Hamilton</u>
website with a link to a Community Survey was launched. The 10-question survey is open until September 23 after which a Community Survey Summary Report will be prepared on the responses.

Staff will send along the link to the IAC for consideration of contributing feedback to the survey.

6. DISCUSSION ITEMS (Item 10)

(i) Advisory Committee Meeting Dates for Remainder of Term (no copy) (Item 10.1)

October and November meetings have been cancelled as per Chair, M. Wright..

- (ii) 2023 Budget Request for the Indigenous Advisory Committee (Item 10.2)
 - Same maintenance budget as current sufficient.
 - Only specific use for funds right now is the banner production and

- booking fee.
- Staff will have to see what permissible ways are to use the committee funding.
- IAC is looking to support Indigenous Community Initiatives in the City.
 - \$250 donation to the Hamilton Regional Indian Centre's Foodbank.
 - \$500 (5 x \$100 grocery gift cards) to support give away at Indigenous Social/Music Festival on October 1st event is in recognition of Every Child Matters and National Day for Truth and Reconciliation.
 - \$500 (5 x \$100 grocery gift cards) to support give away at October 4th opening the Nyaweh Programs Art Exhibit honoring Murdered and Missing Indigenous Women and Children.\
 - \$250 donation to the Water Walkers Event on October 28th to assist with costs of programming.
 - Funds to print promotional material for the recruitment of new members to join the Indigenous Advisory Committee.
- (iii) Recruitment Process for the Indigenous Advisory Committee (Item 10.3)
 - The Recruitment Committee will be: CS. McCormack-Montana,
 Y. Maracle and Cllr. Nann.
 - BD suggested sending a few key agencies in the community a letter to see if they are interested in participating in the selection cttee too [up to 5 people maximum].
 - IAC wants to participate in the 'tradeshow' with other Advisory committees for recruitment opportunities.
- (iv) 2018 2022 Indigenous Advisory Committee Accomplishments (Item 10.4)
 - ability to continue to conduct business virtually during COVID-19 pandemic and adapted well to change in processes.
 - M. Wright in terms of dealing with city hall functions (more divisions are more aware of who we are and what we can bring), ability to make our own choices as to who's on the IAC committee, make decisions for what is best for the Urban Indigenous Community.
 - C. Bellamy Urban Indigenous people have a voice at the table when they haven't in past voices being heard.
 - M. Wright participated in the community with conversations about the UIS; attended other events and brought info about the committee there (e.g. Soaring Spirits). Participated in the

'point in time counts' for homelessness.

- C. Bellamy 2 yrs in a row partnered with HPL to host indigenous literacy for children & books (display cases and sessions)
- S. Cruickshank cooperation with the UIS staff and moving with the times (e.g. changed name of committee from Aboriginal to Indigenous)
- (v) Review of Indigenous Advisory Committees Terms of Reference (Item 10.5)
 - Discussed changed to TOR including: no allies, up to 9 members (max).
 - Add direct connection to Urban Indigenous Strategy in their mandate and objectives.
 - Add "Elder in Residence" role within committee if possible.
- (vi) Water Issues Wrap Up (Item 10.6)
 - If it affects the environment or Indigenous People, they would like to hear about it. Cooperation and knowledge exchange between Water Division and IAC is desired outcome.
 - Setup a more regular communication schedule from them to IAC (quarterly / semi-annual basis for summary of incidents, etc.). if there is a more significant event/issue then they can share (circulate/attend) in a timelier manner.
- (vii) Indigenous Relations Team Update (Item 10.7)
 - Staff B. Dockstator gave an update on September programming in the community for September 30th (Every Child Matters and National Day for Truth and Reconciliation).
 - Promotional initiatives are focused on education "what is everyone's part in Truth and Reconciliation?"
 - 2 Woodland Cultural Centre virtual educational training sessions.
 - 1) Virtual Tour of Mohawk Institute Residential School and debrief.
 - 2) Virtual Learning Session on Truth and Reconciliation.
 - Staff Lunch and Learn viewing Indigenous documentary by Sarain Fox re: residential schools, loss of teachings/culture.
 - Partnering with HRIC and other Indigenous agencies in the City for September 30-October 1st event/social at Gage Park in commemoration of Every Child Matters/NTRC.
 - Orange Shirts for sale for City Staff.
 - Every Child Matters Flag will be displayed at City Hall.

- Orange "HAMILTON" sign will be illuminated Orange on September 30th.
- Oct 4 will be showcasing the Niwasa art exhibit in recognition of the day of action at City Hall as previously discussed with committee.
