Since its inception in 1845, the Hamilton Chamber of Commerce has harnessed collective action to advocate for ambitious, city-building initiatives that enhance the social and economic prosperity of Hamilton and our region.

I am writing in support of Hamilton 100's proposed facility plan in connection with its bid for the 2030 Commonwealth Games.


Hamilton's facility plan includes the Commonwealth Games Sports Centre featuring multiple sport courts. As a legacy of the 2030 Commonwealth Games, that facility would serve as both a community sport centre and an elite training centre. In addition, a show court is included which would serve as an arena where various types of events and sports could be hosted, including domestic and international basketball games and tournaments. A second facility, the 3X3 basketball centre at Eastwood Park, is also a key part of Hamilton's plan and would be another important legacy of the 2030 Commonwealth Games.

There is much good news about Canadian basketball. Buoyed by the Raptors' championship season and the success of the Canada Basketball men's and women's programs, more people are playing basketball than ever before. The NBA reports that youth basketball participation in Canada grew a remarkable 15% in the past year alone - from 1.1M in the 2018-2019 season to over 1.3M in the 2019-2020 season. Basketball is the most inclusive sport in Canada, drawing fans and participants old and young, male and female, urban and rural, and representing a diversity of backgrounds and cultures as rich as the country itself. Basketball is the fasted growing sport in Canada and the most participated sport amongst youth aged 12 to 17. Basketball is considered the coolest sport amongst 18 to 24-year-olds and the first sport choice for newcomers to Canada. 3X3 basketball is now an Olympic Sport and hundreds of 3X3 events are hosted across Canada each year.

But that popularity and growth also brings capacity issues. Canada Basketball is working hard to increase the number of qualified coaches, referees, administrators .... And facilities!

The need for additional basketball facilities has been a long-standing problem in Canada, particularly in the Greater Toronto and Hamilton Area. That problem has only increased as the popularity of the sport grows, and as access to general purpose sports facilities such as schools becomes more restrictive and expensive.

The importance of basketball to a community and the need to provide additional facilities for the ever increasing demand has been recognized by other communities in the Golden Horseshoe (for example, see the "Basketball Development Plan" prepared by the City of Toronto's Parks, Forestry and Recreation Department which can be found on-line at <a href="https://www.toronto.ca/legdocs/mmis/2016/cd/bgrd/backgroundfile-98433.pdf">https://www.toronto.ca/legdocs/mmis/2016/cd/bgrd/backgroundfile-98433.pdf</a>).











Canada Basketball would also be interested in using Hamilton 100's Commonwealth Games facilities for its own programs, games and other events. We had engaged in discussions with the City of Hamilton about relocating Canada Basketball's headquarters and men's national training centre to Hamilton earlier in the year. Although those discussions did not result in an agreement, we would be very interested in exploring all possibilities for our involvement in these proposed facilities. Canada Basketball's participation in the Hamilton facilities could bring significant exposure, employment, and valuable sport tourism benefits.

Finally, I know firsthand how much unfulfilled demand for basketball courts exists in the area from my experience as the former Director of Athletics and Recreation at McMaster University and also as the co-founder/chairman of HoopDome, a seven court privately owned basketball facility located in Toronto's Downsview Park. At McMaster, we could not fulfill much of the third-party requests for rentals of our gymnasiums. Similarly, our courts at HoopDome are booked to capacity with leagues, rentals and tournaments and we regularly must turn away rental requests. HoopDome has been profitable since inception and usage has increased year over year in all twelve years of its existence.

Mr. Powers, I respectfully encourage you to consider Hamilton 100's bid for the 2030 Commonwealth Games. I am sure Hamilton will provide a wonderful Commonwealth Games experience for all participants. And, the legacy of the Commonwealth Games in Hamilton will be important and well-needed community and sport infrastructure.




