## APPEN-DIX C

INDIGENOUS PARTNERSHIP FRAMEWORK

### INTRODUCTION

In its Transformation 2022 and Transformation 2022 Refresh Strategic Plans, Commonwealth Sport emphasizes the goal of positioning itself as a progressive leader in sport and social change, with a vision of creating peaceful, sustainable, and prosperous communities across the Commonwealth.

A necessary way to realize this vision is for host cities to partner with Indigenous peoples to ensure that Indigenous communities and organizations benefit from, and are included in, every stage of the planning, implementation, and execution of the Commonwealth Games.

As such, establishing a meaningful partnership with Indigenous peoples is a Commonwealth Games 2030 Indigenous Partnership Framework FINAL - #45532186v2.docx foundational element of Hamilton's bid for the 2030 Commonwealth Games. Such a partnership is meant to reach beyond reconciliatory commitments and to deliver on key components of the Commonwealth Charter, the Commonwealth Consensus Statement on Promoting Human Rights in and through Sport, the Truth and Reconciliation Commission's Calls to Action, and the United Nations' Sustainable Development Goals.

It further represents a foundation on which the City of Hamilton's commitment in creating mutual responsibilities towards meaningful reconciliation through the action items of the City of Hamilton's Urban Indigenous Strategy. The UIS was developed through collaboration with the Urban Indigenous Community recognizing that action items # 34 and 35 speaks to increase opportunities for Indigenous and non-Indigenous residents to play Indigenous sports and recreation activities and to work with local Indigenous communities to host major sports events for Indigenous athletes.

As we continue to develop recognition of Indigenous peoples who have occupied this territory and who continues to make many diverse, social and economic contributions to the community, we need to seek action towards commemoration and contributions.

The within framework will guide the development of this proposed partnership (the "Proposed Partnership") through a process of engagement.

### VISION

To collaborate and engage with local Indigenous governments, communities, and organizations to deliver a transformative 2030 Commonwealth Games that showcases and celebrates First Nations, Metis, and Inuit cultures, knowledge, and history.

### **MISSION**

- To ensure that Indigenous voices and perspectives are represented and adopted at each stage of the planning, implementation, and execution of the 2030 Commonwealth Games through a process of engagement;
- To leverage the 2030 Commonwealth Games as a means of educating athletes, attendees, and viewers about the original people of Turtle Island by sharing their diverse cultures, rich ways of life, traditions, songs, business development and partnership opportunities, and craftsmanship;

- To highlight Indigenous peoples' skills, knowledge, and cultural sport management abilities in planning and hosting premiere international events; and
- To ensure that the 2030 Commonwealth Games provide an impactful and beneficial legacy that responds to the needs of local Indigenous communities and organizations.

### **VALUES**

The Proposed Partnership will be based on, and guided by, the core values of respect, reciprocity, responsibility, relationships, accountability, authenticity, transparency, and sharing.

### **FACILITATING ENGAGEMENT**

The development of a meaningful partnership with Indigenous peoples will be accomplished through a process of engagement with the leaders of local Indigenous communities and organizations.

In order to facilitate this process of engagement, an Indigenous Partnership Collective ("IPC") will be formed to act as the touchpoint for collaboration between Indigenous peoples, the Hamilton 2030 Bid Corporation, the Commonwealth Games Federation, Commonwealth Sport Canada, and any other interested party.

Members of the IPC will meet on a regular basis and will vote on important issues related to the planning, implementation, and execution of the 2030 Commonwealth Games. Decisions rendered by the IPC will represent the input of Indigenous peoples on Games-related issues and will be presented to the appropriate bodies as needed.

The IPC will develop internal governance and leadership protocols to guide its collaborative efforts leading up to and during the 2030 Commonwealth Games.

### **CREATING BENEFICIAL OUTCOMES**

A meaningful partnership should result in mutually beneficial outcomes for all parties involved.

In considering the 2030 Commonwealth Games, the potential outcomes for Indigenous peoples fit neatly within Commonwealth Sport's mission to: (i) deliver inspirational sporting moments; (ii) nurture a powerful sporting movement; (iii) activate transformational partnerships; and (iv) realize collective impact.

By delivering on these four mission items, the Proposed Partnership should be understood as a mutually beneficial arrangement whereby Indigenous peoples, the host city of Hamilton, and the Commonwealth Sport Movement share in reciprocal benefits.

The Proposed Partnership has the potential to deliver on Commonwealth Sport's four mission items by facilitating the following non-exhaustive list of outcomes for Indigenous peoples. These items are examples of possible outcomes, however the process of engagement discussed above would invite a more detailed exploration of these and other opportunities:

### i) Delivering Inspirational Sporting Moments

- Additional outcomes/initiatives as recommended by the IPC.

The Proposed Partnership is not only aligned with the goals of Commonwealth Sport, but is also aligned with important international goals towards sustainable development. In particular, the Proposed Partnership intersects with the following United Nations' Sustainable Development Goals:

- To end poverty in all its forms everywhere;
- To ensure healthy lives and promote well being for all at all ages;
- To ensure inclusive and equitable quality education and promote lifelong learning opportunities for all;
- To promote sustained, inclusive, and sustainable economic growth, full and productive employment, and decent work for all;
- To build resilient infrastructure, promote inclusive and sustainable industrialization, and foster innovation;
- To reduce inequality within and among countries;
- To make cities and human settlements inclusive, safe, resilient, and sustainable; and
- To promote peaceful and inclusive societies for sustainable development, provide access to justice for all and build effective, accountable, and inclusive institutions at all levels.

### CONCLUSION

Partnering with Indigenous peoples is a necessary component of a successful 2030 Commonwealth Games. Doing so ensures that Indigenous voices and perspectives are represented, adopted, and implemented at all phases of the Games and that that benefits are passed on to Indigenous communities that address their specific

Such a partnership aims to exceed the reconciliatory efforts of previous Games and looks to establish relationships of reciprocity. In doing so, Commonwealth Sport's stated vision can be realized while celebrating the diverse cultures, history, and traditions of local Indigenous communities.
