- (c) the filing date for the final financial statement under section 88.30; or
- (d) the date on which the candidate's extension, if any, under subsection 88.23(6) and 88.27(3) expires.

²Section 17(3) of the *Municipal Elections Act,* 1996:

The following are prohibited from voting:

- 1. A person who is serving a sentence of imprisonment in a penal or correctional institution.
- 2. A corporation.

- 3. A person acting as executor or trustee or in any other representative capacity, except as a voting proxy in accordance with section 44.
