Re: 2023-24 Five per cent base funding increase to community-based mental health and addictions service providers funded by the Ministry of Health

This letter is further to the recent letter from the Honourable Sylvia Jones, Deputy Premier and Minister of Health, in which she informed your organization that the Ministry of Health (the “ministry”) will provide City of Hamilton with up to \$115,100 in new Base Funds starting in the 2023-24 Funding Year. This funding is to provide the five per cent base funding increase to community-based mental health and addictions service providers funded by the Ministry of Health, as announced in the [2023 Ontario Budget](#).

Following your organization’s submission of an updated program budget in Transfer Payment Ontario (TPON) the ministry will revise the budget schedule (Schedule “D” Budget) of your existing Child and Youth Mental Health (CYMH) base Transfer Payment Agreement. The revised budget will reflect the new funding and outline the terms and conditions governing this funding. The new funding will flow to your organization upon acceptance of the agreement in TPON. Note that the ministry has changed its policy related to ink signatures for agreements and an electronic signature is sufficient. Any amendments following the initial Agreement can be accepted and approved through the digital consent function in TPON.

We appreciate your cooperation with the ministry in managing your funding as effectively as possible. You are expected to adhere to our reporting requirements,
