# THE FACILITY NAMING SUB-COMMITTEE PRESENTS REPORT 23-001 AND RESPECTFULLY RECOMMENDS:

- (a) That the Ryerson Recreation Centre at 251 Duke Street be renamed "Kanétskare" (pronounced Ga-nét-sga-re, a Mohawk term meaning Bay or Inlet) Recreation Centre as it meets the guidelines as set out in Section 4(b)(i) of the City of Hamilton Municipal Property and Building Naming Policy;
- (b) That a budget of \$20K funded from the City's Tax Stabilization Reserve, (110046) be established for costs associated with the removal, repair, preparation and installation of new facility signage at the 251 Duke Street site;
- (c) That the Mayor and City Clerk be authorized and directed to execute any required agreement(s) and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor; and,
- (d) That the renaming of Ryerson Recreation Centre to Kanétskare Recreation Centre be considered complete and removed from the Facility Naming Sub Committee Outstanding Business List. General Issues Committee – May 17, 2023
