#### Encampments: Impacts on Businesses in Hamilton Survey Summary -Verbatim Responses for Open Ended Questions

#### Please describe the impacts that encampments have had on your business and/or customers.

(Note: text responses have not been modified in any way for grammar, spelling and/or content with the exception of references to names/personal identifiers that have been redacted.)

- 1. Employees very concerned about their safety. 2. Employees not wanting to be in downtown core. 3. Clients not wanting to travel to downtown core.
- accosting staff in and outside of the office and at parking areas public defecation and urination Racial slurs directed towards staff
- Aggressive drug addicts and homeless people are harassing our customers and staff. We had to invests thousands of dollars in security cameras, and a full time security guard overnights.
- Are customers are always being asked for things. They create a unsafe zone as you are not sure how they are going to react. They are yelling (sometimes to themselves) and you never know what or if they have weapons.
- At my previous location 350 Kenilworth the impact was huge. A nearby encampment was cleared out and resulted in months of individuals sleeping on our front entry. Multiple calls to law enforcement to clear them from entry way or back parking lot.
- Bad first impressions when trying to attract new business to the City.
- Being directly across from Woodlands Park, at it's peak when there were 45+ tents, over 100 ppl in the park there were many impacts on the business. tenants, visitors, vendors feeling unsafe, violence, garbage, drug use, illicit activity etc... and the public bathroom building burning down. Since the encampment has been cleared out there have been very few short time stays, and for the most part have cleared out and cleaned up quickly. So the short answer is that historically the encampment issue had a BIG impact, and now it has dwindled since the protocol essentially deemed the park not suitable for any encampments.
- Business that used to service moved out of the area. Back alley constant garbage and also has become a washroom it seems.
- Clients and staff feel unsafe and don't want to come to our location.
- Clients are hesitant about coming to my place of business because of the unhoused people hanging around. They feel uncomfortable with the drug use that happens right outside my business and the harassment from being should at.
- Clients have been confronted by people while coming in to the Office and some are unwilling to now attend at the Office. Others are hesitant or fearful to come to the Office because of the downtown environment.

- Consistent panhandling at intersections and plaza entrances. Drug deals nearby, public nudity and sex acts. Sexual exploitation of female encampment/addiction residents. Garbage and needles everywhere near encampment sites. Human trafficking of new immigrants at intersections. Theft of personal property outside of businesses and personal addresses near encampments. Open burning at sites. Theft in stores by encampment residents. Fear and risk to customers and staff when attending for work requirements. Feeling unsafe near encampments and those who are panhandling etc.
- Constant cleaning up of drug paraphernalia, people sleeping at our entrance, multiple break ins, encampment belongings overflowing onto our property, encampments creating safety concerns for staff, public drug use
- Customer complaints, Urination & feaces on building. open drugs use leading to frequent shootings downtown now. Staff are nervous and avoid areas in particular stairwell's.
- Customer do not want to come downtown, they tell us they don't come as often because of how shitty the downtown has gotten. We have people openly smoking meth / crack in doorways. Walking down sidewalks, everywhere. Dirty needles, human feces on sidewalks and next to parked cars, vandalism, theft, etc. they come into our businesses and run into washrooms and lock themselves in to use drugs, they come in back doors and steal staff belongings, they come in and harass guests. Our staff has been assaulted, stolen from and some fear working in the city. While housing is an issue, let's be real here and say what's the real problem. This city openly allows addicts and criminals to roam free and do what they want when they want.
- Customers (especially from other countries) regularly comment on how startled and uncomfortable they feel being the city for any leisure or post-work hour activities during their visits here.
- Customers afraid to come into store with people "hanging" around just outside. Theft increased substantially....we constantly were on guard for individuals shop lifting in store. We would attempt to stop them but they would walk off with merchandise and we would observe them going straight into one of the tents across the street
- Customers and employees are afraid for their safety, garbage, drug use near by, begging and pestering of customers
- Customers and employees being harassed.
- customers and staff have indicated that they felt unsafe when trying to get to our office
- Customers are afraid to come encampment occuppiers and wondering around asking for money and on street corners??

- Customers are discouraged from visiting. The neighbourhood is unsightly. There is trash, urine and drug paraphernalia. Homeless people and overdosing on the side walks and in nearby parks, on medians in the street. My revenue and foot traffic is gone.
- Customers are very leery about passing an encampment area for fear of possible danger
- Customers avoiding the area.
- Customers do not feel safe and are not coming down to shop. The encampments are bring drugs and crime into the business areas.
- Customers do not want to come to the core concerns for safety and well being.
- customers do not want to have to deal with encampments so they go somewhere else, cancelled appointments etc.
- customers don't feel safe walking to the business
- Customers don't feel safe coming to the core of the city to just shop as once they did, they now clump their visits to when attending doctors appointments or other more important reasons to come to the core.
- Customers feel uneasy and unsafe when walking to our buildings and into our buildings (if there is anyone posted up in the lobby). It also makes things feel dirty we've found a pile of poo in the lobby twice
- Customers feel unsafe or uncomfortable visiting areas with visible encampments, leading to decreased foot traffic and decreased demand for our services that we are offering downtown
- Customers from outside the City and region, including those from the Mountain, and even the lower City are scared to come to this area and are scared for their safety to shop in the area.
- Customers have outright told us they won't come downtown because of the fear of encampment members. The increase in drug related issues, garbage related issues, etc., has gotten out of control since the encampments have sprung up everywhere. The incidents of out of control people entering our store and harassing our customers has increased substantially. Our business is suffering and revenue is dropping.
- Customers refusing to come downtown for fear of harrassment or verbal assault.
- Customers that used to come from the mountain and outside the city no longer come to my premises citing lack of safety due to encampments. My property value has taken a significant downtown due to encampment proximity.
- customers unable to enter into establishment or being harassed when trying to. Garbage and substances left on premise.
- daily issues with people harassing our guests and staff. The incidents happen at all hours of the day. The concerns have lead to staff feeling unsafe in the restaurant.

- Damage to building Crowding exits Attempted arson x 3 Theft Aggression
- Damage to our property and thievery of products
- damage to properly, and customers uncomfortable coming to the area
- damaged property (parking gate barrier broken with a bat, locks, windows, parking lot, building grafitti,) - reputation. Bringing international clients to hamilton and away from toronto is hard enough but when they get here and wake up to go to an office with encampments garbage, drug use, needles and no security around - hard to recover from that image.
- defecation, urination, nudity, drug use, sexual abuse with a minor, deaths
- Deters commerce and makes residents feel unsafe.
- Difficulty in recruitment due to perception of unsafe environment. Those that we hired are unwilling to come to the office given the unsafe surrounding areas.
- Disruption to business
- doing drugs out front and behind location walking in and out of location bothering guests (smell) vandalism to staff vehicles (being broken into)
- Downtown is not safe or clean or pleasant for us, our employees and our clients. After more than 100 years downtown, we intend to move our business elsewhere with deep regret.
- Drug use, littering of drug paraphernalia, intrusive on families and businesses in the area.
   Loitering on steps of different businesses in the area. They burnt down the washrooms at
   Woodlands Park so now children and families can't even enjoy visiting the playground.
   Completely unfair to parents and children.
- Drug use, overdose, people exposing themselves, horrific sexual advances and awful language shouted at me through the door. Customers being harassed.
- Drugs and crime
- Due to safety concerns, we now keep the front doors of our business locked. Customers have to knock on the door to be let in, which is not very welcoming. We have had to hire security for our business, at our cost. Employees are concerned about their safety coming in and leaving work as well as at lunch. There are concerns over our ability to recruit talent, as many people do not want to come downtown. Many employees site safety concerns as a reason to increase the number of days they are to work from home.
- Effects safety in area and deters customers from coming to the business. Customers leave bad online reviews for the business relating to the encampments.
- Employees and customers being accosted. Afraid to come to workplace. People using drugs and deficating on sidewalk outside. Terrible place to business in.

- Employees are reporting more interaction with drug users, panhandlers, theft of our scrap or persons looking to steal. One incident we had a person gain access to our facility and walk through without any pants on. Employees are concerned for their safety.
- Encampments and presence of unhoused people has deeply affected our business. Lots of activity outside our restaurant. Unable to have a patio out front due to the disruptive nature of the area. Customers feel unsafe when coming down to the downtown area. Staff feel unsafe when leaving at night
- Encampments around the city make some employees, that have presence in the community feel uncomfortable, or fear for their safety when performing their duties.
- Encampments have devastated my business. Customers are scared of being downtown due to open drug use, theft and violence. Police refuse to respond and do nothing of value when they are forced to. My business has experienced vandalism, theft and lost sales. Nearby green spaces (bayfront) have been ruined for the same reason, everyone feels hopeless as these people openly destroy our city with no fear of consequences.
- Encampments have had meth labs across from our business, propane tanks have blown up. Delusional people walking the streets and trying to get into our doors.
- Encampments and large gatherings at Ferguson Station Park has: Kept customers from attending our business stating discomfort of being in the area (particularly for our salon clients) - Drug paraphernalia, garbage, human waste, sleeping or semi-conscious people, and those actively doing drugs immediately outside our business has kept us from using the patio we have licensed for the summer due to unsafe and threatening situations - An increase in theft (blatant daytime & multiple times per week) has caused financial losses that are offsetting revenues in a negative way. - Medical and mental health emergencies have had to be attended to by ourselves, customers, and neighbours. Either administering first aid, calling 911 or mental health supports, has become regular event immediately outside our shop window. - A growing number of folks under the influence have entered the store more regularly - often attempting to light crack pipes inside. - We operate an expense / petty cash account to ensure we have bottled water, juice and pop, first aid, Noxolone, and hygiene products available at all times - The physical and emotional energy required to manage those under-serviced in the area is becoming more taxing and time consuming. Ultimately taking time away from building the business and spending time on more effective solutions that could help the community in need. - The Church group that offers meals on Wednesday nights at Ferguson Station has not been responsible for ensuring garbage and clean up is taken care of properly. In addition, they preach over loudspeaker which is offensive and in noway assisting those they are feeding. The cleanup on Thursday mornings can take up to an hour on the outside of the shop - cleaning food off windows, glass pipes and needs, broken bottles, clothing, human waste, etc. immediately surrounding the shop.

- Fear of their personal safety due to perceived use of drugs and mental health issues.
- Garbage not cleaned up Drug needles very visible on sidewalks
- Garbage, distractions and unsafe.
- GENERAL ASSUMPTIONS BY THE PUBLIC THAT HAMILTON DOWNTOWN IS FULL OF ENCAMPEMTS AND IS DANGEROUS. THIS BEING LARGLEY UNTRUE FOR HUGE PORTIONS OF OUR BEAUTIFUL DOWNTOWN, THERE IS NOT ENOUGH POSITIVE COVERAGE AND/OR "MARKETING" TO EDUCATE THOSE THAT LIVE OUTSIDE OF THE CORE TO UNDERSTAND WHAT THE CITY HAS TO OFFER.
- General fear of safety affecting employees, customers, and the business at large. Customers are reluctant to come downtown into the area of business, affecting sales and revenue.
   Employees are reluctant to come into work (especially working later into the evening or independently) which affects the ability to run the business accordingly.
- Gross, unhygienic, and makes our city look like it is not taken care of. Clients and employees are afraid to walk down the streets.
- Have had people sleep in street-level stairwells beside my office building, or enter into my office building to use bathroom facilities. Some staff have had uncomfortable encounters with some of those who have entered our office building such that staff are now taking to locking the front office door at all times.
- Home renovation company. While no encampments directly near our business location, they are present near some of the houses we renovate. Risk of tool/equipment theft and damage to unoccupied houses during renovation.
- Hinders customers and employees entering and exiting our facility at different times of day. They tend to sit/sleep/shoot up on our stairs of the front entrance. We have to keep our garbage bins in a locked and gated area because they keep stealing our large city garbage bins (blue ones on wheels). This is inconvenient for garbage pick up, it has been missed occasionally because we have not unlocked the gate on time. On several occasions we have had to tend to those that have been at the front our building/or parking lot who are so high that they have required medical attention (we help until city fire/police/ambulance arrive). This takes time out of our staffs day, puts staff at risk. They pee and poop in our parking lots and front of the building. They keep trying to set up their encampments in the stoop of the building and or corners of the parking lots in the bushes. Customers and staff have noted that you cannot drive in Hamilton without having to dodge these people begging or just screaming and acting crazy in the middle of the street while trying to drive downtown. This puts motorists at risk of causing or being in a car accident while maneuvering around them. Many people have mentioned they are looking elsewhere to do business as it is sad, dirty and they feel unsafe at times coming downtown Hamilton.

- homeless harassing customers for money/items as they come in and out. Homeless coming in and stealing, using bathrooms, leaving mess and drug paraphilia behind
- homeless have tried to use my property. leaving rubbish on my property and me getting charged for it. whatever the bylaw officer sees on my property I get charged for it. am eating like a garbage man to try AND NOT GET CHARGED.
- Horrible reviews for business left for something not within our control encampments and the "street people" Patrons expressing disgust with "street people" opening doing drugs and refusing to return
- human excretment on private property, homeless persons sheltering in doorway(s), drug use in doorways(s), multiple solicitations for money when entering and exiting business.
- I FEEL THAT THE ENCAMPMENTS ARE A BLIGHT ON THE LANDSCAPE OF OUR COMMUNITY AND HAVE INCREASED THE COST OF THE CITY LOOKING AFTER THE BEAUTY OF MY CITY. THE EXTRA COSTS FOR PUBLIC SERVICE HAS PUT A BURDEN ON MYSELF AND MY CUSTOMERS. OUR MUNICIPAL GOVERNMENT HAS BEEN IN EFFECTIVE TO SOLVE THIS PROBLEM. HOW DO WE AS TAX PAYERS CHANGE THAT??
- I have had many regular clients tell me they no longer feel safe to park or come to my establishment and have lost them as repeat clients to my competitors. I have also lost 3 great employees who were either harassed, followed, yelled at, or felt unsafe leaving the premises to go to their car in fear that the people camped around the building would continue this erratic behaviour. Homeless and addicted people have also vandalized our property, and often leave their paraphernalia around the door, standing areas, and parking areas of our establishment. I have had to pay for cleanup several times and I am often calling the police for help to remove people who refuse to leave these areas.
- I operate a hotel that has multiple encampments near the QEW; the homeless people are constantly on my property, going through my dumpsters and leaving the garbage all over the ground; and trying to sleep in our stairwells. They do not want to leave when asked, and this causes undue stress to my staff as the police take normally 3-4 hours to respond.
- I have a lot of senior and marginalized customers and they have either disappeared regularly
  or are intimidated to walk certain routes to get to my store for their shopping. The parking lot
  is a constant dumpster and Overdoses are a common occurrence. I have enough to deal with
  this down economy and this is making me reconsider moving far out of the downtown core if I
  continue to be in business.
- I own a fitness studio that caters to women between the ages of 22-65 and have had an influx of reports about drug use, visible drug use on streets as they are parking, damages to the front of our building and panhandling.

- I had a shed at the back of my business with over \$5000 worth of equipment and it was broken into and everything was stolen when we looked on the video. It was folks that are in encampment spaces. After taking everything out of the space recently, just a couple days before getting the survey I found people were staying in my shed. Aside from that they're always people coming down the alleyway and doing drugs right beside our business, which is literally a part of the reason we got that prop so we could open our garage up out into the alleyway and do some programming but instead we're always seeing needles and drug paraphernalia which my staff have to clean at risk. Also, a large part of the reason I wanted to have a business that is close to the bayfront area is because the park is beautiful however, since the tents have gone up entering bayfront Park, we've seen a significant decrease in foot traffic as people want to avoid having to wal all of those tents. I have three businesses in the downtown corp and I can absolutely see how the encampments have impacted foot traffic. People do not want to walk around and have interactions with people who are struggling with addiction and are having explicit sexual and violent interactions and displays in the day much less at night.
- I live a block away from the Bayfront Park encampment. Our neighbourhood has had regular breakins and thefts. I am a carpenter, and have a lot of tools in a backyard shed, and also in my van. I wake up several times in the middle of the night most nights worried that the sound I heard was someone stealing tools. It's an uncomfortable lurking threat that's constantly at the front of my mind that I might wake up one morning and be several thousand dollars behind to replace stolen tools. We've had the propane tank from our barbecue stolen this month, and our upstairs neighbours have had their car window smashed multiple times to steal change. Thankfully there has been no direct impact on my business yet, but the lurking threat is constantly there, and if the encampments continue to terrorize our neighbourhood my wife and I will need to look into getting out, maybe leaving the city, as we can't afford to suffer some of the thefts and vandalism our neighbours have.
- I've had someone go up to my store front and pee at my door. During daylight hours at around 2:30pm
- Impeding customer access to business, encampments have also made customers not want to approach the business, unsanitary conditions that can't always be cleaned up due to repercussions from being too close to someone's belongings in an encampment.
- Increased crime including open drug use and vandalism resulting in increased costs.
- Increased levels of violence, harassment, drug use, disruptances, over-doses on the property and 911 calls since encampments appeared in the City. These issues do not exist at our other locations that do not have encampments.
- Increased litter, trash, needles on sidewalks

- Increased number of thefts from patio furniture and people wandering in the area and coming to business disturbing the operations.
- Increased the negative perception of Downtown Hamilton and discourages people from visiting the area. The blatant drug use on the sidewalks is shocking to see and both staff and customers often report feeling constantly on edge when walking around due to the harassment and frequent loud outbursts from people on the street. The amount of feces seen on the sidewalk is disturbing.
- Increased Theft and Violence towards staff, customer complaints on safety in the area. Relying on foot traffic to the location, customers need to walk through parks etc. which nobody wants to do when there are tents present.
- Is creates a sense of danger and deters people from coming to my business
- It has become difficult to operate a business in downtown Hamilton
- It has caused concerns around security and defacing of property. We have also had a significant increase in the amount of garbage that is left
- It is concerning to see that encampments are out of control. I believe that the crime rate increase is also related to this protocol
- It's scary to know people have to resort to the encampments.
- Lack of Cleanliness, theft, drug usage, a very dire situation
- Lack of foot traffic in the area, clients afraid to visit downtown and harassment on a daily basis.
- Literal daily thefts
- Litter; drug use; drug users congregating and passed out; theft; unwelcoming and sometimes unsafe for customers and employees; generally encampments create a poor business environment
- loosing business due to extreme homelessness in downtown Hamilton. Constant issues and troubles created on a daily basis, especially for the hospitality industry. This has greatly affected the Tourism/Hospitality industry in Hamilton.
- Losers hanging out
- lots of shopping carts and garbage left lying around
- Many of our ATM hours of operation have been reduced due to unsafe and unsanitary conditions for staff and clients. As well as bricks being thrown through our windows at our James street location.
- Minor inconvenience, sleeping near street letter boxes

- My Personal and business assets are at greater risk of damage. As well as a Plumber who's major market is Reno's and Legal multi unit dwelling conversion I've come to grips that the market has dried up and may not come back with the encampments and current leadership is downtown Wards.
- More than anything, optics and perception. No one from an encampment directly did anything negative to my business, but the large encampment at Woodlands Park last summer brought an influx of unhoused people to the area. As a result there were more people roaming around Barton Street and there was more trash on the street. Beyond that, it really affected people's perception of the area, seeing it as unsafe and unclean.
- My customers have vocalized that they felt uncomfortable getting from their car to my business: were approached by panhandler(s) or witnessed something disturbing such as someone taking drugs, behaving erratically, yelling (sometimes directly at them). They ask that I package their purchase discreetly as they do not feel safe carrying it from my store to their car. Cleanliness and perceived safety of the area have drastically declined. More than once there have been people sleeping/passed out in the entrances of my building. Our entrances have also been defecated on, vomited on, piles of garbage left behind. Increase in vandalism (ie: someone threw a bottle at front entrance breaking glass).
- Needles in the park, crime and garbage
- Negative experiences for customers and clients. Many report feeling unsafe, complain about garbage and cleanliness, staff having to clean up dangerous items like drug paraphernalia used needles, human waste etc.
- New customers less likely to come to the downtown. Does not impact existing customers that live and work in the area.
- no one comes to conession street anymore because it's a disgusting cesspool and looks like shit with meth heads lying dead everywhere
- No one wants to buy a building near an encampment.
- Occasional stolen item from outside the business.
- on July 15th, I had a business partner walking through doing a business tour, as we looked out one of our windows, there was a man leaning against our building openly doing crack cocaine, he was swaying back and forth, bent over, glass all around him. It was embarrassing. We called the police to deal with him.
- On occassions encampments have been setting up directly next to our outdoor event space on Commonwealth square. In addition to being unsightly (garbage, laundry, loitering, drug use, etc.) it also creates a disturbance and feeling of unease for visitors and guests.

- Our business is on Lincoln St., and the Arcelor Mittal lot at the end of the street along with the CP rail tracks that run behind the building have been host to numerous encampments. The residents have definitely committed crimes on our property due to their proximity. The last one was directly behind us on the CP property, and 2 weeks ago it finally as expected went up in flames, very narrowly avoiding damage to our property. I personally had contacted the HPS, Hamilton Fire Department and CP rail about it, as in the winter they would have fires that the smoke would blow directly into our shop while our clients were loading their gear, and obviously I was worried that one of those fires would eventually get out of control and put our property in danger. But no one would do anything about it at all. Thankfully the fire that did happen, happened during the day and was dealt with quickly.
- Our clients do not want to come downtown to the office anymore. Our staff do not like coming into the office, as they feel unsafe walking alone in the downtown area. Staff cannot use the outdoor recreational areas anymore, such as Gore Park, Jackson Square Rooftop, and they do not like leaving the office at lunch to go for walks anymore, due to being accosted by the homeless. Staff have said they feel like prisoners in the office, which is unfair to them. We have had homeless people in our underground, which is not safe for our staff and they also come into our building lobby, which again makes staff and clients feel uneasy. We have also recently had the fire alarm pulled in our building by a homeless person, which seems to happen more frequently than it should.
- Our clients/customers are worried about coming to our office in the downtown core due to fear of being accosted. Visually the encampments make our downcore core look disgusting deterring staff from enjoying the downtown core and visitors and tourists from spending time in the city. The areas are a mess and are an embarrassment to those of us who were born and bred here.
- Our cost of enforcement, damage and day to day oversight has more than eclipsed our property taxes on a psf basis. Add to this the direct loss or inability to attract tenants on account of safety, visual optics amounts to millions of dollars in losses. The lack of effort and resolve by politicians that are funded from these property tax dollars is shocking. Politicians and employees alike are all conflicted and conveniently rationalize a deferred return to work timeline. People need to recognize that a lack of enforcement and urgency to clean up the core extends beyond just encampments. Punishment for everything from vandalism, B&E, graffiti, vagrancy, loittering etc. has been ignored for years and the culture is now so complacent that there will be no one left to pay into a broken system. Insulting that even the reassessment is deferred to the point where it has cheated relief to those that have remained loyal to the downtown.
- Our staff do not like coming in due to the encampments. Additionally, they do not feel safe walking to and from their cars or going for lunch during the day.

- Our guests have told us they do not feel safe coming down to the core. We have had multiple people off the street stumble into my business and pass out in front of guests. Then we have to call emergency personell to come and take them out. They ask people on our patio for money every day while they are eating, and when they are parking. Terrible. The City has lost complete control and the businesses in the centre are struggling. Most will be gone within 1-2 years
- Our hotel guests are generally understanding, however there have been instances where guests have been harassed and intimidated. Our guests generally stay within a block or two of our location as they do not feel safe and so they do not frequent local businesses, choosing to stay in or at least close by. There have even been instances of people deficating directly outside of the hotel while guests look on in horror. The city has to come up with a workable plan.
- Our plaza has problems with people sleeping in front our businesses, doing drugs in the parking lot, harassing customers for cigarettes and money, threatening customers when they are denied cigarettes or money, people coming into the businesses demanding to use the phone, when denied they often scream and swear and hurl insults. When police are called they either don't show up or it takes them too long to arrive and by then the people causing the problem are gone.
- Our two restaurants have dropped 27% and 30% respectively over the past two years and the restaurant we own on Aberdeen, just outside of the core, is up 24% over the same period. We have experienced theft/vandalism of 30,000 dollars between the two downtown restaurants over 3 years (HVAC units, furniture, plants, planters and accessories, graffiti, merchandise) and no theft or vandalism outside the core. Customers generally speaking are avoiding businesses in the core and finding alternate solutions in the suburbs or elsewhere, where vagrancy is not apparent.
- outdoor events can be challenging, cleanup or encampments, and being aware of theft and security during before and after events
- Outside the business doors daily. Impacting customers.
- people across to my business gather drinking acholic beverages, smoking weed, swearing and slurring causing a bad reputation to business and loosing clients
- People are afraid to go on Concession Street because of the encampment at the end of the street
- People being in areas that were vacant before. Causing disturbances and stealing any scrap metal that is around.
- People do not want to book business with us based on their experience of the homelessness and safety concerns coming to our establishment.

- People do not want to come to my shop as the encampment is next to it. Scares my customers
- People don't want to come downtown. They feel unsafe.
- People in the city are afraid to come to the downtown core to shop due to the people from encampments walking the streets of our core. The drug use and mental instability of these people are driving away potential and current customers.
- People living behind our building: Vandalism, theft, fires, garbage, concerns over safety ....
   Vandalism currently under \$10k but at some point the vandalism or fires could be very significant.
   10-15 people have currently left from behind our building but others will probably be back at some point.
- People will not come to stores where homeless people and the encampments are. People are scared and feel threatened by there presence.
- Persistent vagrancy near our business has become a significant issue. We've had to involve area security and the police because individuals are sleeping in the front entrance, preventing our members from using the ATM. To address this, we installed a timed lock on our doors. Unfortunately, due to the nature of our business, we usually keep our blinds open, but the vagrancy outside has forced us to close them, impacting branch security and safety. Additionally, the noise from these individuals disrupts our meetings with clients."
- Picking through garbage, dumping in alley, rampant drug use in all/on property, needles and other drug items strewn about
- Poor customer image of the area
- Regular property damage; fences cut, equipment like air conditioners damages, wires cut, garage, needles, broken windows, aggressive behaviour
- Repeat customers refusing to return due to safety concerns, less foot traffic, threats to staff from encampment residents at downtown location, staff resigning due to feeling unsafe because of encampments, theft by encampment residents, exterior air conditioning unit damaged due to stolen copper piping, etc.
- Requests to use washroom facilities and services not provided
- Sad, messed up people vandalizing my building, trespassing and messing my property constantly, intimidating our staff and visitors.
- Safety concerns. Drug items around the property. People laid out on the grass on route to business. Have had to increase security at additional cost. Staff do not feel safe.
- Safety issues (people have gotten attacked and perceived unsafe environment that deters people from coming downtown) Increased theft

- safety concerns for staff have to locked themselves in bathroom. found people passed out behind building and in aisles. Weapons are very common. Staff are quitting or off on leave. Patrons advise they want to support us but they feel unsafe. Patrons have had their car broken into or windows smashed while they were in my store. Patrons and staff feel unsafe with open drug use and knives visible at encampment sites close to stores. theft is very common, and the encampment residents just walk right back into their encampment with stolen goods. This needs to change.
- safety issues for employees around the office. mentally unstable and drug addicts all around the office. open drug use on the streets.
- sense of unsafeness at the Catherine Street Location;
- Several comments from guests eating at our establishment they feel unsafe. Concerned for their well being. They've avoided it before and will again. We've lost business due to this from others saying they won't host people because of it.
- Sitting in front of the doors. Leaving a mess. Smells in the area.
- sleeping in front of business, leaving garbage and belongings in front of our business. Makes our area look unsafe and unappealing to our clientele. Some of the people from the encampments come into our business and ask to use our phones and tie up our phone lines. on occasion they have become aggressive towards staff
- Sleeping in the Royal Bank Vestibule, refusing to leave, threatening my staff, going through garbage cans and leaving a mess
- Slightly more debris behind 165-171 King St. E. Occasional, unnecessary encounters with odd characters who seem lost.
- Staff and clients feel unsafe and uncomfortable coming to our office
- Staff are fearful when finding parking and returning late at night. General unsightliness and litter strewn around. Creates traffic slowdowns.
- Spill over into parking lot of homeless; garbage including drug paraphrenalia; human urination and fecal matter at doorways, pkg areas and sidewalks. Tenants (commercial) cannot accept walk in customers; bldgs on full lock down outside narrow set of hours. Tenants and customers have been verbally abused and personal space breached; violent outbursts are commonplace. Cannot lease vacant space under these conditions
- Staff do not feel safe in the downtown core
- staff reluctant to spend more days in the office because of downtown travel through encampments near by and street parking staff feel unsafe

- Some of the day to day events include: very intoxicated people hanging around outside my shop, people smoking drugs in my doorway, human feces and drug paraphernalia found behind my business, people on the sidewalk yelling and acting aggressively toward myself and customers, intoxicated people/mentally unstable coming in my shop that refuse to leave, garbage and discarded clothing left on the sidewalk, minor property damage. As a whole, I often feel unsafe at work and I frequently lock my door when I see an unstable person on my block. I also worry that my customers don't feel safe while visiting my shop.
- Staff assaulted and accosted by groups within encampments while walking downtown and into work - Staff threatened with violence when asking those building encampments at our entryways to move along as to not block customers pathway - significant amount of drug paraphernalia, trash, fecal matter, and urine along pathways/sidewalks/alcoves that lead into our business - erratic behaviour and open drug use along the pathways that lead to our business - Overwhelming customer and staff feedback that they no longer feel safe or comfortable coming downtown - Staff no longer feel safe walking to and from their cars into work for evening shifts (approx. 50 staff)
- Stolen goods, defecation in public, extreme garbage, low morale, vandalism of the surroundings to the point that we would like to move the business out of Hamilton if would be feasible
- Street safety concerns.
- Tents all over our property Garbage strung about Feces and urination on our property daily Houseless folks arguing with staff and patrons Rare, but have been threats from houseless people to our staff
- The BIA resources have been severely drained trying to manage the day-to-day issues our businesses are facing from encampments.
- the customer feed back is not very nice
- The encampment people love hanging out at the back of our parking lot, we have seen some of them do drugs, looked lost. When we see them in the camera, we will send staff to tell them to leave, but not all of them will listen. We have had encounter that they were very rude and aggressive towards our staff when we tell them to leave the private property.
- The encampments downtown tend to make people shy away from supporting local businesses as they see the unhoused as a stereotype of beggars and criminals, but not as the victims of systemic poverty.
- The encampments in and around City Hall and Bayfront Parks are littered with litter, needles, garbage, open drugs use, terrible image for the City, downtown is a disaster, most citizens from the mountain will not go Downtown

- The garbage, aggressive panhandling, and open fire and propane tank usage is making it difficult to live and work here.
- The homeless sit outside my restaurant every morning and it scares people away. Tim Hortons left downtown Stoney Creek because of this problem and nothing is being done about it. Why not build supportive housing in the encampments around Walmart?
- The individuals in these encampments use our facilities for using the washroom and bathing. They unfortunately use our resources and is not cost effective for us to maintain. Many of them have also vandalized our property in some way to maintain their encampments.
- The more occupants at an encampment, the more frequent it's occupants populate the streets. This brings about a certain image, a certain behaviour, and overall experience net negative to the street. Actions include swearing, yelling, alcohol or drug use (even perceived), and much more.
- The neighboring property has co-operative housing units which should in theory, encourage affordable housing for those in need. It has however created inhabitants in several units that are housing encampment dwellers for overnight stays. This has resulted in regular destruction of the professional business surrounding fences, significant and regular garbage (including mattresses etc.) left in our professional parking lot for our clean up, used needles and other drug paraphernalia as well as the need to lock up our lobby during the evening hours, providing a lack of access to our member customers after hours.
- The people living in the encampment at Mountain Drive Park have broken into houses in broad daylight, stolen property and are out in our residential streets intimidating residents. The park is no longer enjoyable, it's scary.
- Theft, illegal dumping, panhandling, uprise in crime
- thefts, violence, break ins
- There are drug addicts every. Some look dead just lying on the street or behind my store. The have taking a shit on my building. One of them burnt down the building across from me. It's very unsafe and the police don't even stop them from smoking heroin, meth and crack right in public.
- There have been some safety concerns. mentally unstable, and /or in crisis individuals have frequented our building cause the tenants and staff to get upset. Garbage around our building has been a bit of an issue as well.
- There have been two shootings around the corner from our business. As a result, we are scared, and our employees are afraid to walk to their vehicles.
- These are eyesores to parks and businesses especially promoting beauty and cleanliness. It also affects the safety of people as they do cause trouble to others, especially to tourists.

- They have set up in our parking lots and are asking for money when are customers are trying to come in,
- They definitely make clients uneasy when coming in for meetings some of which make comments about it. We've also had issues with the the unhoused coming into the building/offices; as well we have had one camp out in our elevator over a weekend and it was a big mess.
- They occupy our parking lot, smoking drug pipes in the open in front of customers and children. They leave needles around and defecate in public. It is disgusting.
- They're along my walking route to my office, and I've witnessed countless activity of extreme drug usage, seen feces, general uncleanliness and overall it makes me feel unsafe as a small woman walking the streets alone (even in the daylight). We've received feedback from our neighbouring business that our clients are complaining and cancelling their contracts with us for the same reasons mentioned above. Further, we have employees who are requesting to work remotely to avoid the downtown.
- trash everywhere and unwanted individuals roaming around the hotel and sitting outside the hotel doing drunks and drinking, lot of mentally ill individuals threating and harassing our guests non stop all around the hotel and sometimes inside the Jackson Square mall
- Trespassing / individuals feeling unsafe to walk by due to drug impairment / needles / human waste / garbage
- Trespassing. Theft. Dirty needles. Confrontations with staff. Garbage and debris. Break-andenters. Vehicle break-in attempts. Customer complaints and concerns.
- Undesirable for customers / don't feel safe
- unhoused persons have been found in our trucks and trailers various times including being found once we have arrived a customers. We are concerned for their safety riding in a moving vehicle without any way to be secured should there be an accident of sudden stop. Both the drivers and customers are startled when finding someone in the equipment and do not want to confront the person. The police must be called for assistance. Our properties are often used to relieve themselves and waste and garbage left scattered.
- Unruly patrons disrupting flo of business
- Unwillingness to have stakeholders meet downtown due to safety concerns.
- vandalism on our building broken into customers cars my car alone has been broken into three times staff not feeling safe walking to their cars
- Vandalism, Theft, Crime, Public Drug Use/ Dicarded needle risk, public urination/defecation on business property, intimidating Employees and Customers. Loss of sales due to decreased customer visits,

- Very simply, and in general, staff do not want to work in the downtown core, our clients do not want to attend our office in the downtown core, and neither group feels safe in the downtown core.
- Violence, mischief and property damage, thefts, open hard drug use, sex acts are all common occurances now around our shops. The offenders are people that occupy encampments. Customers stay away because they are afraid of the area. Our business is in finacial peril due to the encampments.
- Visible deterrent to client visits to my business, at least one occurence of arson attempted on my building, visible drug use.
- visually unattractive to pedestrians, vehicle traffic, causing a fear of I dont want to come to this area wandering participants from tent cities, to walk streets, high on drugs, beg for money comeinto restaurants to beg for food aggresivly, steal from table food sit in doorways obstruction patrons pass out on sidewalks from drug use
- We are aware of clients who live unhoused in the encampments but those clients are indistinguishable from other clients.
- We are experiencing ongoing inappropriate behavior, including the disposal of needles and feces, pipes for hard drugs, and other garbage around our business. Additionally, drug transactions are frequently occurring in the area.
- We are renovating the First Ontario Centre and all of our brand marketing sponsors and hospitality customers are asking about safety and security around the venue. We need the support of the local business leadership and city to help.
- We are starting to lose clients and staff because of their reluctance to come to the downtown core because of the encampments.
- We deal with the following on a daily basis violence, drug usage in our bathroom, parking lot, witnessing overdose, theft, moving people belonging who are setting up in our private lot (more importantly drug needles) the list can keep on going
- we had an encampment right across the street. it stopped our tenants from doing test drives down the street. The encampment had a car there with the doors open. Transport trucks couldnt turn. Also the encampment were hanging clothes lines and things so they could go to the washroom in the grass
- We have had a few instances of tents being setup on our property. nothing that has stuck through sprinklers and staff asking them to leave. More of an overflow of encampment activity from downtown areas. The city drug issue makes its way into our hotel on occasion.

- We have had encampments around our building particularly on Fergusson Street. We've surveyed our patrons and the #2 reason they do not come to the theatre is due to "fear of going downtown".
- We have had people urinating and defecating outside our store during the day which has deterred walk-in customers. Additionally we have had to lock our store doors when mentally ill people have loitered in front of our store and/or tried to get in to ask for money who would not leave when asked kindly--they have no where to go. Our customers are kind hearted people, but they do not feel safe. We often find syringes and drug paraphernalia around our entrance. My employees don't feel safe walking to and from work.
- We have had to hire full time security.
- We have individuals who are setting up in vestibule area during close of business hours leaving garbage, unsafe for people to use ABM machines located in vestibule areas we have had to lock our vestibule doors thus impacting Member accessibility to their funds
- We have lost events, we have needed to add additional security at our cost. we have introduced a safety plan for our staffing groups.
- We have mainly had visitors mention the encampments and how it nearly dissuaded them from visiting till they recognized we are not near the major encampments.
- We have many incidents of homeless or drug influenced people hanging around our parking lot. Our customer did express concern about random people hanging out outside our business (not complaint as they know it is out of our control). Once in a while we will have to throw away some old clothes, we have had found some empty hand bag (we believe they were stolen because only wallet is missing).
- We have regularly had items stolen while working on jobsites
- We have routinely had to clean up broken crack pipes, needles and other unsanitary entrances from our shop entrance, one of our employees was trapped in the shop with a person high on drugs for over 45 minutes, we have been harassed while alone in the shop a number of times by a known individual with mental health/substance abuse issues, help is always very slow to arrive, foot traffic all but disappeared once the encampment set up at Woodland Park, many of our customers perceive the area as generally unsafe, and we have had to ask several people to stop smoking crack and/or injecting drugs right in front of our shop window. We are often unable to put garbage/recycling out as the bags are torn open and garbage scattered around the general area of the store overnight.
- We have seen a rise in displaced individuals panhandling, looking for shelter when weather is bad, increase in theft and violent incidents.
- we have to keep our doors locked and allow customers to enter only after being buzzed in.

- We hesitate to book film shoots in city parks and have looked for rural locations instead. We have also had our workday interrupted after witnessing an altercation at one of the encampments near our office and waiting for law enforcement to arrive.
- We often hear that people avoid the area due to the encampments. That fear for their safety. We have also had homeless people enter the store to steal whatever they can get their hands on, bullying my wife when she's alone.
- We recently have had many interactions with unhoused people. They come into our store asking to use the phone and yell very mean things to the staff when they say no. This morning there were two people sleeping in our doorway and we were unable to open the store. There have been people openly doing drugs at the back entrances. This has resulted in a lot of fear for our staff, many of them young woman who work until 8pm. We have had to incur the cost of adding additional staff to help everyone feel safe. We have lost customers because they are also scared of the profanities that are regularly yelled and the drug use they witness.
- We've had individuals sleeping in our foyer, using drugs in front and at the side of our business. We had a man defecate in front of our window as well as drug deals happening in broad daylight in front of the shop.
- We've had to lock our doors during business hours as homeless people on drugs would enter. It is a stain on our community. Unsightly. Unsafe. Unwelcoming. My children shouldn't have to see this. If you want to give them a place to set up their tents, give them a piece of land in the middle of no where so we don't have to see it.
- While the tents were allowed in Victoria Park our outdoor 3 & 5 ton a/c units were robbed of their copper resulting in an insurance claim for them both. Same was true for two other businesses within the Park area.
- Who wants to come to Hamilton anymore? I don't even feel safe walking down the street anymore. They are everywhere, constantly begging, in your way, in your face. Drunk, on drugs. Shooting up in front of children. Garbage is everywhere! It just furthers the dirty Hamilton narrative that plagues us. I never came downtown as a kid, and if I didn't work in the core of Hamilton, I would never come down here NOW. The mayor/council does absolutely NOTHING. They allow this by remaining completely complacent.

- 1. Move people into housing first The most critical issue facing all homeless people—the lack of permanent housing—must be addressed first. Other services and programs directed at homeless people and families can support and maintain homeless people in this permanent housing. Reduce or eliminate DC's and take a pro-development stance so that developers can and will develop within and around the city. This is the first step to any successful plan around housing as demonstrated by the cities of Portland, Calgary and several others. 2. Emphasize permanent solutions Too many are using the shelter system as temporary housing. 3. Economic Development Emphasize that Hamilton is open for business. The only long-term solution will involve public-private partnerships and private money goes where there is opportunity. 4. Greater police presence. In order to attract businesses and visitors as well as permanent residents, the city must provide a safe community and there is currently an undercurrent that no one at the city cares or is doing anything about both homelessness and security.
- 1) spread community support services throughout the city rather than having so many in the downtown core, 2) have a greater police presence, 3) consult other municipalities which have made successful downtown revitalizations (ex. Kitchener), 4) attract businesses to the downtown (ex. provide financial incentives), 5) make improvements to the downtown streetscape, 6) provide businesses with incentives to improve buildings/facades, 7) provide free downtown parking, 8) provide incentives to builders to build residential apartment/condos, 9) consult downtown businesses for their input and work with them, 10) and finally get the LRT built (how many years has it been! Get it done!).
- 1. Stop anyone from coming into Hamilton to access services and end up in encampments. 2. Send anyone that is not from Hamilton back to where they came from. 3. There is organized crime and sex violence in these encampments. 4. involuntarily commit individuals into treatment to break the opiod addiction and follow them closely after release to ensure that they complyand stay clean. They are unable to be housed until clean 5. Stop funding non profits that advocate for harm reduction. Stop harm reduction. This is enabling the addict with no end game in site. 6. Let campground providers set up housing in their facilities. Away from the city. Ensure that people that can be housed are protected. 7. Get rid of all woke councillors for deriliction of duty. [redacted name] and [redacted name] should be first.

- 1) DEFUND THE POLICE. Provide appropriate budget for housing and public health supports vs. Policing problems after they have happened. 2) Actually do the math: How much does it cost every time an encampment is cleared? At Ferguson Station I see 2-6 Uniform Officers, at least 1 city garbage truck, 1-2 city maintenance trucks, and up to 10 city workings handling cleanup. Attending an encampment to "shoo" people away while giving them no place to go, no offer to transport them or their possessions, and having no public health, addictions, or housing support on site is atrocious. This is an inhumane practice that needs to end. 3) Actually do the work to budget what is required to take our citizens off the streets and put them in safe housing situations with proper supports. I'd guess it's similar to what you spend on clearing and policing encampments (as above) for real though y'all. 4) Mobile Heath and Harm Reduction units available 365 days per year. Lead by actual research and data that shows successful management of support for our people reduces crime and police budgets a lot more than ignoring it like you're doing now. 5) Give us some of the police money to keep our businesses open. Being 150 feet away from the Station makes a glaring spectacle of dozens of uniform cars driving by people in distress every single day.
- Actually deal with the issue and stop pussy footing around it
- Additional police presences in the entertainment district. We need our clients/guests to feel safe
- Approve initiatives like the Hamilton Alliance for Tiny Homes to quickly provide stable housing for some individuals.
- Arrest the drug dealers. Many of these people have drug addiction issues. Do not allow encampments and open more shelters. It's gotten worse.
- assign/designate an encampment location. In order for communities/families to thrive in a business district, safety should not be compromised
- Ban the construction of structures including tents in public parks.
- Ban them
- Be firm on not allowing encampments anywhere in the City. We are in the real estate business and the encampment practice has a profound effect on the business and the way people perceive the City. People do not want to rent downtown and overall in Hamilton if they have other options. The level of leaving and enjoyment of the City is greatly impacted.
- Better enforcement and reallocation of these individuals. Collaborate with the proper groups to ensure they are located in an area where it does not impact the greater community.
- Better support for the homeless is needed and faster approval and funding of affordable housing. Bring in more events to the downtown core, create more jobs, add security.

- Build more temporary (emergency stockpile of pre-built homes) and permanent affordable housing
- build proper shelters away from the downtown business core
- By getting out of their own way and prioritizing new residential development. Both market and affordable. Too many bureaucrats making work for themselves to justify their role instead of doing the right thing and getting more housing units built.
- Centralize the encampments in one particular area. A centralized compassionate approach to provide out houses and or shower trailer a centralized area would also support the lien police services so that the community is safe for all. Police presence walking the core engaging with people, moving them along.
- Class streets and sidewalks along king, main, cannon
- Clean up alleys instead of blaming businesses
- Clean up our city, uphold the laws, help relocate the encampments

- Divest and cut all ties with Israel and all other entities committing genocide.
- Do not allow encampment
- Do not allow encampments in parks or residential areas. Try to reduce the appeal Hamilton has to the unhoused and limit places where people can freely camp. Provide a specific area where people can camp and no where else. Make sure this area is away from residential areas
- Do not allow encampments to exist all over the City. Provide an area where the unhoused are allowed to be and provide resources. This will eliminate the option to be unhoused all throughout the City and ensure the individuals who need resources have access to them.
- do noy allow them to be established near any business, enforce bylaws promptly
- Do something to gather them into tiny home projects, where they could get the services they
  need to keep them and the community safe and perhaps get them into regular housing again.
  It is ENFURIATING to see the amount of wasted time the council is spending on this issue.

- Don't allow encampments and offer proper solution such has adapt habitats that include medical care
- Education and resources proactively shared, mailed, posted etc... I found that I had to communicate to BIA area businesses, and my tenants on how to report, get help & resources. It would also be good to know what updates there are to the housing crisis and how people can help.
- Eliminate all encampments in a newly created tourism and business zone(s). Eliminate the 5 tent bylaw and introduce sanctioned encampments with wrap around services and introduce no less than 6 police on foot in tourism and business zones operating from 8am to 11pm.
- ENCAMPENTS MUST ONLY BE PERMITTED IN AREAS THAT DO NOT ADVERSLEY AFFECT BIA'S, RESIDENTIAL AREAS AND SCHOOLS. A KEY ASPECT OF THE SUPPORT IS TO STOP AND PROHIBIT THE USE OF ILLICIT DRUGS ON THE STREET AS THIS IS A MAJOR STICKING POINT FOR MANY HESITANT VISITORS TO THE CORE.

- Encampment people need help. The sites need to be serviced. Best to help them before encampments get too big. [redacted name]
- Encampments are an unacceptable solution. Removing them is the solution (replacing with appropriate city-run shelters).
- Encampments are inhumane. There needs to be institutions for those incapable of caring for themselves. Those committing crimes need to be incarcerated. For the rest, there needs to be a designated space, far from downtown. A designated encampment would provide safety and services to the residents. It would allow the services to come to them rather than spread out around our city.
- Encampments need to be dismantled, not only is it dangerous it is a terrible optic for newcomers to our city
- Encampments need to be taken down. Need more police patrolling in the downtown area
- Encampments should not be permitted in/near a BIA. The city should create/offer 1) low income housing for those who are homeless strictly due to economic difficulties and 2) institutional residences with social services/care offered for those who are homeless on account of mental health/addiction issues. Neither of which should be concentrated in the core but spread out across the city. Social services, methadone clinics should also be spread out instead of crammed into the downtown area.
- Encourage law enforcement/ by law officers to respond to calls.
- End encampments.
- enforce current Bi-Laws and close all camps
- Enforce the law. Hamilton has been not only soft but openly encouraging this behaviour. Other cities are sending their homeless here to invade and destroy our public spaces. The tyranny of a few hundred have destroyed a city that deserves to be enjoyed by 300000 others. Police and city council DO NOTHING.
- Enforce the laws
- Establish designated areas with adequate facilities (toilets, waste disposal) for encampments to minimize their impact on business areas and public parks. Implement regular sanitation schedules to keep public areas clean and reduce health hazards. Provide grants or subsidies for businesses to enhance their security measures, such as installing cameras or hiring additional security personnel. Offer financial assistance or city services to help businesses with property maintenance and cleanup efforts related to encampments.

Hamilton is a 3rd world community which has arrogantly proclaimed itself as the Ambitious City without basis. Turn your heads to safety, appearance and foot traffic before you go broke.

I mean for goodness sakes, if I can't camp on crown land for more than two weeks why can people stoop in our public space for an indefinite period of time?
- How about remove the encampments. The City runs several programs offering shelter to those in need. Loitering is not allowed in a basic park so why are people able to take over and set up tents anywhere they want now? The only support the City needs to provide is clearing out the encampments and continuing to provide options to those without shelter.
- I don't know what the solution is. Police being able to respond immediately would be helpful, more shelter beds, more drug addiction services such as rehab. Making it illegal again to do drugs in public as the situation has gotten out of control. Possibly funding for subsidized security in plazas.
- I believe people are sympathetic to the cause but I don't believe this is just an encampment issue. There are a lot of social and substance issues to go along with. Unfortunately you can't conquer it all so I believe it needs to start with bite size pieces. Start with the small population that can be helped. Give them a centralized place to go and access services efficiently. Is so difficult these days to get help all the services departments etc etc. I do understand for some options are minimal, but there are some that can be helped they just need the proper direction but we make those services hard to obtain.
- I feel it would be better to support the people in the encampments rather than the businesses. If there are no persons in encampments then there is no need to support corporate endeavors that cause encampments.
- I haven't really thought about it I know it's just the unfortunate circumstance of todays economic climate with many factors at play. We've also talked about increased security to remove people if possible.
- I really don't. If our essential services won't help, I don't see what the city can do, and with the fact it takes on average an hour to get hold of anyone there, who has time to even try?

- I have seen cities that have utilized city parking lots to house the tent cities. They have clean rest rooms, and BBQs to allow them to prepare their food. We need to make sure that the Canadians have their dignity. I have walked down our Hamilton city and there is human feces, and the garbage in our city is horrendous. This is just a band aid for the severe issue we have. There is a ton of land in Hamilton. I recommend money be spent in housing that allows Canadians live with dignity. - I operated my business for 3 years in downtown Hamilton. Over the course of this time I saw the issue with encampments continue to the point where people were living in vacant units around my business. I've moved to protect myself and my clients as these issues have continued with no end in sight. The only support I got well in downtown was from my BIA staff that went above and beyond to advocate for my business when the city was unable or unwilling to do anything. If the city had acted sooner I might not have left downtown.
- I think designated areas would help until better housing is available. I think encampments need to be far enough from businesses to not impede or deter customer traffic.

- I've been in downtown Hamilton for over 6 years. People do not want to work, live, or visit downtown anymore if they do not have to. I've heard many times from new residents in condos afraid to leave their buildings and regretting moving here. The city, Councillors, and Mayor have not done enough to support small businesses in the core. Multiple emergencies have been declared, with no actual urgent actions being taken. For years businesses in the core have been promised more support (cleaner streets, upgraded sidewalks, grants, new developments, LRT, HSR Improvements etc.). While there have been some advances, we are being left behind in the region compared to other cities. Sidewalks are crumbling, public art/murals always have graffiti on them, parks are unsafe to use, it is not safe to open or even walk outside at night, and foot traffic is down to almost zero on a daily basis. The impacts from encampments have been extreme, though the mismanagement of these crisis by the city has had a more extreme impact on the sustainability of businesses in the core.
- If we could have more street cleaning services either offered from the city OR as additional funds offered to businesses so we could hire staff to clean the surrounding areas of our building. Some of our current staff do not feel safe cleaning around the building. Wondering if there are specially trained city staff that could take this on?

- The city of Hamilton can support our business by not having any encampments! I think it is one of the lowest forms of human acknowledgement is to allow people to have tense outside. And encampments and tents say that you do not care about the physical lives inside of the tent and you do not care about the psychological lives of the people who have to see the tents. It's incredibly disappointing that a city that could be so robust and healthy is allowing what they believe to be social supports to the people who don't pay taxes don't support the cities economic development are not contributing financially to the growth of the city in anyway shape or form, but have the opportunity to have their garbage collected at the side of the street have tents up outside. It's really really upsetting. The city of Hamilton has failed drastically in this area. If allowing drug addicts were having sex during the day in the park while my kids and my family members walk-through, it is Goodwill then humanity is suffering.
- The City of Hamilton could do something PROACTIVE and help these unhoused people instead of wasting tax dollars making their lives even more harder and stripping them of what little they have. The lack of unhoused means there would be no impact of encampments.but that would be too logical.
- the city of hamilton has to stop the encampments before they get going. we have taken our grandchildren for the walk at bayfront park. yes there were a lot of police and the encampments stayed in the tents. but we wont be taking the grandchildren down to the bayfront park anymore. and it is a shame because its a nice park.
- The city of Hamilton should do all it can to provide shelter for people, either permanent housing, supportive housing or temporary housing as required.

- The city should invest in removing public encampments since its affecting families and children of the community. Homeless people are wandering around the city stealing things from backyards or breaking into cars. It is obvious that this protocol didn't do anything good to this city.
- The city of Hamilton should be supporting those who are currently unhoused, instead of attempting to remove these people without any support of helping them. Many of these people face mental health issues and with the price of living sky rocketing it is being made impossible for people to remain "on there feet". Without the proper care for those who are suffering this issue is only going to get worse. It is understandable that the city is thinking of business that are being affected but more importantly the city should be thinking of the humans that are being affected. It is devastating that as the weather gets more extreme we will see more death in these encampments, these deaths are affecting those who are in dire need of our help. Without a proper plan put into action we will slowing see these encampments taking over streets and it will become harder to police and will cause crime rates to continue to increase. If the city of Hamilton would like to support business with the impact of the encampments they should start by actually fixing the root of the problem, and that is mental health issues. As seen in many of the East cost provinces and states it is very easy for issues like this to become massive problems over the course of a decade i.e Skid row.
- The encampments must be removed period. there needs to be real affordable housing otherwise this will never go away. Why do building permits continue to be allowed for luxury condos and luxury homes when thousands of people need simple affordable housing? Being in the construction industry it is more than apparent nothing needs to be as expensive as it is being touted. There are economical solutions to be achieved but unfortunatly as soon as government is involved there is a long list of people who line up to steal the show and take advantage of the money being spent. We need strong un corrupted leadership. Hell I dont even care if its corrupted... just dont be so selfish as to bury the city in squalor. Money can be made if the city is successful as well! imagine that. Most people want to improve themselves if given a chance. We need zero tolerance of street peddling and real housing (not encampents or slum housing) End the million dollar ++ home building.
- The word on the street is that encampments know they will not be charged or suffer consequences for their actions which is emboldening them in disrespecting personal & City property.
- There should not be encampments close to businesses unless they can be kept tidy and the residents are mindful of their impact.
- they need help to move off the streets are there programs that can support a monthly financial support for a year or so to help these people move towards housing decency?

- They have an abandoned townhouse complex at the foot of James St, Convert into simple one bed one bath kitchenette units, perform products such as that, social work the encampments as to why they are there, not always money and refer them to the agency that best suites there needs. By doing nothing you are just enabling the problem. Sometimes you have to perform tough love in order to motivate the person to make a change
- This is a tricky question, without the support of affordable housing projects, that these individuals would actually attend, I cannot see this issue going away. I understand the cost of living crisis make that near impossible to avoid.
- This is a significant issue not just here in Hamilton, however, one person's rights shouldn't
  interfere with anothers. Long-term it will create business who do not want to maintain
  addresses therefore impacting tax revenues. If tax revenues are to maintain, that proactive
  supports AND controls need to be part of the strategic design. Reactive is only burdening the
  city staff and residents while the causal inhabitants are simply moving on and replicating the
  actions elsewhere daily with no accountability.
- Unfortunately my suggestions are perhaps old fashioned. Crack down on public drug use, arrest and detain people and force treatment for addiction, dont let the encampments get started.
- We need the encampments to be removed, or some remedy for housing to be reached. We need more involvement downtown whether it be police, or outreach programs, etc.
- Well the obvious choice is to move the encampment to a different location, but that's hardly a permanent solution. Strictly speaking from Concession BIA perspective, they just need to be gone from our location. Ethically speaking, I don't know to solve the issue.
- Work with the police instead of against each other (stop finger pointing). Take action identify quick wins and implement expediently instead of soapboxing; spending more time hypothesizing and describing an ideal scenario that never gets implemented. We've all hit our limit, no patience left regarding ineffectiveness
- Yeah. Get RID OF THEM.
- Yes remove the Encampments and stop allowing illegal use on public owned lands. This in itself allows more encampments to pop up where ever the people see fit. This disrupts the pleasure of parks and the safety to all.
- Yes, remove them and have the police arrest people for stealing, drug use, loitering etc.
- Zero tolerance for public drug use and encampments outside desiganted area. There is enough land in canada. Designate an area away from the main business and residential. Centralize the issue and offer support from a contained area.
