Mayor Horwath called the meeting to order and recognized that Council is meeting on the traditional territories of the Erie, Neutral, HuronWendat, Haudenosaunee and Mississaugas. This land is covered by the Dish with One Spoon Wampum Belt Covenant, which was an agreement between the Haudenosaunee and Anishinaabek to share and care for the resources around the Great Lakes. It was further acknowledged that this land is covered by the Between the Lakes Purchase, 1792, between the Crown and the Mississaugas of the Credit First Nation. The City of Hamilton is home to many Indigenous people from across Turtle Island (North America) and it was recognized that we must do more to learn about the rich history of this land so that we can better understand our roles as residents, neighbours, partners and caretakers.

Item 15 was voted on separately, as follows:

15. Representation by the Urban Indigenous Community at City Council (Item 11.2)

WHEREAS City Council is currently made up of 15 Councillors and 1 Mayor, a total of 16 members;

WHEREAS members of the urban Indigenous community, represented by the Circle of Beads, have asked the City of Hamilton to support their request for the City to ask the Province of Ontario to have changes made to the *Municipal Act* to permit a member of Hamilton's urban Indigenous community to be a voting member of City Council;

WHEREAS the Circle of Beads has asked, while Council awaits word from the Province about that request, that it establish an interim advisory seat (non voting) on Council for a member of Hamilton's urban Indigenous community;

WHEREAS there are governance, legal, and other implications to honouring these requests that the municipality must fully explore before Council formally considers them;

WHEREAS First Nations in Canada have specific and distinct relationships with the Federal and Provincial levels of governments through the *Indian Act*;

WHEREAS according to the National Association of Friendship Centres, as of 2021, approximately 88% of Indigenous people in Ontario live in urban settings, which means that a majority of Indigenous peoples live their lives with no direct local representation with respect to the services they access most;

WHEREAS City Council approved the Urban Indigenous Strategy (UIS) presented to, endorsed, and fully supported by the General Issues Committee on July 8, 2019 and committed to "having a trusting relationship with Indigenous communities where we communicate and work together appropriately to address the unique needs and issues of Indigenous people";

WHEREAS, within the UIS, there was direct acknowledgement of ongoing and historical oppression including many unique barriers related to health, poverty, justice, employment, and intergenerational trauma;

WHEREAS City Council has made a commitment to supporting Indigenous rights and history;

WHEREAS Land Theme Action 8 in the UIS, a short term goal meant to be achieved by the City in 1-2 years, reads, "Understand how concepts such as the Doctrine of Discovery affect municipal decision making and develop tools to reform those processes";

WHEREAS the City of Halifax, Nova Scotia, after approving a motion to its Regional Council on October 23, 2023, is currently investigating and considering the development of an Indigenous council seat, specifically a Mi'kmaw seat; and

WHEREAS the Province of Nova Scotia has set a precedent by the addition of a Provincial seat in their legislature for a Mi'kmaw representative since 1992.

THEREFORE, BE IT RESOLVED:

- (a) That City staff in the Indigenous Relations and Legal Services Divisions report back to a future General Issues Committee on recommendations and information related to the following:
 - (i) The City's statutory responsibilities to Indigenous communities, the responsibilities of the Provincial and Federal governments, and an identification of any limitations in the *Municipal Act* and other legislation including an analysis that addresses the requests made by the Circle of Beads to Council on February 14 and June 19, 2024;

- (ii) The outstanding actions in the Urban Indigenous Strategy (UIS) that include an identification of any ongoing work towards closer collaboration and involvement throughout the municipal decision making process as it relates to the urban Indigenous community and other Indigenous leaders and representative organizations; and
- (iii) The ongoing work the City is doing with respect to Truth and Reconciliation best practices including a scan of the work being done by other municipalities across Canada and ongoing work through the Federation of Canadian Municipalities with respect to urban Indigenous communities and other Indigenous leaders and representative organizations.

defined depth and the air portion, to be more specifically defined and more particularly described in reference plans, and on such terms and conditions satisfactory to the General Manager of the Planning and Economic Development Department or designate, in a form satisfactory to the City Solicitor;

- Heritage window pane repair by Lower City Joinery for \$4,881.60

- Chain link fence replacement for \$9,034.35
- LED lighting conversion by Christopher's Electric for \$3,725.71

7.5 Request for the Association of Municipalities of Ontario (AMO) to Advocate to the Government of Ontario to Increase Ontario Disability Support Program (ODSP) and Ontario Works (OW) Rates in Ontario

(Hwang/Jackson)

WHEREAS, the Hamilton Social Work Action Committee delegated to the Emergency & Community Services Committee on June 20, 2024, to ask the City of Hamilton to encourage the Association of Municipalities of Ontario (AMO) to leverage its collective power to advocate to the Government of Ontario for it to significantly increase the rates for the Ontario Disability Support Program (ODSP) and Ontario Works (OW);

WHEREAS, about 500,000 Ontarians with disabilities rely on ODSP, with a maximum of \$1,368 per month for a single person and about 445,000 Ontarians rely on Ontario Works, with a maximum of \$733 per month for a single person, that the average ODSP or OW recipient is entitled to much less, when adjusting for inflation, than they did in the late 1990s:

WHEREAS, ODSP rates were frozen from 2018 to 2022 and that even with the indexation of ODSP rates, they remain lower than when they were frozen in 2018, whereas OW rates remain frozen since 2018, which resulted in a 15% decline in inflation-adjusted rates from 2018 to 2024;

WHEREAS, even with the rate of inflation increase for ODSP, the social assistance income of individuals with a disability is not only well below the poverty line but also below the deep income poverty threshold;

WHEREAS, current ODSP and OW rates are contributing to the housing precarity of recipients of social assistance, leading some to experience homelessness, thereby exacerbating existing disabilities and food insecurity, and that homelessness is a social, economic, and health crisis;

WHEREAS, AMO, through the 2024 Ontario budget preparation, advocated to the Ministry of Children, Community, and Social Services (MCCSS) to 1) increase provincial social assistance rates to adequate rates so people can pay rent and feed themselves and their families, 2) to provide base shelter amounts to unhoused people on ODSP and OW to help them get out of homelessness, 3) to increase amount of money individuals on OW can earn without impacts to monthly benefits, and 4) to increase cap on discretionary benefits administered by municipal system managers; and

WHEREAS, increasing the income of people with disabilities, and those experiencing deep poverty, supports the Council priority of Safe and Thriving Neighbourhoods (i.e. reducing chronic homelessness) and the Hamilton Community Safety and Well-being plan (i.e. housing and homelessness and access to income).

THEREFORE, BE IT RESOLVED:

- (a) That staff be directed to draft a letter to the Association of Municipalities of Ontario (AMO) requesting, at its upcoming Annual General Meeting (AGM), that it advocate to the Government of Ontario to substantially increase the rates for Ontario Disability Support Program (ODSP) and Ontario Works (OW) to lift Ontarians living with disabilities out of deep poverty; and
- (b) That a copy of this motion be sent to the Premier of Ontario (premier@ontario.ca), the Minister of Children, Community, and Social Services (MinisterMCCSS@ontario.ca), the Minister of Finance (minister.fin@ontario.ca), to the Association of Municipalities of Ontario (amo@amo.on.ca), and to the 443 municipalities of Ontario.

- (v) Establishing a minimum 25m distance from active construction sites.
