## **CITY OF HAMILTON**

### **BY-LAW NO. 24-**

#### **To Amend By-law No. 01-215 Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the *Municipal Act, 2001, S.O. 2001, c. 25*, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 9 (No Right Turn on Red) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely;

Sterling Street	Southbound	King Street West	Anytime
Stone Church Road East	Eastbound	Upper Gage Avenue	Anytime

2. Schedule 13 (Lane Designations) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

Upper Ottawa Street	30 m north of Rymal Road East	West curb lane	Anytime	Southerly to Westerly
Wentworth Street North	60 m south of Barton Street East	2 <sup>nd</sup> lane from east curb	Anytime	Northerly to Westerly

Wentworth Street North	65 m north of Barton Street East	3 <sup>rd</sup> lane from west curb	Anytime	Southerly to Easterly

3. Schedule 18 (Bicycle Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

Upper Paradise Road	Stone Church Road West to Rymal Road West	East curb lane	Anytime	Northbound
Upper Paradise Road	Stone Church Road West to Rymal Road West	West curb lane	Anytime	Southbound
Sherman Avenue South	Delaware Avenue to Dunsmure Road	East curb lane	Anytime	Northbound
Sherman Avenue South	Delaware Avenue to Dunsmure Road	West curb lane	Anytime	Southbound

4. Schedule 19 (Bike Paths) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "B" (Dundas) thereof the following items, namely:

Cootes Drive	South	Baldwin Street to Dundas Street

And by adding to Section "E" (Hamilton) thereof the following items, namely;

West 5 <sup>th</sup> Street	West	Fennell Avenue West to Claremount Access
Stone Church Road East	South	Arbour Road to Upper Red Hill Valley Parkway

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
