BY-LAW NO. 24-

To Amend By-law No. 16-335, CityHousing Hamilton Municipal Housing Project Facilities Tax Exemption By-law

WHEREAS; Council enacted a By-law that designated eligible properties owned by CityHousing Hamilton as Municipal Capital Housing Facilities, being By-law No.16-335; and

WHEREAS this By-law amends By-law No. 16-335 to include new CityHousing Hamilton developments eligible under the Municipal Housing Facilities By-law No. 16-233;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. The amendments in this By-law include any necessary grammatical, numbering, and lettering changes.
2. That By-law No. 16-335 be amended to include the changes/additions below:
 - a) Delete section 1 and replace with the following:
 1. In this By-law the following words or phrases shall have attributed to them the following meanings:
 - a. "Agreement" has the meaning ascribed to it in section 2;
 - b. "CHH" means CityHousing Hamilton Corporation;
 - c. "Premises" means the premises, or a premises described in Schedule "A" as the context requires
 - b) Delete section 2 and replace with the following:
 2. The City is authorized to enter into an agreement under section 110 of the Municipal Act, 2001 with CHH for the provision of municipal capital facilities for affordable housing at the at the Premises which meet the requirements of By-law No. 16-233. (the "Agreement").
 - c) Delete section 3 and replace with the following:
 3. The land and municipal capital facilities of the Premises shall, subject to section 3, be exempt from taxation for municipal and education purposes, commencing in the calendar year identified for the Premises in Schedule "A"

hereto and while this By law is in force and so long as the Premises are owned by CHH and used as a municipal capital facility, namely as affordable housing.

- d) Delete sections 4 to 5 and replace with the following:
4. The General Manager, Healthy and Safe Communities is delegated the authority to amend Schedule “A” to By-law No. 16-335 to add Premises that meet the criteria as set out in By-law No. 16-233 and remove Premises that do not meet the criteria as set out in By-law No. 16-233.
 5. This By-law shall apply to a Premises until any one or more of the following occurs:
 - a. CHH ceases to occupy the Premises without having assigned the Agreement to a person approved by the City in accordance with the Agreement;
 - b. CHH or its successor in law ceases to use the Premises for the purposes of affordable housing in accordance with the requirements of By-law No. 16- 233;
 - c. the Agreement is terminated for any reason whatsoever.
 6. This By-law shall not apply to any of the Premises if the Agreement is terminated for any reason whatsoever.
3. That in all other respects, By-law No. 16-335 is confirmed; and
4. That the provisions of this By-law shall become effective on the date approved by City Council.
