

The purpose of this Communication Update is to advise Council of a significant milestone for the Macassa Lodge Redevelopment project with the Ministry of Long-Term Care (LTC). Please see the Macassa Lodge Development Agreement Letter in Appendix "A" attached.

The Development Agreement has been signed and executed by Minister Natalia Kusendova-Bashta, Ministry of Long-Term Care. The redevelopment project at Macassa Lodge can now move forward with the signed commitment from the Ministry. Once the Ministry has approved the approval to construct package, the City can commence full construction of the project.

We are grateful for the Ministry's and Ontario Health's support of the City of Hamilton in executing this development agreement for these LTC beds. We are thrilled to have the 20 new beds and 44 redeveloped beds at Macassa Lodge, bringing our LTC home to 290-bed facility. We appreciate the ongoing partnership with the Ministry and Ontario Health as we work together towards completing this exciting project in 2026.

As you know, the funding and support are greatly needed, as our population grows, and the needs of seniors continue to be felt by all our health and human service providers. Hamilton is working to address the needs of highly vulnerable populations, a growing proportion who are seniors. The 44 redeveloped beds and the additional 20 new beds will be very impactful to our community.

We want to thank the Mayor and Council for its ongoing support and commitment for the redevelopment of the 44-beds and the additional 20-beds in our community. Below is a high level of what you are supporting and where we at for the Macassa Lodge Redevelopment

Design

- 65,000 square foot addition classified as the new “B-Wing” designed by Salter Pilon Architects.
- Parking lot expansion off Upper Sherman Ave.
- Landscape improvements to be made, including tree planting, benches, and walkways throughout the site.
- Renovated E-Wing dining room /lounge, and exterior patio areas.
- New connecting corridors to E and C-Wings.
- High-performance, sustainable building envelope and energy-efficient building systems.
- Light and bright interior design with durable finishes.
- Natural wood aesthetic to complement existing building.
- Increased natural light throughout common areas and resident rooms.

Existing Lodge Upgrades

- Flooring and painting upgrades are ongoing throughout the existing Lodge resident home areas.
- Flooring, painting, and furniture upgrades in the Main Lobby.
- New high-efficiency domestic water boilers.

Site Planning and Permits

- Site plan and clearances approvals have been obtained.
- Minor variance has been approved.
- Site Servicing, tree and building permits are in progress.

Project Funding

- Ministry Announced Top Up Funding - March 2024
- Council Approved Project and Funding - June 2024
