2. Proposed Permanent Closure and Sale of a Portion of Public Unassumed Alleyway Abutting 39 Grosvenor Avenue South, Hamilton (PW24052) (Ward 3) (Item 10.1)

(Nann/Hwang)

- (a) That the application of the owner of 39 Grosvenor Avenue South, Hamilton, to permanently close and purchase a portion of the unassumed alleyway abutting the south side of 39 Grosvenor Avenue South, Hamilton ("Subject Lands"), as shown on Appendix "A", attached to Report PW24052, be approved, subject to the following conditions:
 - (i) That the applicant makes an application to the Ontario Superior Court of Justice, under Section 88 of the Registry Act, for an order to permanently close the Subject Lands, if required by the City, subject to:
 - (1) The General Manager, Public Works, or designate, signing the appropriate documentation to obtain any required court order; and
 - (2) The documentation regarding any required application to the Ontario Superior Court of Justice being prepared by the applicant, to the satisfaction of the City Solicitor;
 - (ii) That the applicant be fully responsible for the deposit of a reference plan in the proper land registry office, and that said plan be prepared by an Ontario Land Surveyor, to the satisfaction of the Manager, Geomatics and Corridor Management Section, and that the applicant also deposit a reproducible copy of said plan with the Manager, Geomatics and Corridor Management Section;
 - (iii) That, subject to any required application to the Ontario Superior Court of Justice to permanently close the Subject Lands being approved:
 - (1) The City Solicitor be authorized and directed to prepare all necessary by-laws to permanently close and sell the alleyway, for enactment by Council;
 - (2) That the City Solicitor be authorized to amend and waive such terms as they consider reasonable to give effect to this authorization and direction;
 - (iv) That the Corporate Real Estate Office of the Planning and Economic Development Department be authorized and directed to enter into any requisite easement agreements, right of way agreements,

and/or other agreements deemed necessary to affect the orderly disposition of the Subject Lands and to proceed to sell the Subject Lands to the owners of 39 Grosvenor Avenue South, Hamilton, as described in Report PW24052, in accordance with the City of Hamilton Sale of Land Policy By-law 14-204;

- (v) That the City Solicitor be authorized to complete the transfer of the Subject Lands to the owners of 39 Grosvenor Avenue South, Hamilton, pursuant to an Agreement of Purchase and Sale or Offer to Purchase as negotiated by the Corporate Real Estate Office of the Planning and Economic Development Department;
- (vi) That the City Solicitor be authorized and directed to register a certified copy of the by-laws permanently closing and selling the alleyway in the proper Land Registry Office; and
- (vii) That the Public Works Department publish any required notice of the City's intention to pass the by-laws and/or permanently sell the closed alleyway pursuant to City of Hamilton Sale of Land Policy By-law 14-204.

3. Installation of Speed Cushions as a Traffic Calming Measure on Gemini Drive (Ward 14) (Item 12.1)

(Spadafora/Francis)

WHEREAS, the City of Hamilton has adopted Vision Zero approach which considers human error as part of the roadway safety equation;

WHEREAS, Ward 14 Gilkson Neighbourhood residents have advocated for traffic calming in their neighbourhood in proximity to RA Riddell Elementary School to address roadway safety concerns as a result of speeding and cut-through traffic;

WHEREAS, a public meeting was held at the Chedoke Arena on July 30, 2024 at which the Ward 14 Councillor and Transportation Division representatives attended to receive resident concerns regarding traffic safety in the Gilkson Neighbourhood; and

WHEREAS, at the July 30, 2024 public meeting residents collectively identified their strong desire for the installation of speed cushions on Gemini Drive as a traffic calming measure and to reduce instances of cut-through traffic.

THEREFORE, BE IT RESOLVED:

- (a) That the Transportation Division be authorized and directed to install up to 4 speed cushions on Gemini Drive between Upper Paradise Road and Cranbrook Drive as part of the 2024 Traffic Calming program's fall application;
- (b) That all costs associated with the installation of traffic calming measures be funded through the Ward 14 Capital Re-Investment Reserve#108064 at an upset limit, including contingency, not to exceed \$20,000; and
- (c) That the General Manager of Public Works and City Clerk be authorized and directed to execute any required agreement(s) and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor.

4. Installation of Speed Cushions as a Traffic Calming Measure on Orchard Drive (Ward 12) (Item 12.2)

(Cassar/Kroetsch)

WHEREAS, the City of Hamilton has adopted Vision Zero approach which considers human error as part of the roadway safety equation;

WHEREAS, Ward 12 residents have advocated for the installation of speed cushions on Orchard Drive to address roadway safety concerns as a result of speeding and cut-through traffic;

WHEREAS, improving road safety is a top priority for the Ward 12 office for this term of Council; and

WHEREAS, signatures were collected from residents resulting in support by 27 of 47 (53%) homes on Orchard Drive for the installation of speed cushions as a traffic calming measure.

THEREFORE, BE IT RESOLVED:

- (a) That the Transportation Division be authorized and directed to install up to 2 speed cushions on Orchard Drive between Wilson Street West and the Spring Valley Arena as part of the Transportation Division's 2024 Traffic Calming Program for fall implementation;
- (b) That all costs associated with the installation of traffic calming measures be funded from the Ward 12 CP Minor Maintenance Account (#4031911612) at an upset limit, including contingency, not to exceed \$10,000; and
- (c) That the General Manager of Public Works and City Clerk be authorized and directed to execute any required agreement(s) and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor.

5. Installation of Speed Cushions as a Traffic Calming Measure in the Mohawk Meadows Neighbourhood (Ward 12) (Item 12.3)

(Cassar/A. Wilson)

WHEREAS, the City of Hamilton has adopted Vision Zero approach which considers human error as part of the roadway safety equation;

WHEREAS, Ward 12 residents have advocated for the installation of speed cushions on Mohawk Meadows Neighbourhood to address roadway safety concerns as a result of speeding and cut-through traffic;

WHEREAS, improving road safety is a top priority for the Ward 12 office for this term of Council:

WHEREAS, signatures were collected from residents resulting in support by 6 of 10 (60%) homes on Algonquin Avenue for the installation of speed cushions as a traffic calming measure;

WHEREAS, signatures were collected from residents resulting in support by 19 of 22 (83%) homes on Tuscarora Drive for the installation of speed cushions as a traffic calming measure;

WHEREAS, signatures were collected from residents resulting in support by 23 of 33 (70%) homes on Hiawatha Boulevard for the installation of speed cushions as a traffic calming measure;

WHEREAS, signatures were collected from residents resulting in support by 16 of 23 (70%) homes on Seneca Drive for the installation of speed cushions as a traffic calming measure;

WHEREAS, signatures were collected from residents resulting in support by 7 of 9 (78%) homes on Cayuga Avenue for the installation of speed cushions as a traffic calming measure; and

WHEREAS, signatures were collected from residents resulting in support by 41 of 64 (64%) homes on Oneida Boulevard for the installation of speed cushions as a traffic calming measure.

THEREFORE, BE IT RESOLVED:

(a) That the Transportation Division be authorized and directed to install traffic calming measures on the following roadways as part of the Transportation Division's 2024 Traffic Calming Program for fall implementation:

- (i) Algonquin Avenue between Mohawk Road and Oneida Boulevard (up to 2 speed cushions);
- (ii) Tuscarora Drive between McNiven Road and Tomahawk Crescent (1 speed cushion);
- (iii) Hiawatha Boulevard between Cayuga Avenue and Algonquin Avenue (up to 2 speed cushions);
- (iv) Seneca Drive between Oneida Boulevard and Algonquin Avenue (up to 2 speed cushions);
- (vi) Cayuga Avenue between Mohawk Road and Iroquois Avenue (up to 2 speed cushions);
- (vii) Oneida Boulevard between Algonquin Avenue and Tomahawk Crescent (up to 5 speed cushions);
- (b) That all costs associated with the installation of traffic calming measures be funded from the Ward 12 CP Minor Maintenance Account (#4031911612) at an upset limit, including contingency, not to exceed \$65,000; and
- (c) That the General Manager of Public Works and City Clerk be authorized and directed to execute any required agreement(s) and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor.

6. Installation of Speed Cushions as a Traffic Calming Measure on Watercrest Drive (Ward 10) (Item 12.4)

(Beattie/Tadeson)

WHEREAS, the City of Hamilton has adopted Vision Zero approach which considers human error as part of the roadway safety equation;

WHEREAS, Ward 10 residents on Watercrest Drive have repeatedly advocated for traffic calming in their neighbourhoods to address roadway safety concerns as a result of speeding and cut-through traffic; and,

WHEREAS, signatures were collected from residents resulting in support by 10 of 18 (56%) homes on Watercrest Drive for the installation of speed cushions as a traffic calming measure.

THEREFORE, BE IT RESOLVED:

- (a) That the Transportation Division be authorized and directed to install up to 2 speed cushions on Watercrest Drive between Seabreeze Crescent and Glover Road as part of the 2024 Traffic Calming program's fall application;
- (b) That all costs associated with the installation of traffic calming measures be funded through Ward 10 CP Minor Maintenance #4031911610 at an upset limit, including contingency, not to exceed \$10,000; and
- (c) That the General Manager of Public Works and City Clerk be authorized and directed to execute any required agreement(s) and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor.

7. Biking Infrastructure Enhancement along Main Street East from Queenston Traffic Circle to Parkdale Avenue (Item 12.5)

(Hwang/M. Wilson)

WHEREAS, the existing 1200mm trunk watermain on Queenston Road from Rosewood Road to Delena Avenue needs to be moved outside of the Light Rail Transit corridor due to space constraints;

WHEREAS, Metrolinx will fund the replacement of the watermain and any associated City and third-party surface and subsurface works;

WHEREAS, the new routing of the watermain will be along Rosewood Road from Queenston Road to Main Street East and on Main Street East from Queenston Traffic Circle to Delena Avenue;

WHEREAS, the Light Rail Transit office has been working on an enhanced design for Main Street East from the Queenston Traffic Circle to Parkdale Ave that will include additional trees, bump outs, pedestrian crossings, and traffic calming enhancements;

WHEREAS, consideration has been given to increase pedestrian safety and slow down traffic on Main Street East but there is no cycling infrastructure in the new design; and

WHEREAS, the procurement is set for the upcoming fall procurement schedule.

THEREFORE, BE IT RESOLVED:

- (a) That staff put forward an enhanced design for Main Street East from Queenston Traffic Circle to Parkdale Avenue that includes cycling infrastructure on the south side of Main Street East; and
- (b) That the enhanced biking infrastructure be funded from the Ward 4 Capital Re-Investment Reserve #108054 at an upset limit, including contingency, not to exceed \$400,000.

8. Installation of Traffic Calming Measures on Dulgaren Street (Ward 6) (Item 12.6)

(Jackson/Spadafora)

WHEREAS, residents on Dulgaren Street in Ward 6 have advocated for the installation of speed cushions and an all-way stop at the intersection of Dulgaren Street and Dysan Avenue to address roadway safety concerns as a result of speeding; and

WHEREAS, signatures were collected from residents resulting in support by 16 of 18 (89%) homes on Dulgaren Street for the installation of speed cushions as a traffic calming measure.

THEREFORE, BE IT RESOLVED:

- (a) That the Transportation Division be authorized and directed to install traffic calming measures as follows:
 - (i) Up to two speed cushions on Dulgaren Street between Dysan Avenue and Eleanor Avenue as part of the 2024 Traffic Calming Program's fall application;
 - (ii) Convert the intersection of Dulgaren Street and Dysan Avenue to all-way stop controls;
- (b) That all costs associated with the installation of traffic calming measures be funded through the Ward 6 Capital Re-Investment Reserve #108056 at an upset limit, including contingency, not to exceed \$10,000; and
- (c) That the General Manager of Public Works and City Clerk be authorized and directed to execute any required agreement(s) and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor.

9. Installation of Speed Cushions as a Traffic Calming Measure on Fletcher Road (Ward 9) (Item 12.7)

(Jackson/Francis)

WHEREAS, the City of Hamilton has adopted Vision Zero approach which considers human error as part of the roadway safety equation;

WHEREAS, the Principal of Our Lady of the Assumption Catholic Elementary School on Fletcher Road in Ward 9 has advocated for the installation of speed cushions which the posted school zone to address roadway safety concerns as a result of speeding;

WHEREAS, the segment of Fletcher Road in proximity to Our Lady of the Assumption Catholic Elementary School transitions between rural and urban and that drivers need to transition their operating speeds to a lower speed when entering the urban area; and

WHEREAS, a petitioning process was not utilized because of the advocacy received from the Chair of the Hamilton-Wentworth Catholic District School Board, the Our Lady of the Assumption Catholic Elementary School Principal and that the proposed location of the speed cushions fronts the school property. This would be considered an exceptional circumstance as described in Report PW24039 Speed Cushion Process.

THEREFORE, BE IT RESOLVED:

- (a) That the Transportation Division be authorized and directed to install 2 speed cushions as a traffic calming measures on Fletcher Road between Showcase Drive and Bellagio Avenue as part of the 2024 Traffic Calming program's fall application;
- (b) That all costs associated with the installation of 2 speed cushions be funded from the CP Minor Maintenance Ward 9 Account (#4032311609) at an upset limit, including contingency, not to exceed \$10,000; and
- (c) That the General Manager of Public Works and City Clerk be authorized and directed to execute any required agreement(s) and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor.

WHEREAS, signatures were collected from residents resulting in support by 13 of 21 (62%) homes on Meadowvale Avenue for the installation of speed cushions as a traffic calming measure.

THEREFORE, BE IT RESOLVED:

- (a) That the Transportation Division be authorized and directed to install 1 speed cushion on Meadowvale Avenue as a traffic calming measure and as part of Transportation's 2024 Traffic Calming Program for fall implementation;
- (b) That all costs associated with the installation of traffic calming measures be funded through the Ward 5 Capital Re-Investment Reserve #108055 at an upset limit, including contingency, not to exceed \$5,000; and

11. Installation of Speed Cushions as a Traffic Calming Measure on Various Streets (Ward 1) (Item 12.9)

(M. Wilson/Hwang)

WHEREAS, the City of Hamilton has adopted Vision Zero approach which considers human error as part of the roadway safety equation,

WHEREAS, roads adjacent to parks and schools frequently see the greatest number of young pedestrians and cyclists at risk by speeding motorists;

WHEREAS, Ward 1 residents have repeatedly advocated for the installation of speed cushions on various roadways throughout their neighbourhoods to address roadway safety concerns as a result of speeding and cut-through traffic; and

WHEREAS, a petitioning process was not utilized as the Ward 1 office has discussed the provision of speed cushions on the noted roadways and sought neighbourhood support by alternative means.

THEREFORE, BE IT RESOLVED:

- (a) That the Transportation Division be authorized and directed to install traffic calming measures on the following roadways as part of the 2024 Traffic Calming program's fall application, as follows:
 - (i) Napier Street between Locke Street North and Queen Street North (up to 3 speed cushions);
 - (ii) Melbourne Street between Dundurn Street South and Locke Street South (up to 2 speed cushions);

- (iii) Hill Street between Dundurn Street North and Poulette Street (up to 3 speed cushions);
