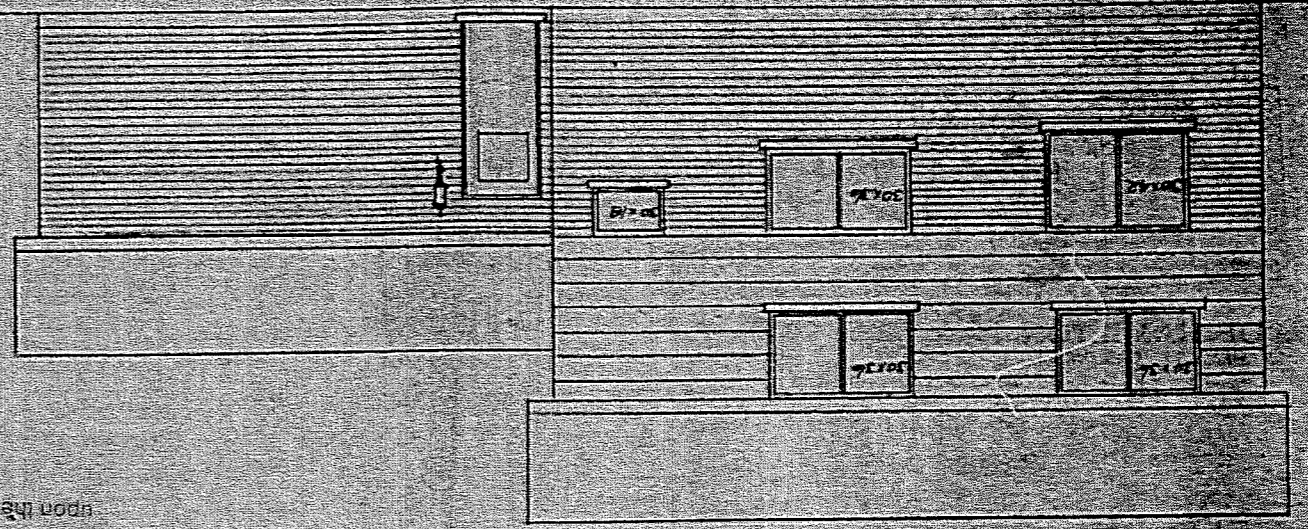
FRONT ELEVATION

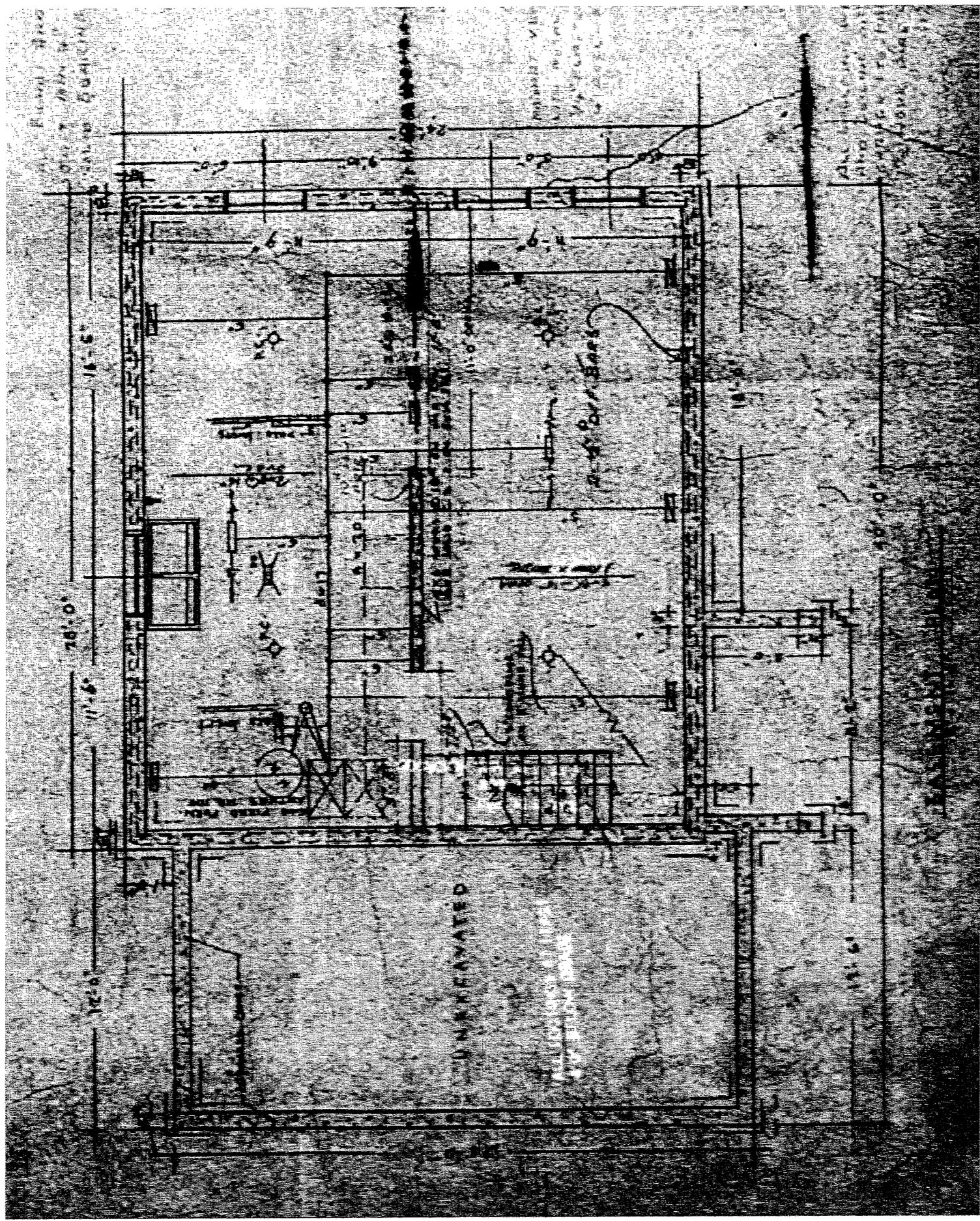


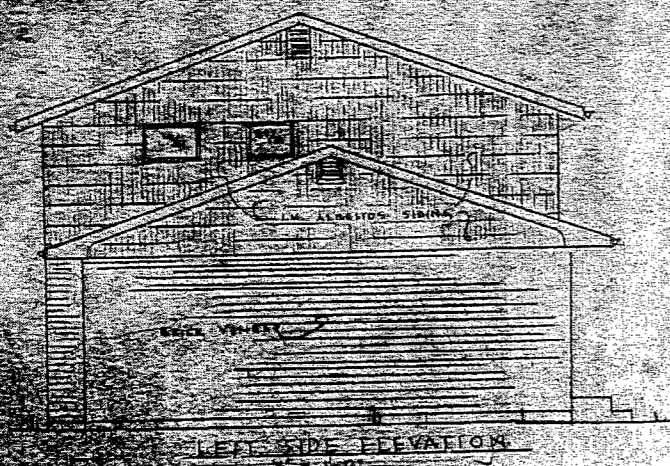
SECOND FLOOR PLAN



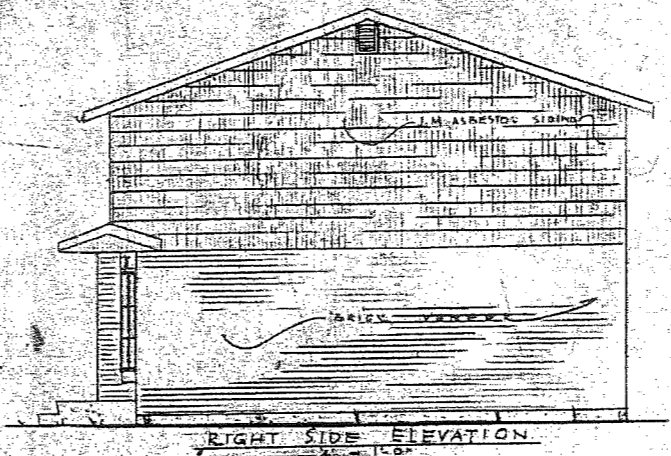

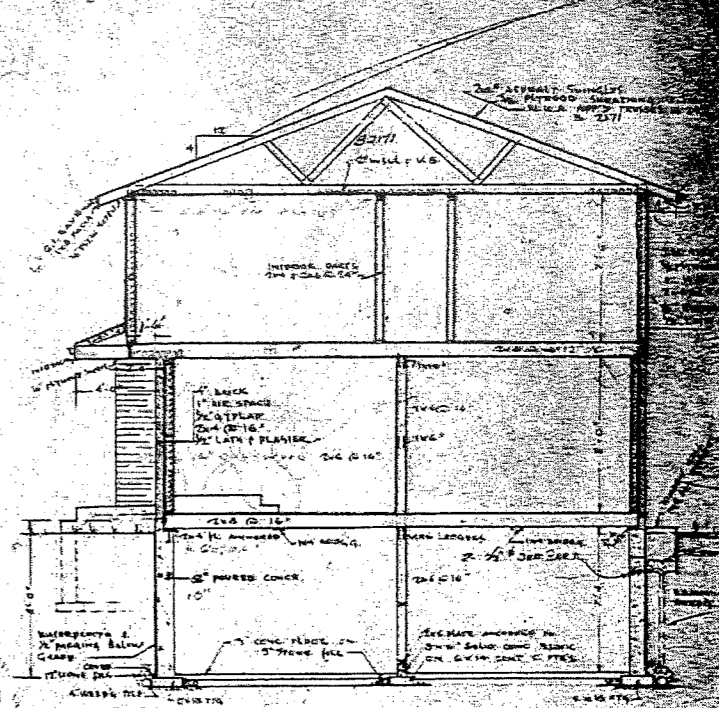
RIGHT SIDE ELEVATION



REAR ELEVATION

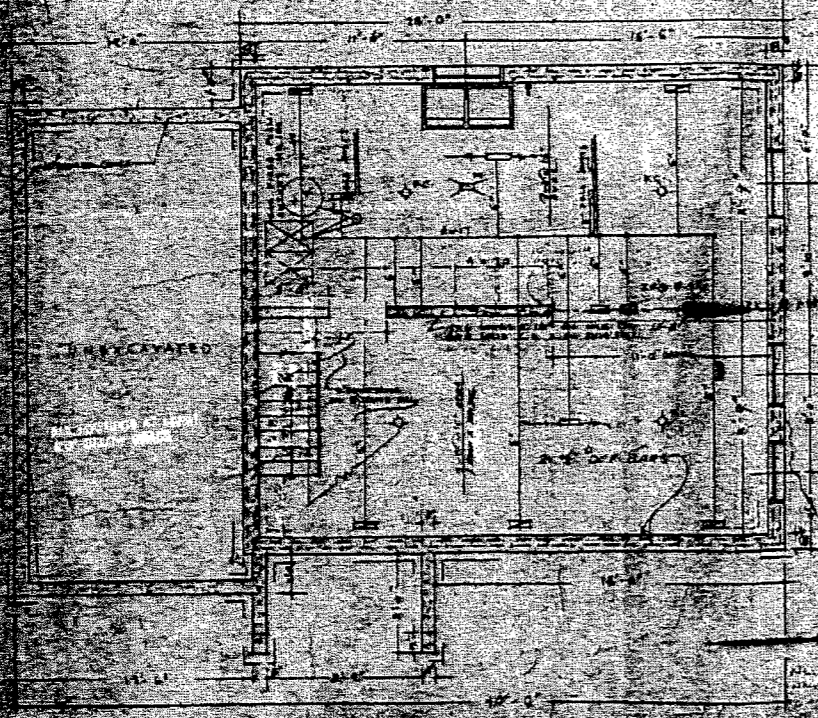


FRONT ELEVATION

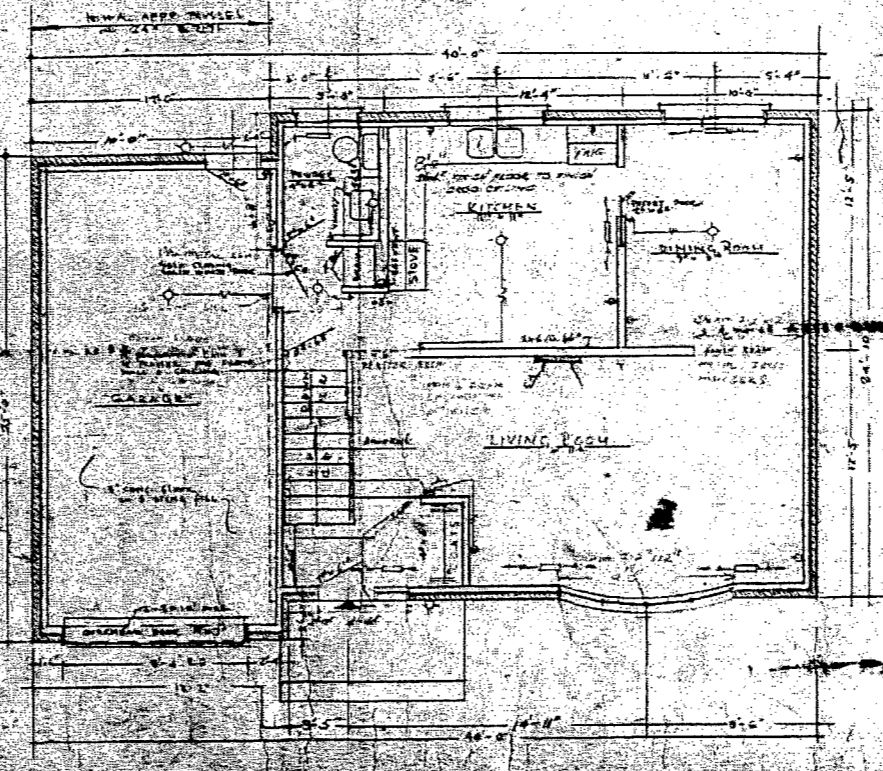

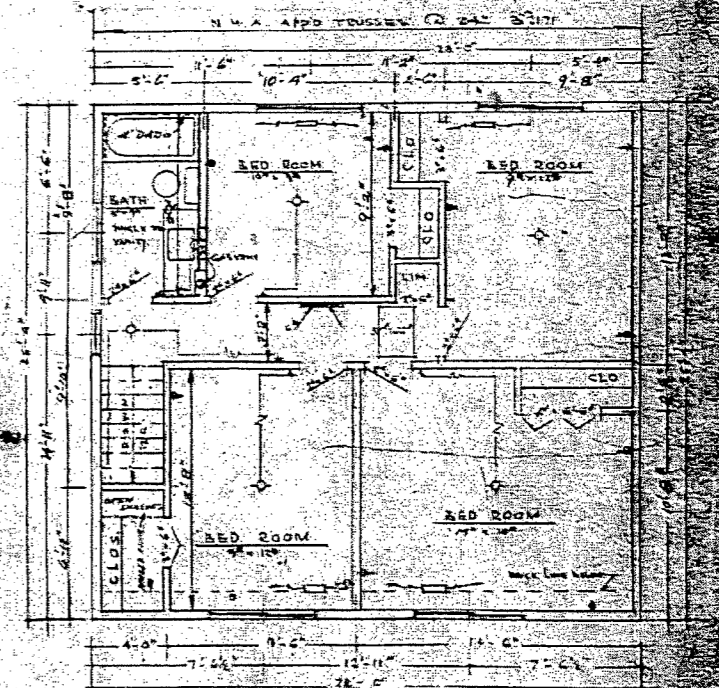
