Writing to you from a snowy Ward 7 about two-storey additional dwelling units. My purpose in writing is to express my surprise and dismay that what I thought had been decided on and begun to be implemented seems suddenly to be in question? I thought the Council's decision to allow this innovative form of gentle density intensification had been unanimous?

I would hope that the normal kinds of checks and balances of the building permit approval process will ensure that two-storey ADU's get built in suitable locations that fulfill urgent housing needs while enhancing neighbourhoods.

I also hope that the discussions you will have around the horseshoe at the GIC will reassure the mover of the motion that Council made the right decision in approving these family and neighbourhood friendly additional dwellings.

Hamiltonians support a firm urban boundary, and we need to hear that determination firmly reaffirmed by our municipally elected representatives in response to this unexpected motion to reconsider your earlier sound and forward-thinking decision.
