Dear Mayor, Members of Council, Charlie Toman, Melanie Pham, Neil Stoop, Anita Fabac, Board Members of Habitat for Humanity,

First, I would like to extend a HUGE thank you to the members of the Planning and Economic Development Department who authored this excellent document. Congratulations on a job well done, as you carefully and professionally crafted a meticulous defense for the opposition of the MZO request submitted by the Upper West Side Landowners Group (UPWSLG).

Not only does the requested MZO translate to an urban boundary expansion of approximately 90 hectares but it also requests conversion of approximately 99 hectares of employment lands within the Airport Employment Growth District (AEGD) Secondary Plan to residential and other uses, thereby limiting future employment. As you are all aware, Hamilton has maintained its firm Urban Boundary and this expansion request conflicts with citizens' expectations, i.e. NO expansion.

The applicant also has multiple applications under appeal at the OLT. Note: the MZO differs from what is proposed through these applications. The MZO and applications request amendments to almost every Plan which the City has developed and changes to zoning bylaws. They seem to present no respect for the rules of good planning, good governance, and adherence to an overarching vision. Their applications and MZO request present discrepancies and conflicts which make it difficult for Planning to decipher what they actually want and if the MZO is approved, implementing it will be problematic because it sloppy and poorly done.

3 Examples:

- 1. Quote from page 12. "Residential land uses within the Secondary Plan predominantly medium density with 7,463 total dwellings, whereas the MZO is predominately low density with approximately 5,000 total dwellings." Very confusing. Is it 7,463 or 5,000?
- 2. On page 14, more confusion is found. The Submission says the MZO would result in 370,000 470,000 square metres of employment space while staff estimate the lands within the proposed MZO include only 139,700 square metres of land designated for employment use. No zoning is proposed for these lands which indicates it may be a mapping error. Who knows?
- 3. Within the document, there are several references to Habitat for Humanity, a long-established and respected charitable organization. The applicant has stated that up to 10% of the total dwelling units (up to 500 units) would be affordable, in accordance with a signed Memorandum of Understanding (MOU). However, there is no mechanism in place within the MZO to ensure these affordable dwellings will be delivered. There is supposed to be an accompanying agreement, prepared by UWSLG, to be signed by the City and UWSLG in exchange for the City's support. However, no agreement was included in the submission. Moreover, a copy of the MOU between UWSLG and Habitat for Humanity, offering first right of refusal to purchase a minimum of 100 units has not been provided.

The list of discrepancies, poor project management, conflicting information, lack of consultation with Indigenous groups, demonstrated by the Group is long and the Planners have done a thorough job of listing them. Please say NO to this request for expansion. It has become even more important today, in light of Trump's tariffs, that we conserve every acre of farmland possible to ensure food security in the face of an economic trade war.

As a Hamilton taxpayer, I object to paying for the cost of infrastructure to support this housing development because it requires new roads, at a cost of \$10M per kilometer for multimodal paths which meet the standards of Hamilton's Master Transportation Plan and 5,000 residences will require access to water, sewer, wastewater treatment etc. Connection to the Grand Trunk sewer line alone is an estimated \$500M.

My last comment, and I don't know if it is within your purview, but the UWSLG should be charged a very large fee for constantly wasting the time and resources of the City Planners and Council. Their half-baked applications have been ongoing since at least 2020. How many hours have been consumed by their frivolous 'nuisance' applications? In addition to a hefty fee, a punitive fine should be levied (to discourage them from repeating similar mistakes) and all future applications should be put on hold for the next? of years (Is 2 years a good number?).

Dear Planning Committee Members,

I have been heartened to see the City doing everything in its power to respect the firm urban boundary decision City Council made a while back with overwhelming public support. So it's frustrating beyond words to find land speculation persisting in our area. What a waste of your valuable time, as it is of staff and citizen time!

So here I am writing to urge you to hold the line and reject the MZO for forced expansion of Hamilton's urban boundary by the Upper West Side Builders group onto 200 acres of Hamilton's prime farmland, wetlands, water courses, woodlots and meadows. As you know, your thorough and sensible staff report recommends that you not approve this MZO request. What a bind the Province has put you in that you even have to process such a patently inappropriate UBE request!

This case is particularly troubling because these UWS builders have gotten Habitat for Humanity onside. I have donated to this fine charity in the past, and am curious to know how this partnership (if it is one) developed.

It's puzzling that Habitat for Humanity is involved in this MZO approval request at all. It would seem much more suitable for H4H builds to be well within the urban boundary so that families settling into a Habitat home would have transit and other amenities nearby. The UWS development site would definitely require frequent use of a family car.

I do know, however, that the developers in this MZO request have misrepresented or misunderstood the nature of the land on which they wished to build, and this inaccurate framing of it as "not prime farmland" may have made it easier to get Habitat for Humanity involved.

Your staff report confirms that all the farmland in the threatened parcel is actually deemed prime. The staff report also points out that the biodiversity field studies submitted by the developers are out of date and don't conform to the City's requirement that they be no more than five years old. As you know, this is a critical time for all the farm, wood, and wetland species in our part of Ontario, especially

for those already at risk. It's been shown over and over that humans who respect the need to protect biodiversity end up ensuring their own wellbeing.

Thank you for reading my letter! If there's any way (beyond refusing them) for the City of Hamilton to stop these frivolous requests in their tracks and to discourage others from even being suggested, that would save the City's already stretched resources. With so many low-to-moderate income Hamiltonians struggling to find adequate shelter, it's unconscionable that rich developers such as UWS should waste staff and councillors' time and public money attempting to make good on their private land speculation. If you can slap a fine on them as a deterrent, please do!

Dear members of Hamilton City Council

I am writing to urge all members of council to reject the MZO to expand Hamilton's urban boundary into farmlands in the upper west side area. This proposal is a land grab that is inappropriate in many ways.

- 1. The citizens of Hamilton have soundly rejected expansion of the urban boundary and the inevitable increased costs to taxpayers to support the resultant sprawl. Council has already rejected the efforts of the UWS group to override the will of the people and Council.
- 2. The farmland in the proposed expansion is, indeed, prime agricultural land, while the woodlands and wetlands are essential to the maintenance and increase of biodiversity in our area, which is of national significance, and to stormwater and ground water management.
- 3. In a time of economic uncertainty, with the United States initiating a trade war against Canada, we are once again confronted with the need to be more self-sufficient, especially when it comes to food production. While the UWS group has argued in the past that the properties in question are too small for profitable farming, we actually need more intensive truck farming that can provide essential fresh and stored produce for our existing urban population. Areas of Ancaster and Glancaster have traditionally supported that form of agriculture.
- 4. In a world where our climate is changing and posing new and worsening meteorological threats, we need to be working toward net zero release of greenhouse gases. Sprawling onto farmland will only increase single car commuting, exacerbate traffic congestion, and leave more residents without a public transportation option. In-fill development is the only sensible housing strategy.

Our friends and colleagues in conservation, Save Our Streams Hamilton, were in touch regarding their concerns about the proposed Minister's Zoning Order (MZO) for Upper West Side Lands. Having read the information supplied and available online, we share their concerns.

I am writing on behalf of Think Turtle Conservation Initiative to strongly oppose the request for a Minister's Zoning Order (MZO) that would force an expansion of Hamilton's urban boundary onto hundreds of acres of prime farmland, wetlands, watercourses, woodlots, and meadows. This proposal is deeply flawed, environmentally destructive, and financially irresponsible.

The land speculators behind this request made a calculated investment in these lands, knowing they lay outside the firm urban boundary. Now, they seek to override carefully considered planning policies for their financial gain at the expense of Hamilton's natural heritage and taxpayers. The potential loss of our natural heritage is a regret we cannot afford.

Expanding onto this land would destroy critical ecosystems at a time when protecting wetlands, streams, and biodiversity should be a priority. Field studies assessing species at risk and natural habitat are outdated and fail to meet the city's requirement that they be no older than five years. We cannot afford to make irreversible decisions based on incomplete or inadequate data.

Additionally, the 2023 Subwatershed Study and Stormwater Master Plan, provided in support of this expansion, was not conducted under an approved Terms of Reference and appears to be missing key components. Proper hydrological assessments are essential before considering any development, yet the information presented does not meet basic planning standards.

Hamilton's Planning Staff have confirmed that all proposed expansion lands are prime farmland—some of the best in the country. Ontario is already losing farmland alarmingly, and this expansion would accelerate that loss. These lands should be preserved for food production and climate resilience, not paved over for speculative development.

Beyond the environmental cost, this proposal would deepen Hamilton's financial deficit. The city is already struggling with a \$3.8 billion shortfall in funding and infrastructure maintenance. Adding more roads, water mains, and services to newly developed farmland will significantly increase this burden, making the decision even more weighty for taxpayers.

The developers claim to have a memorandum of understanding with Habitat for Humanity to build a mere 2% of affordable housing, yet no documentation has been provided to confirm this. This vague and unverified promise does not justify overriding Hamilton's responsible growth strategy.

This is now the third attempt by Upper West Side landowners to force an expansion of Hamilton's urban boundary. Each attempt wastes valuable time and resources of city planning staff, diverting attention from policies that support sustainable, responsible growth within the existing boundary.

It is also deeply concerning that staff have deemed Indigenous consultation insufficient. Any significant land use change must include meaningful engagement with Indigenous communities, ensuring their voices and concerns are heard and respected. This is not just a matter of policy but of ethical and legal responsibility.

This MZO directly conflicts with Hamilton City Council's firm urban boundary growth strategy, which is embedded in the Urban Hamilton Official Plan. The city is actively implementing policy and zoning changes, incentives, and process improvements to accommodate housing needs within the existing boundary. There is no justification for circumventing this comprehensive and thoughtful approach.

Hamilton's Planning Staff have already recommended that councilors reject this MZO, and I urge you to uphold that recommendation. The February 4, 2025, Planning Committee agenda outlines numerous reasons why this request should be denied. Allowing this MZO to proceed would set a dangerous precedent, undermining local decision-making and responsible urban planning.

Expanding the urban boundary onto these lands would be a reckless and irreversible mistake at a time when climate action and environmental protection must be priorities. These wetlands, watercourses, and meadows provide habitat for at-risk species. Once they are lost, they are lost forever.

I urge you to reject this MZO and support Hamilton's firm urban boundary. Protecting farmland, ecosystems, and financial sustainability is the right choice—for today and future generations.

To whom it may concern,

I am NOT supportive of the proposed Zoning By-law Amendment to change the zoning from Townhouse-Maisonette to Multiple Dwelling. While I am in favour of intensifying density and development within Hamilton's current city limits rather than development outside our city's urban boundaries in principle, the urban intensification must be done in a smart way and this proposal does not adequately service the number of units proposed.

The proposal would seek to add 105 affordable dwelling units to 525 Stone Church Road East, while only adding 22 parking spaces for those new residents to use within the building footprint, with an additional 30 parking spaces for new residents, existing residents and visitors to use. The current proposal seems to imply 52 parking spaces to service 105 units is enough - this is ignorance.

Fifty-two parking spaces to service 105 units is NOT adequate and the consequence of not providing adequate parking will have an impact on the surrounding neighbourhood. The adjacent streets of Southpark Ave., Rushdale Dr. and Redmond Dr. are regularly parking up on both sides of the street creating impairments to travel, dangerous conditions for road safety with people parking too close to corners and stop signs, and an overall annoyance to our neighbourhood. This is true, specifically along Redmond Dr., off of which is the only entrance into 525 Stone Church Rd. exist. The street parking concerns/issues are likely to increase if the proposal is permitted to move forward in its current state.

The proposal needs to be modified to either reduce the number of units to be closer match with the parking provided or increase the number of parking spaces within the existing footprint. And I explicitly say "within the existing footprint" because the 30 additional parking spaces proposed outside the new building footprint are proposed on top of what is currently grass and some trees and I see no compensation for vegetation removed on the plan. There is no compensation depicted on the plan to replace the trees that are going to be lost as a result of this development. Greenscapes and vegetation buffer extreme weather events and help with heating and cooling costs of structures. I would not like to live in a concrete city.

I can see an argument being made to encourage residents to use public transit as the Stone Church Bus Route and the Mountain Bus Hub of Lime Ridge Mall are both located close to the proposed development, as justification for not providing more parking. I can also see justification for the number of parking spots is supported by the City's Parking Rate Area strategy and complies with the Minimum Required Parking Rate Schedule. But in reality Hamilton is a car centric city and the basic structure to move around the city is built around personal vehicles. So until the City builds a trusted, efficient and reliable public transit system, most people are going to have personal cars and you need to provide parking spaces to accommodate them so people are not parking on the street.

Good morning Natasha,

I hope you are having a lovely weekend, and more importantly staying safe and healthy. Seems to be a nasty cold / flu virus going around the last few weeks, hopefully you have managed to steer clear of it.

As part of the Upper West Side Landowner group ongoing commitment to public engagement and dialogue, I would be happy to arrange a meeting with yourself and anyone else that wishes to attend to discuss some of your points or concerns below. My cell number is in my signature line.

With respect to your email below, I have the following to offer at a high level, and as food for thought:

- I agree with you prime farmland should be preserved. Unfortunately, the lands in question here are not prime farmland. Half of the lands have already been developed at some point in time with a golf course, and others have not operated or cannot operate as prime farmland due to their poor soil conditions. Unlike the other growth areas the Upper West Side lands are the only swath of land not identified as prime-agricultural by both existing City mapping, and provincial mapping (OMAFRA). Note, these lands are also NOT "Greenbelt". I'll speak to future planning and roadways below.
- With respect to "urban" I would be happy to speak to you about the history of these lands, but in 2010 the lands were located within the Urban Boundary. They were removed by a mutual agreement/settlement in 2015 between the landowners and City, and agreed the lands were not to be Employment land so to protect the residential land uses on the north side of the street from incompatible uses, and would be considered for residential development at a later date. They were placed into a "rural" designation for the time being not prime agricultural, as a placeholder of sorts for later development. Note that only two holes within the existing urban fabric were designated as rural all of the lands around each of these parcels is already designated "urban", and depending on the land uses could proceed to develop in the very near future.

- With respect tariffs ongoing threat of tariffs and uncertainty on their implementation is scary for all industries being impacted. On the housing front, it runs the risk of making materials even more expensive than they already are. Keeping that in mind, and if that does impact all types of housing, the very housing that the City, and yourself, have identified as being necessary will become that much more unaffordable. Projects like high-rise buildings, or mid-rise buildings rely on substantially more materials than a house, townhouse, or walk-up apartment. That housing form, being high intensity - high rise development, has already become non-existent in today's marketplace - the cost of construction, without tariffs, makes it very challenging to construct and sell. In addition, those projects can take anywhere from 4 - 7 years to deliver on average, meaning hundreds if not thousands of homebuyers will be waiting years before they can call one of those units "home" in Hamilton. In addition, the revenue that would otherwise come from those buildings for the City, would take years to realise - potentially leaving the City in a vulnerable financial position that could run the risk of having to increase taxes on existing residents - or, most recently, a proposition of land transfer tax, which would make purchasing a home in Hamilton more expensive. Lastly, the vision for full build out of this community is one of multiple components, including several housing types, commercial/retail uses, employment uses, park spaces, and preservation of natural heritage spaces. It is intended to be a truly 15min community with community amenities at the fingertips reducing the need for vehicular ownership. I'll speak to transit below.
- With respect to Transit you are correct, Hamilton Transit has not necessarily planned their routes for this area, yet. However, I would point you to the Transportation Master Plan for this year which was approved by City Council. I've attached an excerpt for your reference here you will notice that the Garth Street extension from Twenty Road to Dickenson Road in blue, as well as several east/west collector roads, and surprisingly, two yellow north-south roads running through "holes" in the urban fabric. When these roads are closer to implementation, you can rest assured that Hamilton Transit will be involved and make the necessary arrangements to plan for routes, stops, and infrastructure. This would occur during the detailed design and engineering phase of their respective implementation. The fact that the transportation master plan has been approved, and those projects identified as capital projects in the City's DC Background Study, lays further cement on the direction of this particular area.
- With respect to Habitat Hamilton. I'd like to share the origin story of their involvement. It started on a sunny day when myself and other Cachet representatives were volunteering at one of Habitat's builds. On a break, I found myself interested and engaged in a discussion with Donna, their procurement officer. My main objective was to understand how the organization comes into their land and finances and builds their project. I learned quickly that Habitat is no different than other real estate entities, in that they have to source and purchase land, and then find ways to make their projects affordable. They do that through volunteer work which unfortunately, means that building a few townhouses can take years. With that in mind, I had

several meetings with the CEO, Sean Ferris, over coffee, formal meetings at our offices, virtual meetings, and the final outcome was a documented and signed Memorandum of Understanding between Habitat Hamilton and the Upper Westside Landowner Group. Note that each and every landowner in the group agreed to this despite the loss it may result in on their spreadsheets. Included in that MOU are basic terms, but the one of the most important, is a model that the owners and Habitat would implement where the landowners are the ones constructing the homes at our cost, and put into the Habitat program. That means that a Habitat home would be delivered in only a few months, as opposed to taking years. A direct benefit to the affordability component of City and community building, as well as to Habitat as a whole. In addition, the 2% that you mention was guaranteed to Habitat, equalling approximately 100 units - they would also be entitled to first right on the balance of the 500 units, which could represent up to 10% of the total units proposed (500 units). Ultimately, what is being portrayed as a hoax for the MZO request, started with genuine concern and discussions for Habitat, and a vision of what could be achieved when private, non-profit, and a City come together, all for the betterment of Hamilton.

I apologize for the long email on a Sunday. I am happy to arrange a meeting with yourself and any other attendees to discuss in more detail.

Thank you for your engagement and passion toward the City of Hamilton. While we may not always agree, having difficult discussions is what leads to positive solutions for the City.



Candidate Area (Lesser Quality Agricultural Lands)


Specialty Crop Area
