Naming Rights for the Mohawk 4Ice Centre (Ward 6)**

That Report HSC2005, dated January 27, 2025, respecting Naming Rights for the Mohawk 4Ice Centre (Ward 6), be received and the following recommendations be approved:

WHEREAS, 499 Beach Blvd, is city-owned property which has been designated a park, located in the Beach Community, Hamilton;

WHEREAS, Jim Howlett was a well-known, universally respected Hamiltonian and long-time beach resident with decades of community involvement, environmental activism and contributions to the beach community, which greatly increased the quality of life of its residents;

WHEREAS, on September 12, 2023 the Hamilton Beach Community Council unanimously endorsed recognizing 499 Beach Boulevard as Jim Howlett Park; and

WHEREAS, the family of Jim Howlett approves of the naming of 499 Beach Boulevard to become Jim Howlett Park.

THEREFORE, BE IT RESOLVED:

- (a) That 499 Beach Boulevard be officially recognized as Jim Howlett Park; and
- (b) That the General Manager, Public Works or designate be authorized and directed to approve and execute any and all required agreements and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor, related to the naming and creation of a Park at 499 Beach Boulevard, Hamilton.

9.2 20 Lake Ave South, Hamilton (Ward 5)

(Francis/Jackson)

WHEREAS, 20 Lake Avenue South is City-owned property which has been designated a park and was purchased by the City of Hamilton in 2021 from the HWDSB;

WHEREAS, R.L. Hyslop joined S.S. # 3 Stoney Creek as the principal in January 1918 and served as the principal until 1958 for 40 years, before passing away in 1960;

WHEREAS, the original elementary school that stood on these grounds by the name of S.S. #3 Stoney Creek was renamed in honour of R.L. (Robert Lloyd) Hyslop in 1958 after his retirement;

WHEREAS, R.L. (Robert Lloyd) Hyslop elementary school permanently closed in 2021 and demolished in 2023;

WHEREAS, R.L. Hyslop is historically revered for his community work in Stoney Creek;

WHEREAS, The Stoney Creek Historical Society endorses maintaining the name of R.L. Hyslop for the new park that is to be built in 2026; and

WHEREAS, park signage will be part of the overall park construction project and can reflect a new name on a sign installed at that time.

THEREFORE, BE IT RESOLVED:

- (a) That 20 Lake Avenue South, Stoney Creek, be officially recognized as R.L. Hyslop Park; and
- (b) That the General Manager, Public Works or designate be authorized and directed to approve and execute any and all required agreements and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor, related to the naming of the future park at 20 Lake Avenue South, Hamilton.
