A Paradigm Shift in Income Security

Working with Tracy Smith-Carrier Ph.D., M.S.W., OCT, RSW, Professor & Canada Research Chair (Tier 2) in Advancing the UN Sustainable Development Goals.

The project explores what can be done with two principles:

- 1. The notion of "stackable benefits", where all income is exempt and maximized to a given level such as the poverty line in Canada.
- 2. It utilizes existing benefits and programs so there is no increase in overhead to deliver the funding.
