1. Declaration of Dividend on Common Shares (Item 5.1)

**WHEREAS** the City of Hamilton is the sole shareholder of the Corporation (the "Sole Shareholder");

**AND WHEREAS** it is desirable to declare a dividend of Twelve Million Nine Hundred Sixty-Nine Thousand Three Hundred and Ten Dollars (CDN \$12,969,310) on all of the outstanding Common Shares of the Corporation;

**AND WHEREAS** the Corporation is not now, and would not become after payment of the aforementioned dividend, unable to pay its liabilities as they become due and the realizable value of the Corporation's assets would not, after payment of the aforementioned dividend, be less than the aggregate of the Corporation's liabilities and the Corporation's stated capital of all classes;

**NOW THEREFORE** the Council of the City of Hamilton, acting in its capacity as representative of the Sole Shareholder, RESOLVES AS FOLLOWS:

#### **DECLARATION OF DIVIDEND ON COMMON SHARES**

#### **BE IT RESOLVED:**

- (i) That the Sole Shareholder hereby approves the declaration of a dividend of Twelve Million Nine Hundred Sixty-Nine Thousand Three Hundred and Ten Dollars (CDN \$12,969,310) on all of the outstanding Common Shares of the Corporation to be payable on December 12, 2024 to the holder of record of all of the outstanding Common Shares of the Corporation as at the close of business of the Corporation on the 11<sup>th</sup> day of December, 2024; and
- (ii) that the Sole Shareholder approves the preparation of all necessary documents and/or agreements to give effect to the foregoing and the President of the Corporation (or their designate) is hereby authorized and directed to execute, on behalf of the Corporation, all such necessary documents and/or agreements or to take any action deemed necessary in respect of any of the foregoing.

**THE FOREGOING RESOLUTIONS** are hereby consented to by the Sole Shareholder of the Corporation pursuant to the provision of the *Business Corporation Act* (Ontario).
