Subject: 56 St. Matthews Avenue, Hamilton – Development Charges Payable

On December 6, 2024, development charges (DCs) for 56 St. Matthews Avenue, permit number 24T-3225 were paid. However, it has come to our attention that Building staff billed based on an outdated estimate in error. Therefore, a top up payment for DCs of \$36,579 is payable as calculated at the building permit issuance date, January 8, 2025. Please see below for a breakdown of the DC balance payable:

The reason for the increase is that the City's transition policy to honour the DC rates at the date of permit application expired November 30, 2024 for this application, therefore the increase is the result of bringing the DCs payable up to the current rate at the time of permit issuance, January 8, 2025. Section 55 of the City of Hamilton Development Charges By-Law, 2024 requires that additional payment of DCs shall be made where there has been an error.

Payment of the outstanding DCs payable must be made within 60 days of this letter. If payment is not received within 60 days then the DCs payable will be transferred to the property tax roll in accordance with Section 32 of the *Development Charges Act, 1997*.
