RECOMMENDATION

- (a) That the Arts Advisory Commission's 2011 Volunteer Committee's base Budget Submission in the amount of \$9,000, attached as Appendix A to Report CS11008, be approved.
- (b) That, in addition to the base funding, that a one time funding from the Arts Advisory Commission reserve, in the amount of \$5,000, be approved .

EXECUTIVE SUMMARY

The 2011 budget request will enable the Arts Advisory Commission to fulfil its mandate, and is in keeping with previous years' requests. The one time request of \$5,000 for the development of a website was initially approved by Council in 2010. The website is in development, but the funds have not yet been spent, and so this Report requests approval to spend those funds in 2011.

Alternatives for Consideration – Not Applicable.

FINANCIAL / STAFFING / LEGAL IMPLICATIONS

Financial: For 2011, the Arts Advisory Commission has requested a base budget of \$9,000. The 2010 base budget was \$9,000. The one time request of \$5,000 from the Arts Advisory Commission reserve fund can be accommodated, as the balance of the reserve at the end of 2010 was \$12,309.72.

Staffing: There are no staffing implications associated with the recommendation of Report CS11008.

Legal: There are no legal implications associated with the recommendation of Report CS11008.

HISTORICAL BACKGROUND

The mandate of the Arts Advisory Commission is:

- To recommend activities for the stabilization and strengthening of the arts community
- > To inform Council of issues and achievements in the Hamilton arts community
- To liaise with and act as a point of contact for members of the arts community regarding issues affecting the arts community
- > To monitor and assist with the implementation of the Public Art Program
- > To monitor and assist with the implementation of the Arts Awards Program
- To monitor and assist with the implementation of the Community Partnership Program, Culture Stream

In 2009 and 2010, the Arts Advisory Commission undertook significant consultation with the arts community, the results of which were presented to Council in April 2010 and summarized in the Executive Summary of the consultation, which is attached as Appendix B to Report CS11008. At that time, Council authorized the Arts Advisory Commission to spend up to \$5,000 from its reserve fund to develop a website to facilitate communication and collaboration within the arts community, which is currently in development. Because these funds were not spent in 2010, this Report asking Council to again authorize the expenditure from the Arts Advisory Commission's reserve account for 2011.

POLICY IMPLICATIONS

There are no policy implications associated with the recommendation of Report CS11008.

RELEVANT CONSULTATION

In preparation of Report CS11008, Culture Division staff consulted with the Arts Advisory Commission, which approved the appended 2011 budget and workplan at its October 2010 meeting. Staff also consulted with the Finance and Corporate Services Department – Finance and Administration Section, by providing the total amount of the requested 2011 budget.

ANALYSIS / RATIONALE FOR RECOMMENDATION

The 2011 workplan that is attached as Appendix C to Report CS11008 responds to both the ongoing mandate of the Arts Advisory Commission and the feedback received from the arts community during the 2009 and 2010 consultations.

A primary focus for the Arts Advisory Commission in 2011 will be the formulation of recommendations for the development and implementation of a sustainable and appropriate funding model and funding amounts for artists and not for profit arts and culture organizations. These recommendations will be submitted as part of the Council-mandated review of the Community Partnership Program in 2011.

EXECUTIVE SUMMARY

In November 2009 The Arts Advisory Commission (AAC) to the City of Hamilton hosted a day-long event that brought members of the diverse arts community together to learn and plan around the local arts scene. Nearly 80 participants representing a range of art practices engaged in small group discussions that were to shape the future work of the AAC. The following is a summary of the report. BACKGROUND ABOUT THE AAC

The AAC is a volunteer committee appointed by Hamilton City Council and is comprised of a diverse range of stakeholders in the Hamilton community. It has been in existence for 15 years and has support from the City's Culture Division staff for its activities.

The group has many functions, including:

- Informing Council of achievements and issues in the local arts community;
- Selecting and recommending winners of the annual Hamilton Arts Awards;
- Monitoring and assisting with the implementation of the Public Art Programme;
- Revising the "Policy for the Arts" annually;
- Recommending educational and promotional activities for the stabilization and strengthening of the arts community.

THE BIG PICTURE REVISITED

Over the past 5 years, a surge of creative activity and emergence of new artists, arts organizations, networks, and forms of artistic expression in the local arts community has taken place. There has been an increase in the focus of the arts as a key economic sector, both through market driven conversations, and the burgeoning quantity and quality of arts produced and the audience it has been attracting to the City. The AAC determined that it needed be kept apprised of current local conversations and to hear from key stakeholders about opportunities and challenges in moving a healthy arts community forward. The resulting forum in November 2009 was captured in a report "The Big Picture Revisited" published in February 2010. Three themes were

highlighted at the forum both through presentations and focus groups:

- Support for Individual Artists
- Engaging City Hall
- Sustainability of Arts Organizations

PRIORITIES IDENTIFIED BY FORUM PARTICIPANTS

Support for individual artists:

- educate City Hall about the importance of arts and diversity of art making practices (each legitimate and important)
- facilitate open communication between the arts community and the City of Hamilton, the AAC and its work
- develop and communicate opportunities for artists in terms of professional and human resource development, potential funding, and projects
- strategize ways to connect to the growing 'support local' movement by encouraging City Hall to give local arts as gifts, having a presence at Eat Local events, etc.
- advocate for artists to be financially supported and have access to health care, legal aid, and business development support
- inform a funding strategy that is equitable across sectors, including individual grants and support housing for artists
- focus on an education strategy that includes a better understanding of the arts in the local community and making the arts part of school curricula
- provide a collective voice to artists with a strong local presence and focus on artists as voters

- advance the marketing, promotion, and publicity of the local arts scene with a stronger connection to the media, developing an open-concept gallery at the new City Hall and including the arts in major civic activities
- build on the current change in atmosphere and culture (a growing momentum around dialogue and collaboration) and explore and identify possibilities for capacity building
- proactively promote and enable artistic endeavours for artists to sell work, develop promotional spaces, and provide legal spaces for posters
- advocate for transparency and clarity in zoning, tax incentives, and financial incentives for underused buildings
- promote initiatives that support artists in the community through a cultural enablement plan, mentorship opportunities, and strategic partnerships

Engaging City Hall:

One of the themes of the Big Picture in November 2009 was identifying ways that the community and the City of Hamilton could better work together to find solutions to support artists and arts organizations development. Recommendations included:

- explore models of arms-length arts councils that can provide funding and advocacy for local artists
- advocate for an increase in the municipal arts budget
- keep apprised of opportunities on which to capitalize to ensure the inclusion of the arts and artists at City events
- support the research of best practices to understand how other communities and municipalities support their artists and arts organizations

- develop communication mechanisms to tell the story of the sector and its members
- educate City Hall about the work of artists and the role of the arts in our community
- advocate for an increase in the City grant budget to better support local artists in their work and housing/infrastructure needs
- support the AAC through a review of the selection process, the identification of champions/advocates and resources to develop communication strategies
- work to build support and consensus within the arts community and beyond

Sustainability of Arts Organizations:

- develop a range of funding options and municipal funding commitments, and leverage support from other levels of government
- look for additional resources for operations
- provide spaces and opportunities to share those spaces, and advocate for the City to provide subsidies to arts organizations through shared spaces, rent, and tax relief
- have the resources and networks available to spread the message that the arts community is important and has a significant impact locally
- explore communication mechanisms to inform decision makers and the community about the arts as an important sector for growth and development and to find opportunities to link with different sectors such as business and industry
- support collaboration, community building, and development opportunities by working with the Culture Division of the City and developing an inventory of organizations and artists in the City

 develop an arms-length organization to assist the City in funding arts organizations outside of the political process

ANALYSIS AND RECOMMENDATIONS

While the focus groups were organized around the three different topics listed previously and each group identified a variety of strengths and challenges within the community, five clear themes emerged for moving forward to strengthen the arts scene in Hamilton. These themes are not organized in order of priority.

1. Building Understanding and Appreciation of Arts:

- AAC must promote the value and importance of the arts community
- art-making must be respected as a legitimate profession
- the local cultural community should become better known and valued

2. Funding:

- more funding is needed, and most groups identified the development of a funding body, arms-length to the City of Hamilton as a key change needed to ensure that individual artists receive grants to support their work
- creative and new solutions are needed to increase financial support to arts
- reform in the way support is delivered is required
- moving the arts conversation into the economic sphere was noted by many groups as a way to best articulate the economic development possibilities of a vibrant cultural community
- local artists need to be paid for their work through a commitment from the City

3. Support Beyond Money:

- find solutions for lack of space including subsidized and more affordable studio/living spaces, tax relief, zoning clarity, and offering financial incentives for utilizing under-used buildings
- increase promotional opportunities for artists in the form of increased access to media (for example the City purchasing advertising space in the Hamilton Spectator for local emerging artists)
- support for showing artists' work in public places and providing spaces to legally post posters
- provide professional development opportunities, health care and counseling, business skills development, and mentorship

4. Arts Community Collaboration:

- the local arts community needs to come together to better understand each other and develop collective messages to promote collaboration individually, organizationally, and across sectors
- the story of the arts community is a critical one and sharing this story is an important opportunity for moving forward
- develop co-operative or collaborative models to share space, resources, and mentorship

5. Capitalizing on Opportunities:

- the arts community needs to position itself to respond to local opportunities as they emerge
- have artists involved in the reopening of City Hall and understand how local artists can play a role at this and other City events
- encourage the City to purchase local artists' work to enhance the new space
- ensure that the Pan Am games represent a momentum in the

community that has a place for arts

• encourage local networks and build cross-sector and cross-community synergies

AAC RESPONSE TO THE BIG PICTURE REVISITED

The Arts Advisory Commission has developed a workplan for 2010-11 that is informed by the feedback received through The Big Picture Revisited, and that takes best advantage of the AAC's status as an advisory committee to City Council. Specific workplan items include:

- holding a follow up to the Big Picture Revisited to share outcomes and engage the arts community in developing solutions
- developing an improved electronic presence for the AAC as a means to facilitate communication with the arts community
- explore a percentage funding model (like the 1% solution) that fits with Hamilton's City budget structure and locally identified needs, in order to increase financial support for the arts community
- through research and consultation with other municipalities, identify

the best model and local capacity for arts-length funding delivery for the Hamilton arts community

• find the resources and model for a dedicated community engagement position to increase communication and collaboration within the arts community and with the City of Hamilton
