

Further to the recent letter from the Honourable Deb Matthews, Minister of Health and Long-Term Care, approving one-time funding of up to \$2,000.00 at 100% for City of Hamilton, Public Health Services to support activities related to the World Tuberculosis (TB) Day on March 24, 2011, I am writing to provide the accountability and administrative details.

The funding is to be used for the development, reproduction and distribution of any new communication or educational materials and activities, specifically designed for World TB Day 2011. These might include:

- Electronic material for posting on websites.
- Paper/electronic messages, fact sheets, posters and visual displays for health care practitioners, health care settings, or other appropriate venues, with the specific goal of TB education/TB awareness.
- Audiovisual/educational material for health care settings, settlement agencies, homeless shelters and any other appropriate settings where TB is a relevant issue.
- Printed flyers/brochures/newsletters for distribution to the public at various events or locations, including multi-lingual versions of existing documents.
- Advertising World TB Day in newspapers, radio, television, websites, journals, etc;
- Educational/training events and materials for health care professionals such as synthetic arms for medical professionals to practice performing accurate TB skin tests.
- Reprinting/reproducing previously approved World TB Day material.
- Reprinting or reproducing third-party materials, approved by the health unit, that are appropriate for World TB Day 2010, (keeping in mind that you must abide by copyright laws).

agreements expire and new contracts are negotiated, the government will work with transfer payment partners and bargaining agents to seek agreements of at least two years' duration that do not include net compensation increases.
