Listed on Appendix "A" attached to Report CL10001(c) are details of the Freedom of Information requests received during the fourth quarter of 2010 from October 1 to December 31. These details include the length of time it took to process each request and the status of the request, noting which exemptions, if any, were applied, as well as the type of request, and the originator of the request, based on the categories of private citizen, business and media. We also include the total of time spent by each city department on FOI requests for each quarter.
