1. EMS Impact of Hamilton Health Sciences Access to Best Care Plan MUMC Paediatric Conversions and West End Urgent Care Centre (HES11002) (City Wide) (Added Item 5.3)

Whereas the third party consultant's report has predicted a 2011 \$1.1 million budget pressure to meet the response times and demand that will occur for Emergency Medical Services directly as a result of the Hamilton Health Sciences ABC Plan to close the E.R. for adults at McMaster Medical Centre:

Therefore be it resolved:

(a) That the Mayor, the City Manager, the Chair of the Emergency and Community Services Committee and Councillor McHattie be directed to meet with representatives of Hamilton Health Sciences and the LHINS and the City's Provincial Government representatives (the Honourable Sophia Aggelonitis and Ted McMeekin, MPP) to address the 2011 \$1.1 million budget pressure, with the intent of offsetting this impact on the City of Hamilton's municipal tax levy.

and Ted McMeekin, MPP) to address the 2011 \$1.1 million budget pressure, with the intent of offsetting this impact on the City of Hamilton's municipal tax levy.
