Information:

Under the *Municipal Act*, the Treasurer must submit to Council before the 31st of March each year, an itemized statement of the remuneration and expenses paid to each Member of Council and citizen appointees to various local boards in the preceding year.

One-third of the Mayor's and Council Members' remuneration is received tax free as allowed under current tax legislation. In addition to the actual remuneration paid to the Mayor and Members of Council, Appendix 'A' of Report FCS11021 also shows the remuneration that would be required if the one-third tax free exemption was discontinued and the remuneration was grossed up to off-set the tax impacts.
