Don Jaffray, Executive Director of the Social Planning and Research Council, and Sara Mayo, Social Planner, appeared before the Committee. Their presentation included the findings in their report entitled, "Hamilton's Social Landscape", dated May 2011.

Mr. Jaffray thanked the Committee for the opportunity to present and provided introductory comments. He indicated that the report, commissioned by the United Way of Burlington and Greater Hamilton, was a collaborative effort with others to develop strategies, actions and responses to address social trends in the community, and especially to the most disadvantaged and marginalized people.

With the assistance of power point, Ms. Mayo provided statistical information on population growth, young children, seniors, recent immigrants, persons with Aboriginal ancestry, persons who identify with a visible minority group, families led by female lone parents, persons under age 65 with self-declared activity limitations, persons who have contacted a health professional about mental health, persons working full-time, yet still living in poverty, persons living in poverty and poverty rates by selected groups, City of Hamilton and Ontario, 2006 Census.

All of the information presented is published in the May 2011 special report from the SPRC and the United Way of Burlington and Greater Hamilton, a copy of which was distributed to the Committee and retained in the Office of the City Clerk for the public record.

The Committee was also distributed with "Hamilton's Social Landscape", a copy of which was submitted to the City Clerk for the public record and is available for viewing on the City of Hamilton website.

(ii) Julia Kollek, on behalf of the Hamilton Climate Change Working Group, respecting the Hamilton Climate Change Action Charter (Item 6.3)

Mr. Kollek indicated that she is here as part of the Working Group for Clean Air Hamilton, working on a Charter on Climate Change in Hamilton. With the assistance of power point, Ms. Kollek presented the following information:

Trevor Harris, U.S. Steel Canada, appeared before the Committee to respond to issues requested by the Committee in a letter to U.S. Steel dated August 16, 2011.

Rolf Gerstenberger and Gary Howe, President and Vice President, Steelworkers' Union Local 1005 respectively, and Jake Lombardo, Political Action Committee Chairperson, appeared before the Committee to respond to questions of the Committee.

Mr. Gerstenberger's comments included, but were not limited to, the following:

- First concern that came up last month is that U.S. Steel locked out the employees on November 7, 2010; there was no strike vote; employees worked for three months past the expiry of their contract and were not interested in going on strike or getting locked out
- U.S. Steel decided to lock out its emloyees
- Presented that Local 1005 is the obstacle to not having water treatment plant completed; Local 1005 is presented as villains
- Local has long history about being concerned about environment damage caused by the steel industry
- Have been locked out for over 10 months, no arrests, no accusations
  of violence, some people who enter and exit have to wait a bit, but
  usual give and take on picket lines
- Have had 2 injunctions against Local at the Gate and 1 at Lift Bridge; trying to encourage unionized workers not to cross picket line and want everyone to respect it
- Quoted the following from Local 1005 Information Update #32 September 12, 2011: "In the matter of the renovations required to the water treatment plant, the lawyer for U. S. Steel asked us if we would permit AECON to cross the picket line to start the work and we said NO. U. S. Steel should settle the phony lock-out with Local 1005 and stop its cynical attempts to blame Local 1005 for its irresponsibility toward the state of affairs at its Hamilton Works. Today, USS is supposed to report to City Council on what efforts it is making to settle

its phony lockout. Let us hope City Council does not grant U.S. Steel another extension, which is does not warrant."

## (h) MOTIONS

(i) Open Data (Item 9.1)

Chair McHattie relinquished the Chair to speak to his motion.

#### (McHattie/Farr)

WHEREAS the City of Hamilton's expressed values are: accountability, excellence, honesty, innovation, leadership, respect and teamwork; and that the City wishes to involve its citizens in living these values;

AND WHEREAS the adoption of an Open Data policy is intended to advance these values for the following reasons:

- municipalities across Canada have an opportunity to lower their costs by collectively sharing and supporting software they use and create;
- the total value of public data is maximized when provided for free or where
  - necessary only a minimal cost of distribution;
- when data is shared freely, citizens are enabled to use and repurpose it to help create a more economically vibrant and environmentally sustainable city; and Hamilton needs to look for

- opportunities for creating economic activity and partnership with the creative sectors;
- the adoption of open standards improves transparency, access to city information by citizens and businesses and improved coordination and efficiencies across municipal boundaries and with federal and provincial partners;
- digital innovation can enhance citizen communications, support the brand of the city as creative and innovative, improve service delivery, support citizens to self-organize and solve their own problems and create a stronger sense of civic engagement, community and pride;

THEREFORE BE IT RESOLVED that in pursuit of an open data policy, the City of Hamilton directs the City Manager to report back to Council on open data, including a clear definition of the term, "Open Data", open standards and open source, including validating and quantifying the benefits listed above, and the implications, resources, risks and benefits of endorsing the following principles:

- Open and Accessible Data the City of Hamilton will freely share with citizens, businesses and other jurisdictions the greatest amount of data possible while respecting privacy and security concerns;
- Open Standards the City of Hamilton will move as quickly as possible to adopt prevailing open standards for data, documents, maps and other formats of media;
- Open Source Software the City of Hamilton, when replacing existing software or considering new applications, will place open source software on an equal footing with commercial systems during procurement cycles.

## (i) NOTICES OF MOTION

Chair McHattie relinquished the Chair to introduce the following Notice of Motion:

# (i) Canada – European Community Free Trade Agreement – Impact on City of Hamilton

WHEREAS the government of Canada and the European Union have been negotiating a trade agreement known as the Comprehensive Economic and Trade Agreement (the "CETA"); and WHEREAS the European Union and European corporations are insisting on unobstructed access to procurement by sub-national governments, including municipalities, school boards, universities, hospitals and other provincial agencies, which could significantly reduce or eliminate the right to specify local priorities when public money is invested in goods, services or capital projects; and

WHEREAS Canadian municipalities have expressed growing concerns with trade agreements and their potential impacts on municipal programs and services and local autonomy; and

WHEREAS unobstructed access to Canadian municipal procurement by European corporations, combined with investment protections in CETA on government concessions related to transit, water, electricity and other social services delivered locally, may encourage privatization and reduce economic development options for local communities; and

WHEREAS the provincial and territorial governments have been actively involved in negotiating CETA with the European Union:

#### THEREFORE BE IT RESOLVED:

- (a) That the City of Hamilton request:
  - (i) a briefing from the Ontario Government on the scope and content of trade negotiations with the European Union, including the details of its procurement offer to the EU;
  - the Federation of Canadian Municipalities to provide a sector-by-sector analysis of the potential impacts on municipal functions and powers of the procurement regime that the European Union is seeking;
  - (iii) the Federation of Canadian Municipalities to urge the Government of Canada not to provide the European Union with access to sub-national government procurement;
  - (iv) that the Government of Ontario negotiate a clear, permanent exemption for local governments from CETA;
  - (v) City staff to review the available information on the impact CETA will have on the City of Hamilton, with special emphasis on procurement and the delivery of social services, and;
- (b) That this resolution be sent to the Association of Municipalities of Ontario for consideration and circulation to Ontario municipalities.
- (ii) Councillor C. Colllins introduced the following Notice of Motion:

#### **Hamilton Waterfront Priorities**

Whereas Hamilton's waterfront and shoreline precincts are valuable geographic and environmental public assets that add to the quality of life for the City's residents;

And Whereas over the past several years, City Council has passed and endorsed several key policy initiatives to enhance and revitalize the waterfront precinct including; the West Harbour Recreation Master Plan, the "Setting Sail" secondary plan, Hamilton's Neighbourhood Development Strategy, the City of Hamilton Economic Development Strategy, as well as the pursuit of all-day GO train service to James St. North;

And Whereas the 2011 Senior Management Team Workplan clearly identified the goal of accelerating existing actions that revitalize the economic potential and assessment growth of the waterfront.

#### Therefore be it resolved:

- (a) That staff be directed and authorized to begin discussions with the Hamilton Port Authority, with the objective of a formal agreement transferring the lands consisting of Piers 7 and 8, to the City of Hamilton immediately;
- (b) That staff report back to Council in the 4<sup>th</sup> quarter of 2011 with a recommended "framework" for these discussions;
- (c) That staff be directed and authorized to commence key studies that will accelerate the public and private sector development of Piers 7 and 8, including but not limited to issues of site servicing, geo-technical, soils, remediation, as well as development phasing, marketability, and valuation;
- (d) That staff be authorized to fund these studies from the "Waterfront Development Corporation" capital budget;
- (e) That staff Report back by the 4<sup>th</sup> quarter of 2011 with a comprehensive 2012 workplan for the development of the waterfront precinct.
- (iii) Councillor B. Clark introduced the following Notice of Motion:

## Request for Confirmation of LRT Commitment from the Province

Whereas on June 15, 2007, the Liberal Government announced "Move Ontario 2020" would develop \$17.5 billion in 52 rapid transit projects;

And Whereas the Province promised that GTA municipalities would not contribute to Capital;

And Whereas Hamilton was included in "Move Ontario 2020" with two LRT projects;

And Whereas on September 12, 2007, Premier McGuinty and local Liberal candidates promised Hamilton two LRT lines and said that the Conservatives would cancel the projects;

And Whereas on April 1, 2990, the MTO announced \$3 million in grant to establish two LRT lines, EA, plans, etc.;

And Whereas on May 17, 2010, Metrolinx presented to the Metro Board of Trade that the Sheppard LRT, Eglinton LRT, York VIVA, Scarborough LRT and Finch LRT worth \$9.5 billion would proceed at no cost to the TTC or Toronto:

And Whereas Hamilton, like Toronto, does not have the capacity to contribute to LRT.

Therefore Be It Resolved:

That the City of Hamilton request confirmation on LRT commitment from the Province to fully fund Capital for two LRT lines and use of Gas Tax for operating costs.
