5.1 Citizen Committee Reports:

The process for Citizen Committee Reports and implications for CFFSC work was described. To bring an issue or recommendation forward to the Board of Health, a Citizen's Committee Report is to be used. The report is to be prepared using the template and then formally approved by the committee members at a meeting before being signed and going to the City Clerk's office for placement on a Board of Health agenda.

Dr. Tran noted that another process of highlighting recommendation items in the minutes before submitting them to the Board of Health may be used for issues not requiring a complete report.

5.2 Strategic planning and timetable for 2011 and 2012:

It was suggested that the committee focus on a food security issue at each meeting, have a presentation followed by a discussion and recommendation leading to a policy. Priority setting and timelines were set for the fall as follows:

September:

- o Farmers' Market Policy Recommendations
- o Food Charter development

October:

- Local food procurement for institutions and city facilities. (Dave and Sarah will draft a report for the community to edit)
- Update on the Hamilton Farmer's Market (Sapphire)

November:

- Report of Public Health Healthy Food Systems Situational Assessment and plans for 2012.
- Communication plan for CFSSC, including a website presence, a newsletter or listserv.

ACTION: Sarah will liaise with Tina and the members of the enhanced community food access sub-committee to develop a plan to bring forward in November.

December (tentative):

- o Update on community gardens
- o Report on local food hub progress and possible connection to committee work .

It was decided to keep the structure of the sub-committees, but to encourage members to engage in whatever committee aligned with their interests, and not stay in less relevant ones. Sarah has students who can help with committee research work.
