## (i) 2012 Tax-Supported Capital Budget Overview (Item 3.1)

Mike Zegarac, Director, Financial Planning and Policy, provided introductory comments including that the overall purpose of this Capital Budget Workshop is to engage Council and obtain feedback on capital priorities, issues, direction, etc, prior to the commencement of actual budget deliberations.

Workshop #1 will provide a brief overview/update on the State of the Infrastructure and a series of presenters from a cross-section of programs providing the Committee with some context leading into the budget deliberations. Staff is also seeking some input with respect to the 2012 Capital priorities.

The City Manager will also have a discussion with the Committee respecting the Senior Management Team's (SMT) 2011 work plan.
