## Motorcycle parking

Operators of motorcycles will benefit from a decision to give them free parking on Toronto streets. Council agreed to amend City bylaws in order to exempt motorcycles from parking fees at onstreet parking meters/machines. The rationale is that parking receipts tend to disappear from parked motorcycles, resulting in unwarranted parking fines. Council also wants the Toronto Parking Authority to consider designating areas for motorcycle parking at its parking lots.
