EXECUTIVE SUMMARY

The 2012 Preliminary Tax Supported Operating Budget was submitted to Council on January 24, 2012 at GIC. Each department then provided GIC with an indepth presentation of their 2012 budget plan. Boards and Agencies also presented, as well as members of the public provided delegations.

Based on the feedback during this time, staff have developed a number of recommended options to reduce the average total tax impact from 2% (as submitted) to 1.4%. The reductions are identified in Appendix "A" to report FCS12014. Further information will be provided during a staff presentation at the February 24th GIC.
